Bilateral Issue Indo-Pak Talks on

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether the Foreign Secretary of Pakistan visited India recently and had talks with his Indian counterpart on various bilateral issues between the two countries:
 - (b) if so, the outcome thereof:
- (c) whether the issue of border disputes also figured in the talks;
 - (d) if so, the details thereof:
- (e) the outcome of talks held at other levels on various issues between the two countries:
- (f) whether the Government have initiated any talks with Pakistan for a peaceful settlement of Siachen Glaciers issue: and
 - (g) if so, the outcome thereof?

MINISTER OF EXTER-THE NAL AFFAIRS (SHRI MADHAV-SINH SOLANKI): (a) to (d) The Fourth Round of Foreign Secretary level talks between India and Pakistan took place in New Delhi from 4 to 6 April, 1991. The talks covered the entire range of bilateral and included an exchange of views on international issues of mutual interest. In these discussions it was pointed out to Pakistan that the crux of the present problem in bilateral relations was its support to terrorism and subversion directed against India in Puniab and Jammu & Kashmir.

The Foreign Secretaries signed two agreements on 6 April, 1991, relating to: ---

(i) Advance Notice on Military Manoeuvres and Exercises. Troop Movements.

(ii) Prevention of Air Space Violations and for Permitting Overflights and Landings by Military Aircraft.

It was also decided to commence discussions on several pending bilateral issues and, in principle, to convene the Sub-Commissions of the India-Pakistan Joint Commission on mutually convenient dates. Agreement was also reached to hold the fifth round of Foreign Secretary level talks. These are now scheduled to be held in September, 1991.

(e) The Surveyors General of India and Pakistan met in New Delhi from 23 to 26 March, 1991 to discuss the demarcation of the international boundary between the two countries in the Sir Creek area. These talks helped in a better appreciation of each other's point of view. Further discussions on the issue are scheduled to take place at the Secretaries level scheduled later this month.

The India-Pakistan Committee Combat Drug Trafficking and Smug-gling met in Islamabad from 30 to 31 July, 1991 and agreed, inter-alia. to expedite exchange of information to control drug trafficking and smuggling across the Indo-Pakistan border.

(f) and (g) In the Fourth round of Foreign Secretary level talks, it was agreed in principle to resume the dialogue on Siachen at the appropriate time.

Repatriation of Refugees to Sri Lanka

THE MINISTER OF EXTERNAL AFFAIRS (SHRI MADHAVSINH SOLANKI): (a) and (b) During the recent visit of Sri Lanka Foreign Minister to India, the Indian side stressed that the Sri Lanka Government must take steps to encourage an early and voluntary return of the refugees presently in India.

(c) and (d) Government of India has provided relief supplies valued at approximately Rs. 1.17 Crores to the United Nations High Commission for Refugees for its on-going relief operations at Peasalai and Madu (Mannar District).
