

**Consumption of Fertilizers**

2172. SHRI ARJUN CHARAN SETHI: Will the Minister of AGRICULTURE be pleased to state:

(a) the state-wise, per acre consumption of fertilizers in paddy and wheat fields during the last three years; and

(b) the steps taken by the Government to promote the use of fertilizers in the country?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI MULLAPPALLY RAMACHANDRAN): (a) No such data are maintained.

(b) Through schemes for encouraging the opening of retail outlets in remote and rainfed areas, encouraging the use of small packs, ensuring timely availability and through extension messages, the use of fertilisers in the country is encouraged.

CRPF remained deployed in Andhra Pradesh, A&N Islands, Arunachal Pradesh, Assam, Bihar, Chandigarh, Delhi, Gujarat, J&K, Manipur, Meghalaya, Nagaland, Punjab, Pondicherry, Rajasthan, Sikkim, Tripura, Uttar Pradesh and West Bengal during 1990 and 1991 (information given upto 30-6-1991).
