Will the Minister of COAL be pleased to state:

- (a) whether an accident took place due to collapse of coal wall of the Kavadi open- cast mine of the Western Coalfields Limited (WCL) in Maharashtra recently;
- (b) if so, the details thereof including the loss of life and property therein;
- (c) whether the Government have gone into the reasons of this tragedy;
- (d) if so, the details thereof and the action taken by the Government in this regard;
- (e) the details of amount proposed to be paid as compensation to the victims of this Kavadi mine tragedy;
- (f) whether the Government propose to appoint a committee to look into the safety aspects in the coal mines of WCL;-
- (g) if so, the details thereof; and
- (h) if not, the reasons therefor?

Answer

THE MINISTER OF COA (SHRI N.T. SHANMUGAM)

- (a): An accident took place due to sliding of overburden bench in Kawadi Opencast mine of WCL in Maharashtra on 24-6- 2000at 3.50 P.M. But the accident was not due to collapse of coal wall.
- (b): While fifteen workers were engaged for drilling and preparation for blasting operation, at about 3.50 P.M., there was sliding of boulders and other materials from rise side of the quarry. The rolling mass moved towards the site where the workers were engaged. Sensing the trouble, five workers ran off to safer place but ten of them tried to take shelter against nearby drill machine and explosive van which also got toppled trapping the workers.
