## Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of the schemes for rural development in operation in Haryana, Rajasthan, Uttar Pradesh, Delhi and Kerala at present;
- (b) whether the State Governments have submitted a number of rural development schemes for approval to the Union Government during the last three years and the current year;
- (c) if so, the details thereof, State-wise;
- (d) the reasons for delay in clearance of the scheme; and
- (e) the time by which all the schemes of these States are likely to be cleared?

## **Answer**

## MINISTER OF RURAL DEVELOPMENT (SHRI SUNDAR LAL PATWA)

- (a) The Ministry of Rural Development implements the Jawahar GramSamridhi Yojana (JGSY), the Employment Assurance Scheme (EAS), the SwarnjayantiGram Swarozgar Yojana (SGSY), Indira Awaas Yojana (IAY), the Integrated Wasteland Development Programme (IWDP), the Accelerated Rural Water Supply Programme (ARWSP) and the Central Rural Sanitation Programme (CRSP) in Haryana, Rajasthan, Uttar Pradesh and Kerala. In addition, the Desert Development Programme (DDP) is implemented in Haryana and Rajasthan, while Drought Prone Areas Programme (DPAP) is implemented in Rajasthan and Uttar Pradesh. However, only the Central Rural Sanitation Programme (CRSP) is implemented in Delhi.
- (b) & (c) The details of Schemes submitted by the States during the last three years are indicated at the Annexure.
- (d) & (e) The sanctioning of project proposals depends upon their conformity with the Guidelines and availability of funds. No time frame for sanctioning the projects can be specified, in view of this.
