(a) whether some sugar mills of Madhya Pradesh and Maharashtra havesought the approval of the Union Government to increase their production capacity;

(b) if so, the details thereof alongwith names of sugar mills; and

(c) the action taken by the Union Government on this request?

# Answer

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION ( \$ SREENIVASA PRASAD )

(a), (b) & (c) : The sugar industry has been de-licensed from 11.9.1998. The entrepreneurs are free to carry out expansion of their existing sugar mills by filing Industrial Entrepreneur Memoranda (IEM).

As on 31.10.2000, 28 IEM had been filed from the State of Maharashtra for expansion of the existing units whereas no IEM had been filed from the State of Madhya Pradesh. A statement indicating the names of the sugar mills in the State of Maharashtra which have filed the IEM is enclosed (Annexure).
