Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the value and quantity of sugar imported and exported during each of the last three years, country-wise;
- (b) the losses incurred as a result of import and export of sugar during the last three years and as on date;
- (c) the foreign exchange spent and earned during the above period;
- (d) whether the Government have allowed export of sugar to Pakistan recently;
- (e) if so, the details thereof;
- $(f) \ whether \ any \ policy \ has \ been \ chalked \ out \ by \ the \ Government \ for \ export \ of \ sugar \ and \ other \ commodities; \ and$
- (g) if so, the details thereof?

Answer

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTIONV(SREENIVASA PRASAD)

- (a) The quantity and value of sugar imported and exported during each of the last 3 financial years country-wise are given in Annexures A and B respectively.
- (b) The exports and imports of sugar are being undertaken by the private parties/public sector undertakings as per their commercial judgement and as such, there is no question of loss to the Government.
- (c) Since there are no exports and imports of sugar on Government account, the details of foreign exchange spent/earned are not available with this Ministry.
- (d) & (e): The exports of sugar are being undertaken to various countries including Pakistan. During the current financial year, i.e., 2000-2001 (upto 17.11.2000), Registration-cum-Allocation Certificates (RCAC) have been issued for export of sugar to Pakistan for a quantity of about 1.72 lakh tonnes (Prov.). However, physical export is under progress.
- (f) & (g): The policy of the government to permit exports of agricultural products is governed principally by the concerns of India's food security, maximising farm incomes and earning foreign exchange. Review of export performance of agricultural products is an ongoing process and accordingly policy interventions are made as and when considered necessary with a view to making agricultural exports increasingly viable. Export policy is being constantly updated and export regime in respect of agricultural products has been liberalised. Very few items are now either prohibited for exports or their exports restricted or are subject to quantitative ceilings.

Due to surplus production and stock of sugar in the country, the Government had released a quantitative ceiling of 10 lakh MTs for export during the current year and placed at the disposal of APEDA for issuing RCAC. As on 17.11.2000, APEDA has issued RCACs for a quantity of 4.29 lakh tonnes (Provisional) and the release orders for the same have also beenissued by the Directorate of Sugar.

Government have decided to export wheat from the surplus stocks available with it. Wheat will be made available by the FCI for export at a price not lower than the Central Issue Price (CIP) for BPL category which, at present is Rs. 4,150/- per MT.
