- (c)&(d) The parameters of the scheme have already been simplified to cover more beneficiaries under the Prime Minister's Rozgar Yojana. The simplification/modification in the scheme is a continuous process based on the interaction with the implementing agencies and the experience gained in the implementation of the scheme.

STATEMENT REFERRED TO IN REPLY TO THE LOK SABHA STARRED QUESTION NUMBER 294 TO BE ANSWERE 15.03.2000

ELIGIBILITY CRITERIA UNDER THE PRIME MINISTER'S ROZGAR YOJANA

I. AGE (a) 18 to 35 years for all educated unemployed in the Country except for the North Eastern States.
(b) 18 to 40 years for all educated unemployed in the North Eastern States.
(c) 18 to 45 years: for Scheduled Caste/Scheduled Tribes, Ex-servicemen, Physically Handicapped And Women educated unemployed in the country.

II. EDUCATIONAL VIII Passed. Preference will be given to those QUALIFICATIONS: trained in any trade in Government recognised/

Approved institutions for a duration of at least Six months.

III. FAMILY INCOME: Neither the income of the beneficiary along with Spouse nor the income of parents of the Beneficiaries should exceed Rs. 24,000/- per annum.

FOR NORTH EASTERN STATES

Upto Rs. 40,000/- per annum.

- IV. DEFAULTER: Should not be a defaulter to any nationalised
 Bank/financial institution/cooperative bank.
 Further a person already assisted under other
 Subsidy, linked Government schemes would
 Not be eligible under the Scheme.
