## Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the revised guidelines for computerisation of land records have been circulated to State Governments;
- (b) if so, the details thereof;
- (c) the details of the funds allotted to each State especially to Karnataka for the purchase of computers for land records since implementation of the programme;
- (d) whether the Karnataka Government has sent a proposal to release Rs. 10.20 lakh for computerisation of Deputy Commissioners` Office;
- (e) if so, the reaction of the Union Government thereto; and
- (f) the time by which the said amount is likely to be released to the State?

## **Answer**

#### MINSTER OF STATE FOR RURAL DEVELOPMENT(SHRI SUBHASH MAHIRIA)

- (a) & (b) Yes Sir. The revised guidelines inter alia provides 100% grant by Government of India to State Governments for undertaking Data Entry Work, site preparation and purchase of computers and other peripherals at Tehsil/Taluka/Block level.
- (c) Funds under the Scheme are not allotted to States but released on project to project basis. Since inception of the scheme Government of India has released Rs.1815.03 lakh to State Government of Karnataka for implementation of the scheme. Out of which Rs. 672.60 lakh have been released for purchase of computer, software and other peripherals for 177 talukas of the State. A statement showing the funds released to various States/UTs is annexed.
- (d) Yes Sir. As per the guidelines for implementation of the scheme of Computerisation of Land Records, the supply of computers at District level is the responsibility of National Informatics Centre (NIC). The NIC has informed that the computers have already been supplied in all the 27 districts of the State.
- (e) & (f) Question does not arise in view of reply given to part (d) of the question.
