(a) As on 1-1-2000, 38 projects costing Rs.20 crores and above in the Central Sector are under implementation in Madhya Pradesh. (b) 4 projects are reported to have been completed in accordance with their schedule during the last 3 years.

(c) Of the 38 projects, 6 projects have reported time overrun as well as cost overrun with respect to the original schedule and costs. The details of the 6 projects are enclosed.
