Will the Minister of FINANCE be pleased to state:

- (a) the details of film personalities/TV personalities who have not paid their income-tax dues and the value of dues to be recovered from each individual defaulters;
- (b) whether the Government have launched any special drive to collect these IT dues from the above persons ; and
- (c) if so, the outcome thereof ?

Answer

MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI BALASAHEB VIKHE PATIL)

a) Details of the film personalities who have not paid their income-tax dues and the value of dues to be recovered from each individual defaulters as on 30.6.2001 are given in the statement annexed to the reply.

b & c) No special drive to collect IT dues from film personalities/TV personalities has been launched. However, the recovery of taxes is a continuous process which involves various statutory procedures. These include attachment and sale of moveable and immovable properties; charging of interest for late payment; levy of penalty; etc. Periodical review and monitoring of cases involving arrears are made by the higher authorities from time to time for issuing necessary instructions for expediting recovery of taxes.
