- (b) if so, the number of Members nominated in each ZRUCC and DRUCC along with terms and reference, State-wise;
- (c) the number of members out of that recommended by the MPs; and
- (d) if not, the time by which the ZRUCCs and DRUCCs are likely to be constituted?

- (b) & (c) The details of total number of members nominated on various DRUCCs and number of persons nominated on the recommendation of Members of Parliament on these Committees are given in Annexure-I. The details of the total number of members nominated on various ZRUCCs are given in Annexure II. There is no provision in the constitution for giving representation to the nominees of Members of Parliamenton ZRUCCs. Asregard terms and reference of ZRUCCs and DRUCCs, Zonal Railway Users' Consultative Committees (ZRUCCs) and Divisional Railway Users' Consultative Committees (DRUCCs) are functioning on all the Zones and Divisions for a two year term from 01.01.2000 to 31.12.2001. The functions of these committees are given in Annexure-III.

Functions of the Divisional Railway Users' Consultative Committees (DRUCCs) and Zonal Railway Users' Consultative Committees (ZRUCCs) as mentioned in reply to parts (b) & (c) of Unstarred Question No.1835 raised by Shrimati Kailasho Devi and Shri Chandresh Patel regarding Constitution of ZRUCCs and DRUCCs.

1. Divisional Railway Users' Consultative Committees (DRUCCs):

The Railway Users' Consultative Committees in the Divisions represent the local users in the territories served by the railway and consider matters relating to:

- (i) Provision of amenities in the area within which the Committee is concerned.
- (ii) Proposal regarding opening of new stations within the jurisdiction of the Committee.
- (iii) Arrangements regarding time tables.
- (iv) Improvement of the services and facilities provided by the Railways.
- (v) Any subject of general public interest or public convenience or such matters affecting the services and facilities which has been the subject of representation by users, or which has been referred to them for consideration by the Zonal Railway Users' Consultative Committee, the National Railway Users' Consultative Council or by the Administration.
- 2. Zonal Railway Users' Consultative Committee (ZRUCCs):

The Zonal Railway Users' Consultative Committee at the Headquarters of each railway represents the general railway users of the territory or zone served by the railway as a whole and considers:

- (i) Such matters, from the point of view of the zone as a whole, as are referred to in Para 1 above.
- (ii) Matters arising from the reports of the Divisional Committees, or such other matters relating to the subjects referred to Para 1 above, as may be specifically forwarded by the Divisional Committees for consideration; and
- (iii) Matters referred for consideration and report by the Administration, Ministry of Railways or the National Railway Users' Consultative Council.
