#### **Training Centres for Railway Employees**

366. SHRI BHIMRAO VISHNUJI BADADE : Will the Minister of RAILWAYS be pleased to state :

(a) the details of training institutes in the country to impart training to railway employees;

(b) whether the Government propose to open such training institutes in Maharashtra; and

(c) if so, the time by which it is likely to be opened?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ) : (a) There are 169 training institutes on the railways spread all over the country which cater to the training needs of all the railway employees.

(b) There is no proposal to open new training institutes in Maharashtra.

(c) Does not arise.

#### **Sub-Post Offices in Maharashtra**

367. SHRI SAHEBRAO SUKRAM BAGUL : Will the Minister of COMMUNICATIONS be pleased to state:

(a) the number of villages in Maharashtra which do not have sub-post offices;

(b) whether State Governments Maharashtra have sent any proposal in this regard;

(c) if so, the details thereof; and

(d) the time by which decision is likely to be taken thereon?

THE MINISTER OF COMMUNICATIONS (SHRI BENI PRASAD VARMA) : (a) 39,098 villages in Maharashtra do not have Sub Post Office. However, Extra Departmental sub POs/Branch POs are available in 11290 villages in the State.

(b) No, Sir. The State Government of Maharashtra have not sent any proposal in this regard.

(c) and (d). does not arise in view of (b) above.

#### **Capacity of International and National Airports**

368. SHRI JAGDAMBI PRASAD YADAV : Will the Minister of CIVIL AVIATION be pleased to state :

(a) the number of International and National Airports in the Country and their daily and monthly landing, taking off and maintenance capacity;

(b) whether keeping in view the vastness of our country these numbers seem to be less and if so, the scheme to enhance their number and to upgrade their standard; and

(c) the position of India in the International Commercial Sector and the names of the countries with whom India is facing competition?

THE MINISTER OF CIVIL AVIATION AND MINISTER OF INFORMATION AND BROADCASTING (SHRI C.M. IBRAHIM) : (a) There are five International Airports and 115 National Airports (including 28 civil enclaves) in the country. The number of aircraft and their seating capacity operating to these airports, varies from airport to airport.

(b) Upgradation of airports and other infrastructural facilities is a continuing process and is taken up in a phased manner depending upon projected requirements and availability of resources.

Airports Authority of India (AAI) is developing 12 airports at Jaipur, Lucknow, Nagpur, Indore, Vadodara, Hyderabad, Coimbatore, Calicut, Patna, Bhubaneswar, Guwahati and Imphal as Model Airports as well as Goa and Ahmedabad airport for limited international operations.

There are plans for developing airports at Ajmer in Rajasthan, Lengpui in Mizoram, Tura in Meghalaya, Androth in Lakshadweep, Kargil in J&K. State Governments have taken initiative for development of airports at Devanahalli near Bangalore and Nedumbassery near Cochin.

(c) India is favoured destination for international carriers. More international airlines have expressed their intention either to operate to India or to increase the frequency of operation.

#### **Number of AI FHTS Operatings**

369. SRI E. AHAMED : Will the Minister of CIVIL AVIATION be pleased to state :

(a) the number of Air India Flights operating from India to Saudi Arabia during a week;

(b) whether there is any proposal to operate flights between Calicut and Jeddah by Indian Airlines; and

(c) if so, since when?

THE MINISTER OF CIVIL AVIATION AND MINISTER OF INFORMATION AND BROADCASTING (SHRI C.M. IBRAHIM) : (a) Air India operates 18 frequencies per week to Saudi Arabia.

(b) and (c). Indian Airlines has a proposal to provide direct airlink between Calicut and Jeddah. This will be feasible only after the approval is given by the Kingdom of Saudi Arabia to the designation of Indian Airlines as second Indian Carrier for operation of air services between the two countries.
