## Increase in Accidents of Trains

(a) whether train accidents and derailments have

increased during the last six months resulting inconvenience to the travelling commuters;

- (b) if so, the details of trains accidents and derailments took place in each zone, location-wise till date:
- (c) the main causes of these accidents and derailments:
- (d) the number of persons killed and injured therein, trains concelled/diverted and loss incurred by railways by each of these accidents:
- (e) whether the credibility of the railways have been eroded and the Government have failed to take any concrete steps in this regard; and
  - (f) if so, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) and (b). No, Sir. Number of consequential train accidents during the period May 1996 to October 1996 was 183 as compared to 190 during the corresponding period of last year.

- (c) The main reasons for the accidents were human failure (including other than railway staff), equipment failure, sabotage, etc.
- (d) 9 passengers and railway staff lost their lives and 71 sustained injury in these accidents. In addition, 125 persons (other than passengers and railway staff) died and 96 injured mainly in manned and unmanned level crossing accidents. The cost of damage to railway property amounted to Rs.20.59 crores (approx.). Information regarding number of trains cancelled/diverted on account of these accidents is being collected and will be laid on the Table of the Sabha.
- (e) and (f). No, Sir. Safety is always accorded a very high priority in train operations and Railways have taken concrete steps to improve safety.
