IDENTIFICATION OF BENEFICIARIES IN SUPER CYCLONE AFFECTED AREAS OF ORISSA

Will the Minister of URBAN DEVELOPMENT AND POVERTY ALLEVIATION be pleased to state:

- (a) whether HUDCO had identified beneficiaries in the Super-Cyclone affected areas of Orissa to provide shelters;
- (b) if so, the details thereof, district-wise;
- (c) the number of beneficiaries provided funds during each of the last three years, year-wise;
- (d) whether HUDCO beneficiaries have been provided with full grant;
- (e) if not, the reasons therefor; and
- (f) the time by which each beneficiary is likely to be provided with shelter?

Answer

MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT & POVERTY ALLEVIATION (SHRI O. RAJAGOPAL)

(a): No, Sir.

(b): Does not arise.

(c): HUDCO has sanctioned loan assistance of Rs.1416.25 crores for construction of 3.47 lakh houses for cyclone victims of super cyclone of October 1999 in the State of Orissa since November, 1999. Physical and Financial details are given in the Annexure.

(d): No, Sir.

(e): HUDCO provides only loans to the State designated agencies and have no provision to provide grants.

(f): State Government designated agencies have to complete the formality for securing HUDCO loans. These agencies release funds to the beneficiaries based on the progress at site.
