- (a) to (c): The 1996 syllabus was restructured on the basis of the recommendations of the Academic Council. The revised restructured syllabus was approved by the Governing Council in August, 1999 which has been put into practice from the academic year, 2000. The number of students passed out in each course since 1991 to 1999 is given in Annexure. The students admitted in the year 2000 are in the third year of the Three Year Diploma Course and the students admitted in the year 2001 are in the second year of the Three Year Diploma Course. The final examination of the Three Year Diploma Course is yet to be held.
- (d): The year-wise details of funds allocated and actual expenditure incurred by FTII are as under:
