Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) whether the Government are aware that there is an increase in the case of atrocities on SC/STs;
- (b) if so, the State-wise number of incidents of atrocities committed against persons belonging to the Scheduled Castes/Scheduled Tribes particularly in Tamil Nadu during the period between October 31, 2001 and October 31, 2002;
- (c) the proportion of murder and rape against total incidents; and
- (d) the steps being taken by the Government to stop such incidents?

Answer

- (a), (b) & (c) As per the crime statistics of the National Crime Records Bureau, Ministry of Home Affairs, there has been a very slight increase of 0.13% in incidence of crime against Scheduled Castes/Scheduled Tribes from 29,645 cases in the year 2000 to 29,683 cases in the year 2001. The State/UT wise details of cases for the year 2000 and 2001 are given in the Annexure. So far as the State of Tamil Nadu is concerned, the available data from November 2001 to September,2002 indicates that there has been 460 such incidents out of which, the cases of murder and rape were 6 and 3 respectively. It may be noted that the number of cases in Tamilnadu fell from 1305 in year 2000 to 537 in year 2001.
- (d) With a view to prevent atrocities on Scheduled Cast and Scheduled Tribes, the State Governments/Union Territory Administrations have been requested to implement provisions of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989 in letter and spirit. Financial assistance is also provided for strengthening of administrative, enforcement and judicial machinery, relief and rehabilitation of the affected persons. Implementation of the Act is also reviewed from time to time.
