STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (O)F THELOK SABHA STARRED QUESTION NO 402 FC ANSWER ON 18.12.2002REGARDING PROGRESS MADE BY BIMARU STATES BY SJHROTIRADITYA M. SCINDIA ANI SHRI SUSHIL KUMAR SHINDE

- (a): No, Sir.
- (b): Does not arise.
- (c) & (d): In the meeting between Deputy Chairman, Planning Commission and ChiefMinister, Madhya Pradesh held on 27.2.2002 for finalization of Annual Plan 2002-03 of Madhya Pradesh, the State Government was appreciated for Padhana-BadhanaAndolan, Education Guarantee Scheme and other related measures taken by them, which led to improvement in literacy rate from 44.2 in 1991 to 64 in 2001. However, attention of the State Government was drawn towards low rural female literacy rate, specifically of Scheduled Caste and Scheduled Tribe population as well as disparity among different districts over the literacy status.

As the decadal growth rate of population in reorganized Madhya Pradesh at24.34 during 1991-2000 was still higher than the All India average of 21.34 and the health and demographic indices of the State, such as birth rate, death rate and infant mortality were still above the National Level, the State Govt. was impressed upon tobring about improvement in quality, content and coverage of health care facilities.
