Development of Agriculture

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRIK.C. LENKA): (a) Sir, Two scientists formerly employed in the Indian Agricultural Research Institute had in this paper published in "The Economic Times" quantified the potential gap of Indian agriculture in physical and monetary terms.

- (b) The estimated gaps between actual and potential returns from crop production resulting from the failure to adopt fully the recommended level of technology in various regions of the country have been worked out.
- (c) Concentrated efforts have been made to tap the potential of Indian Agricul-

ture through extension programmes, infrastructural developments like increase in irrigation for critical imputs like fertilizer and improved seeds and output and remunerative price support.
