Will the Minister of COMMUNICATIONS be pleased to state:

- (a) the name of Post Offices in Delhi Circle where Departmental Stamp Vendors are posted;
- (b) whether the minimum sale of stamps (other than bulk sale) required for the continuance of the post is around Rs. 2,500/- or so;
- (c) if so, whether the Stamps Sale figures of each Post Office where Departmental Stamp Vendors are posted, is furnished to the Divisional Office etc. during each month;
- (d) if so, the details thereof;
- (e) whether for sale of stamps around or below Rs. 2,000/- only Extra Departmental Stamp Vendor is posted, whose salary etc. is much below than the Departmental Stamp Vendor;
- (f) if so, the details thereof;
- (g) whether retaining the posts of Departmental Stamp Vendors in Post Offices, where sale had been less than required did not result in financial loss to the Department;
- (h) if so, the details thereof;
- (i) whether the Government propose to post the said vendors as postman; and
- (j) if so, the details thereof?

Answer

THE MINISTER OF STATE FOR COMMUNICATIONS (SHRI TAPAN SIKDAR)

- (a) List of Post offices in Delhi Circle having Departmental Stamp Vendors is enclosed (Annexure `A`).
- (b) No, Sir. When average sale of stamps per day exceeds Rs. 1,000/- a Departmental Stamp Vendor will be justified.
- (c) No, Sir.
- (d) Does not arise in view of reply against para (c).
- (e)&(f) Extra Departmental Stamp Vendor is justified when total average sale of stamps per day is Rs. 600/- for 3 hrs.` workload and upto Rs. 1,000/- for 5 hrs.` workload. The Extra Departmental Stamp Vendor is paid Time Related Continuity Allowance which is less than the salary of Departmental Stamp Vendor.
- (g) A Departmental employee has to work for full eight hours even when deployed for stamp vending for sometime. The question of loss to the Department does not arise since the criterion for continuance of a post is total workload handled.
- (h) Does not arise in view of reply against para (g) above.
- (i) Posts of postmen and stamp vendors are borne on the same cadre and individual officials are transferable from one post to another, as per exigency of work.
- (j) Does not arise in view of reply to part (i) above.
