# Supply of M-17 Helicopters & T-80 Battle Tanks by Russia to Pakistan

901. DR. M. JAGANNATH: Will the Minister of DEFENCE be pleased to state:

- (a) whether Russian M-17 helicopters and T-80 battle tanks have found their way to Pakistan inspite of Russian promise to India that this war equipment will not be supplied to Pakistan;
- (b) if so, whether the Government have taken up the matter with Russia; and
  - (c) if so, the Russian response thereto?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI N.V.N. SOMU): (a) to (c) According to our information, Russian has supplied some MI-17 civilian transport helicopters to Pakistan in 1996. It has not supplied T-80 battle tanks or other arms to Pakistan. The Russian authorities have on several occasions provided high level categorical assurances that Russia was committed not to supplying arms to Pakistan.

902. SHRI PRAMOD MAHAJAN: Will the Minister of CIVIL AVIATION be pleased to state:

- (a) the height of new ATC Towers in Mumbai and Chennai airports:
  - (b) whether it is permissible under safety norms;
  - (c) if so, the details thereof; and
  - (d) if not, the action taken thereto?

THE MINISTER OF CIVIL AVIATION (SHRI C.M. IBRAHIM): (a) to (d) The matter is under examination by an expert committee.
