- (b) if so, the reasons therefor;
- (c) the special steps taken/proposed to be taken by the Government to remove this imbalance; and
- (d) the current rate of growth, State-wise?

### **Answer**

### MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI M.V. RAJASEKHARAN)

- (a): Yes, Sir.
- (b): The reasons for imbalance in the pace of development of various States include historical and geographical factors, differences in resource endowment and infrastructure development.
- (c): In addition to various Special Area Programmes already in place for the realization of this objective, a new programme, namely, Rashtriya Sam Vikas Yojana has been initiated in the Tenth Five Year Plan aiming at focused development programmes for backward areas to reduce imbalances and speed up development. From the current year, the Backward Regions Grant Fund has been established for this purpose.
