STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF STARRED QUESTION NO.392 TO BE ANSWERED IN LOK SABHA ON 23.8.2004

The State Governments have furnished the information in respect of Gross Irrigated Area to Planning Commission upto the end of the Ninth Five Year Plan (2001-02) and the same is at Annexure-I.

Irrigation being a State subject, the responsibility of planning, execution and funding of all types of irrigation projects to increase the land under irrigation primarily rests with the State Governments. However, for early completion of ongoing major & medium irrigation projects, Government of India provides Central Loan Assistance (CLA) to the State Governments under the Accelerated Irrigation Benefit Programme (AIBP) since 1996- 97. CLA under AIBP is also provided for the minor irrigation schemes of the special category areas comprising the North Eastern States and Sikkim, the hilly States of J&K, Himachal Pradesh and Uttaranchal as well as the drought prone Kalahandi, Bolangir and Koraput districts of Orissa with effect from 1999-2000.

As per information furnished by the State Governments to the Planning Commission, the target for additional gross area to be brought under irrigation during the Tenth Five Year Plan period (2002-07) in the country as a whole works out to be 10360880 hectare with the targets in respect of Maharashtra and Gujarat being 956080 hectare and 1282600 hectare respectively.
