## Will the Minister of SHIPPING, ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) whether the Government proposes to restructure the National Highways Authority of India for better financial management and to empower it to take independent decisions in view of the long delay in clearing the projects;
- (b) if so, the details thereof;
- (c) whether the Government had set up any Committee/Board in this regard;
- (d) if so, whether the said Board/Committee has submitted its reports to the Government;
- (e) if so, the details thereof and the steps taken by the Government in this regard;
- (f) whether there is any proposal to provide online information regarding engineering-procurement-construction;
- (g) if so, the details thereof;
- (h) the projects undertaken by the NHAI in various parts of the country particularly in Tamil Nadu during the last three years and current-year, State-wise; and
- (i) the progress made by NHAI to inter-connect its offices with there contractors and toll booths across the country?

## **Answer**

THE MINISTER OF STATE INTHE MINISTRY OF SHIPPING, ROAD TRANSPORT AND HIGHWAYS(SHRI K. H. MUNIYAPPA)

- (a) to (e) An Inter-Ministerial Committee (IMC) has been constituted as per one of the decisions taken by Committee on Infrastructure headed by Hon'ble Prime Minister for restructuring of National Highways Authority of India so as to make it a multidisciplinary professional body. This IMC is considering various formats for restructuring NHAI and the report is yet to be finalised.
- (f) and (g) All procurement processes are posted on NHAI's website.
- (h) The details are annexed.
- (i) NHAI offices are already connected by fax, phone and e-mail. It is proposed to further improve the connectivity by establishing a computer Wide Area Network (WAN) to inter connect all its field offices and toll plazas with the Head Quarters. The tenders have already been invited for the procurement of the whole system.
