(b) to (d) Yes, Sir. A one-man Committee under the Chairmanship of Shri K.K.Bakshi, former Advisor

(Education), Planning Commission, Govt. of India was constituted by the Navodaya Vidyalaya Samiti (NVS) to study causes of death of the students in JNVs. Steps taken by the Samiti to obviate recurrence of such instances are as follows: -

- (i) Based on a careful analysis of the circumstances, detailed guidelines for safety & security of children in JNVs have been prepared and circulated to the Vidyalayas. Implementation of these guidelines is being monitored at various levels.
- (ii) Additional female staff nurse has been posted in all such JNVs where the existing staff nurse is a male.
- (iii) Matrons on contract basis have been appointed in JNVs where the strength of girls exceeds 100.
- (iv) A film highlighting the safety & security concerns in JNVs has been produced and CDs have been provided to all the JNVs to screen it for the students so as to sensitize them.
- (v) Regular medical checkup of the students is done and comprehensive medical record of each student is maintained.
- (e)&(f) Ex-gratia grant of Rs. 50,000/- each has been provided to the families in deserving cases.
