- (a): The details of loan sanctioned and loan released by HUDCO to State Housing Boards are at Annexure-I.
- (b)&(c): The statement of position of default of Housing Boards as on 30.6.2004 is at Annexure-II.
- (d): Default Resolution Package has been worked out by HUDCO with the Housing Board of Assam, Bihar and Chattisgarh. Part amount against the above packages has been received and the balance is under follow up.

Gujarat Landless Labour Housing Board, Jammu & Kashmir Housing Board and Himachal Pradesh Housing Board are making the payment. For other Housing Boards, the matter is under follow up for recovery of dues by concerned regional offices of HUDCO at the level of Agencies taking the loan and guarantor State Governments.
