Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state:

(a) the details of the schemes under consideration pertaining to the Commonwealth Games proposed to be held in India 2010;

(b) the details of structural provisions for organising the Commonwealth Games, 2010;

(c) whether any assessment has been made to find out the cost of holding the games;

(d) if so, the total estimated expenditure to be incurred under various heads for the purpose;

(e) whether any decision has been taken regarding mobilising funds for the purpose; and

(f) if so, the sources from where these funds are proposed to be mobilised?

Answer

THE MINISTER OF YOUTH AFFAIRS & SPORTS (SHRI SUNIL DUTT)

(a) & (b) : The Commonwealth Games, 2010 have been allotted to India and are scheduled to be held at Delhi. A Core Group of Ministers (GOM) has been constituted for coordinating the work relating to the organization of the Commonwealth Games to be held in Delhi in 2010. The Organising Committee required to be constituted, as per the bid document, has not been registered. A Task Force on upgradation of Sports Authority of India's infrastructure has been constituted and Central Public Works Department (CPWD) has been engaged as consultants in this regard.

(c) & (d) : At the time of Government approval for Commonwealth Games Bid, Indian Olympic Association (IOA) had projected an expenditure of Rs.399.05 crores. Besides, Government of NCT of Delhi has projected cost of construction of Games Village at Rs.186.00 crores and Rs.32.50 crores for construction of indoor and outdoor stadium in the Yamuna Sports Complex and for upgradation of existing infrastructure of the Delhi Development Authority. The detail of the projected estimates are placed at Annexure- I. However, at the time of presentation of bid document at Jamaica the projected estimates of expenditure were revised upwards. These estimates are further likely to be revised after detailed scrutiny.

(e) & (f) IOA while submitting the proposal to Government had, on the basis of a consultants assessment, had projected revenue generation of 100 Million US Dollar.
