विदेशों से भारत के सम्बन्ध मैत्रीपूर्ण बने रहे हैं, द्यपि कभी कभी गलतफहमियां पैदा हो जाती हैं। इस समय मेरी सरकार के प्रतिनिधि चीनी गणतंत्र की सरकार से तिब्बत के सम्बन्ध में सामान्य हित के विभिन्न मामलों पर बात चीत कर रहे हैं। मझे पूरी श्राशा है कि इस बातचीत के परि-णामस्वरूप सभी विशिष्ट समस्यात्रों के बारे में समझौता हो सकेगा। सोवियत संघ भीर कई ग्रन्य देशों से हमारी व्यापारिक संधियां हुई हैं। पिछले वर्ष हमारे प्रधान मंत्री की पाकिस्तान के प्रधान मंत्री के साथ मुलाकातें हुई । ये मुलाकातें मैत्रीपूर्ण थीं और इनके फलस्वरूप दोनों देशों के बीच कई एक विवादग्रस्त मामलों के बारे में, जो बहुत दिनों से चले ग्रा रहे थे, पारस्परिक सद्भावना पैदाहो सकी। इस दिशा में हम कुछ मागे बढ़े थे पर दुर्भाग्य से कुछ ऐसी घटनायें घटी हैं जिनके कारण प्रगति में रुकावटें पड़ रही हैं। मुझे खुशी है कि मेरी सरकार श्रीर श्रीलंका की सरकार के बीच श्रीलंका के भारतीय प्रवासियों के प्रकृत पर समझौता हो गया है। इस समझौते द्वारा उक्त समस्या का भन्तिम रूप से निब-टारा नहीं होता, परन्तु उस दिशा में यह पहला कदम है भीर समस्या के हल के लिये गंभीर प्रयास है। इसलिये में इसका स्वागत

करता हूं। ग्रपने पड़ोसी राष्ट्रों, श्रीलंका तथा बर्मा से, जिनके साथ हमारा भौगोलिक ही नहीं बल्कि चिरकाल से सांस्कृतिक सम्बन्ध भी है, मैत्रीपूर्ण सम्बन्धों को उन्नत करने का मेरी संरकार सतत प्रयत्न करती रही है।

पश्चिमी एशिया के देशों भौर मिस्र के साथ हमारे सम्बन्ध मैत्रीपूणं भौर पारस्परिक सहयोग के रहे हैं। मुझे खुशी है कि सूडान के निर्वाचन भ्रायोग के भ्रष्ट्यक्ष के रूप में हमारे मुख्य निर्वाचन भ्रायुक्त की सेवामों की प्रशंसा की गयी है भौर चुनाव व्यवस्थित उग से सम्पन्न हो गये हैं। में सूडान में स्वाधीनता के उदय का स्वागत करता हूं, जो स्वयमेव तो शुभ है ही, चिरकाल से त्रस्त भौर भ्राजकल भी भ्रनेक संकटों के शिकार भ्रमीकी मूखंड की भावी उन्नति के लिये भी यह एक शुभ लक्षण है।

गत वर्ष इस प्रवसर पर मेरे ग्रमिभाषण के बाद भारतीय संघ में ग्रान्ध्र नामक नये राज्य का उदय हुन्ना है। भारतीय राज्यों में इस अभिवृद्धि का में स्वागत करता ह भीर नये राज्य की सफलता की कामना करता हूं। भारत में राज्यों के पुनर्गठन की मांग की देखते हुये मेरी सरकार ने इस कार्य के लिये एक आयोग की स्थापना की है, जिसमें योग्य भौर ग्रन्भवी सदस्य रक्खे हैं। यह कार्य बड़े और ऐतिहासिक महत्व का है। इसे बस्तुंगत रूप से पूर्ण शांतिचित्तता के साथ करना है, जिससे कि सम्बन्धित क्षेत्रों की जनता का भीर इसके साथ ही समस्त राष्ट्र का प्रधिक से प्रधिक कल्याण हो सके। मुझे पूर्ण विश्वास है कि इस भ्रायोग के काम में सभी लोग संद्भावना और समझदारी के साथ सहयोग देंगे।

'हमारे संघ के दो राज्यों में, त्रावनकोर-कोचीन भीर पटियाला तथा पूर्वी पंजाब

रियासती संघ में, भाजकल भाम चुनाव हो रहे है । उपर्यंक्त दूसरे राज्य में संविधान सुवारू रूप से नहीं चल सका श्रीर नये चनाव होने तक प्रशासन का कार्य भार मुझे अपने ग्राधीन लेना पडा ।

हमारी प्रथम पंच-वर्षीय योजना की भाषी भवधि समाप्त हो चुकी है। कुछ मामलों में प्रगति इतनी ग्रन्छी नहीं हुई जितनी हम प्राशा करते थे, परन्तु कुछ चन्य मामलों में महत्वपूर्ण प्रगति हुई है । विशेष रूप से सामुदायिक योजनाम्रों के कार्य में उन्नति हुई है और राष्ट्रीय विकास कार्य में भी, जिसका श्रीगणेश श्रक्टबर, १९५३ में हमा था, संतोषजनक उन्नति हुई है। इस कार्य में जनसाधारण का योगदान बहुत उत्साहवर्षक है। इस कार्य का यह पहलू बहुत ही आशाजनक है। यद्यपि औद्योगिक उत्पादन में भौर कई एक दूसरे क्षेत्रों में विशेष प्रगति हुई है, फिर भी व्यापक बेरोजगारी की समस्या मेरी सरकार के लिये चिन्तन का विषय है। लोगों को भ्रधिक रोजगार दिलाने के उद्देश्य से योजना भ्रायोग पहली पंच-वर्षीय योजना पर पूर्निवचार कर रहा है।

साधारण श्राधिक स्थिति में बराबर स्वार हम्रा है। १६४२-४३ में भनाजी का उत्पादन उस के एक वर्ष पहले की भ्रपेक्षा पचास लाख टन अधिक हुआ है और इस वर्ष की स्थिति भी ग्रच्छी है। खाद्य की श्स्यति में सुघार बहुत संतोषजनक है भीर देश इस दिशा में भात्मनिर्भरता के लक्ष्य की कीर तेजी से भागे बढ़ रहा है। भौधोगिक उत्पादन में, विशेष कर सूती कपड़े, कागब, रासायनिक पदार्थ, बाइसिकल, नमक भीर बहत से इंजीनियरिंग सम्बन्धी उद्योगों के क्षेत्र में उत्पादन काफी ज्यादा होता रहा है।

भोद्योगिक उत्पादन की सुचक संस्था बढ़ कर १९५३ में १३४ हो गयी जबकि १९५२ में वह १२६ थी। युद्ध के बाद से हमारे भी छी-गिक उत्पादन का यह उज्जतम स्तर है। इस्पात उद्योग के विस्तार मौर इस्पात के एक नये कारखाने की स्थापना के सम्बन्ध में इस समय ग्रन्तिम कार्यवाही हो रही है। जट भौर चाय उद्योग, जिन्हें बड़ी कठिनाइयों का सामना करना पड़ा है, भव भच्छी स्थिति में हैं।

मेरी सरकार घरेलू उद्योगों की उन्नति को विशेष महत्व देती है। मुझे खेद है कि इस दिशा में सन्तोषजनक प्रगति नहीं की जा सकी है। आशा है कि अखिल भारतीय खादी भौर ग्राम उद्योग बोर्ड . भ्रखिल भारतीय करवा बोर्ड भीर भ्रखिल भारतीय दस्त-कारी बोर्ड के प्रयत्न इस दिशा में निकट भविष्य में ही ठोस कार्य कर सकेंगे।

महान् नदीघाटी योजनाधों के सम्बन्ध में सन्तोषजनक प्रगति हुई है भौर इन योजनाओं में से कुछ पूर्णभी हो चुकी हैं भौर इस समय चालु हैं। पांच नयी योजनायें, श्रर्थात कोसी, कोयना, कृष्णा, रिहांड भीर चम्बल योजनायें, पंच-वर्षीय योजना में शामिल कर ली गई हैं। इन योजनाओं के सम्बन्ध में प्रारम्भिक व्यवस्था की जा रही है, जिससे कि मागामी वित्तीय वर्ष में इन्हें चालू किया जा सके। कोसी योजना के बारे में नैपाल सरकार से बातचीत चल रही है।

भारत के हवाई यातायात का पुनर्गठन हो चुका है भीर दो सरकारी निगम, एक भीतरी यातायात के लिये भीर दूसरा विदेशी यातायात के लिये, स्थापित किये जा चुके हैं। विचार हो रहा है कि विदेशी सर्विसों का विस्तार करके उन्हें सुदूरपूर्व तक ले जाया जाय।

पिछले साल हम ने दो युगान्तरकारी घटनामों को मनाया—जो भारत में रेल व्यवस्था तथा तार-डाक व्यवस्था की शता-डिदयां हैं। रेल यातायात में बराबर प्रगति हुई है भौर रेल के डिड्बों तथा इंजिनों के निर्माण की मोर विशेष ध्यान दिया जा रहा है। नये रेल मार्ग लोलने के लिये निकट भविष्य में कई एक बड़ी योजनामों को हाथ में लिया जायेगा। डाक भौर तार सम्बन्धी सुविधामों का भी, विशेष रूप से देहाती भौर पिछड़े हुये क्षेत्रों में, विस्तार किया गया है।

मेरी सरक।र घरों की समस्या को महत्वपूर्ण मानती है। विभाजन के बाद से विस्थापित लोगों के लिये घरों पर अभी तक ७२ करोड़ रुपया व्यय किया जा चुका है। इसके अतिरिक्त भौद्योगिक कार्यकर्ताओं के लिये घरों के निर्माण के वास्ते ऋण और सरकारी सहायता दी गयी है। सस्ते और आकर्षक मकानों के निर्माण को प्रोत्साहन देने के उद्देश्य से हाल में ही एक अन्तर्राष्ट्रीय प्रदर्शनी का उद्घाटन किया गया है, जिसकी भोर बहुतों का ज्यान आकृष्ट हुआ है।

१६५४-५५ के वित्तीय वर्ष में भारत सरकार के मनुमानित म्राय तथा व्यय का क्यौरा म्रापके सम्मुख रखा जायगा ।

 संसद् के विगत सत्र के बाद सात प्रध्यादेश प्रवर्तित करने घावश्यक हो गये । इन में से दो का सम्बन्ध उन दो मामलों से है जिनके बारे में एक विधेयक ग्रमी ग्रापके विचाराधीन है। इन में से उन सभी ग्रध्या-देशों पर विचार करने का घापको घवसर मिलेगा, जिन्हें स्थायी विधान का रूप देना घावश्यक होगा ।

भ्रापके सम्मुख २८ विषयक विचारा-चीन हैं। इन में से कुछ पर प्रवर समितियां विचार कर चुकी हैं। दसरे विधेयक जिन पर प्रवर सिमितियां आजकल विचार कर रही हैं, उक्त सिमितियों की सिफारिक्षों समेत आपके सामने रखे जायेंगे। इन विधेयकों में हिन्दू विधि के सुधार सम्बन्धी विध्यक भी सिम्मिलित हैं, जिन्हें मेरी सरकार बड़ा महत्व देती है। संसद् के इस सत्र में भापके सम्मुख अन्य विधायी प्रस्ताव भी रक्खे जायेंगे जिनका सम्बन्ध सार्वजनिक कल्याण से है। न्यायालयों के कार्य को गतिचील करने और मुकदमें बाजी के व्यय को घटाने के लिये न्यायिक कार्य प्रणाली में सुधार करने को मेरी सरकार बहुत उत्सुक है।

इस मास के भारम्भ में इलाहाबाद में कूम्भ मेले के समय एक भीषण दुर्घटना घटी। इस भवसर पर धात्रियों का भ्रपूर्व जन-समृह एकत्रित हुन्ना था। इस विशाल जन समदाय की सुविधा के लिये उत्तर प्रदेश की सरकार ने सन्तोषजनक व्यवस्था करने का बड़ा प्रथास किया था। परन्तु भ्रमा-वस्था के दिन अचानक एक दूर्घटना घटी जिसके कारण बहुत से लोग बेकाब भीड़ के पांव तले भाकर रौंदे गये भीर मर गये। इस दुखद दुर्घटना से यह शुभ समागम विषादपूर्ण बन गया भीर हमारे भनेक देश-वासियों के लिये शोक का विषय हो गया। भापकी भार से, भीर में भ्रपनी भार से. दिवंगत भारमाभ्रों के सभी सम्बन्धियों समवेदना तथा सहानुभूति भेजता हुं।

नये वर्ष का मारम्भ इस प्रक र मा है कि इस में जितनी माशा की झलक है उतना ही भय भी दिखाई देता है । शान्ति स्थापना में प्रगति भीर तत्सम्बन्धी प्रयत्नों के सफल होने की आशा है । हमें भीर विस्व को कठिन परीक्षामों का सामन। करना पड़ सकता है, इस बात की भाशंका भी है। मानव जाति के लिये इस संकट के समय में हम अपने देश की और समस्त विश्व की सेवा कर सकते हैं यदि हम उन सिद्धांतों उप प्रडिग रहें जिन्होंने अतीत में हमारा पथ-प्रदर्शन किया है और यदि हम राष्ट्र- पिता के शांन्ति , सिहण्ता और आत्म- विश्वास के सन्देश को याद रक्खें। मैं विश्वास करता हूं कि आपके कार्य कलाप में यह सन्देश आपका पथ आलोकित करेगा।

The President: Members of Parliament, I have come here, after a full year, to welcome you to the new session of Parliament. During this past year, you have had to consider many difficult problems and shoulder heavy burdens. Many those problems still remain with us. but I think that you may well look back on this year as one of considerable achievement. As a symbol of the indomitable spirit of man quering almost insurmountable obstacles and difficulties, came final conquest of Everest. With this signal achievement was associated one of our own brave countrymen. In the international sphere, the old tensions and fears continue. efforts are being continually made to find some settlement and I earnestly trust that these efforts will lead to an easing of these tensions and will point the way to some future settlement both in the West and in the Far East.

India has continued to pursue policy of peace and friendship with all the countries of the world and has not hesitated to undertake responsibilities where, it was hoped, this might enable her to perform some service in the cause of peace. Korea, my Government accepted the Chairmanship of the Neutral Nations Repatriation Commission and sent a Custodial Force to take charge of the prisoners of war, pending a final decision about their future. Unfortunately, the processes laid down in the Armistice Agreement could not be carried through, as intended, and

a difficult situation arose. The Commission will conclude its labours within a few days and the Custodial Force is gradually returning to India. The major matters of dispute in Korea have not been settled yet. I earnestly hope that an early attempt will be made in the United Nations General Assenibly, or otherwise, to give full consideration to these outstanding issues. I should like to express, on your behalf and mine, our high appreciation of the work of our representatives in the Neutral Nations Repatriation Commission in Korea and of our officers and men of the Custodial Force, who discharged their difficult and delicate tasks with ability and impartiality.

India's relations with other countries continue to be friendly, even though sometimes some misunderstandings arise. My Government's representatives are at present discussing with the Government of the People's Republic of China various issues of common concern in regard to Tibet. I have every hope that these discussions will lead to a settlement of outstanding issues. Trade agreements have been made with the Soviet Union and several other countries. In the course of the past year, meetings took place between my Prime Minister and the Prime Minister of Pakistan. These meetings were friendly and led to some understandings about various matters which have long been in dispute between the two countries. While some proin this respect, gress was made unfortunately some other developments have at present come in the way of further progress. I am glad to find that an agreement has been arrived at between my Government and the Government of Ceylon over the long standing issue of the people of Indian descent in Ceylon. This agreement does not finally solve this problem but is a first step and an earnest attempt to that end and I welcome it as such. It has always been my Government's endeavour to develop close and friendly relations with our neighbour countries, Ceylon and Burma, with whom India has not

only geographical but cultural affinities of long standing.

With the countries of Western Asia and Egypt, our relations have been of close cooperation and friendship. I am glad that the services of our Chief Election Commissioner as Chairman of the Electoral Commission for the Sudan were appreciated and successful elections were held. I welcome the emergence of self-government in Sudan both in itself and as a symbol of future progress in the Continent of Africa, which has suffered so much in the past, and is now undergoing a severe ordeal.

Since I addressed you on the last occasion, a new State in the Indian Union has come into existence, the State of Andhra. I welcome this addition to our fraternity of States and wish it success. In view of the demands for further reorganisation of the States in India, my Government have appointed a Commission for this purpose consisting of eminent and experienced members. This is a task of high and historic importance, which has to be dealt with in an objective and dispassionate manner so as to promote the welfare of the people of the areas concerned as well as of the nation as a whole. I earnestly trust that the work of this Commission will be assisted by all concerned in a spirit of harmony and understanding.

In two of our States, namely, Travancore-Cochin and Patiala and East Punjab States Union, general elections are taking place. In the latter State, the Constitution could not function properly and I had to take over charge till such time as resh elections could take place.

Half the period of the first Five-Year Plan is over. In some matters progress has not been as rapid as had been hoped, in others there has been significant progress. In particular, the Community Projects show promise and the National Extension Service, which was inaugurated in October 1953, is making satisfactory progress. The contribution of the

people has been most encouraging. This is a particularly happy feature. Although there has been marked progress in industrial production and in other respects, my Government have been concerned at the existence of a considerable volume of unemployment. The Planning Commission have undertaken a revision of the first Five-Year Plan, particularly toprovide more employment.

There has been a continued improvement in the general economic situation. The output of foodgrainsin 1952-53 was fifty lakh tons over the output of the previous year and this year's prospects are good. improvement in the food situation. has been highly satisfactory and the country is making rapid approach tothe goal of self-sufficiency. Industrial production has continued at a. high level, more particularly cotton textiles, paper, chemicals, bicycles, cement, salt and most of the engineering industries. The index of industrial production rese to 134 in 1953 from 129 in 1952. This was the highest level of industrial production: since the war. Plans for the expansion of steel production and forthe establishment of a new iron and steel plant are now being finalised. The jute and tea industries, which were facing serious difficulties, are now again doing well.

My Government attach special importance to the development of cottage industries. I regret, however, that progress in this respect has not been very satisfactory. It is hoped that the efforts of the All-India Khadi and Village Industries Board as well as the All-India Handloom Board and the All-India Handlorafts Board will yield substantial results in the near future.

Satisfactory progress has been made in the great River Valley Schemes and some of the projects have already been completed and are yielding results. Five new projects, namely, the Kosi, the Koyna, the Krishna, the Rihand and the Chambal have been included in the Five-Year

Plan. Steps are being taken to expedite certain preliminary arrangements in regard to them, and, in the case of the Kosi, to have discussions with the Government of Nepal, with a view to starting work on these new projects during the next financial year.

The Air Services of India have now been reorganised and two State Corporations, one dealing with internal airlines and the other with external services, have been formed. It is proposed to extend the external services to the Far East.

In the course of the past year, two land-marks have been celebrated, namely, the centenaries of the beginning of the Railway System and the Telegraphs in India. There has been steady progress on the railways and special attention is being paid to the manufacture of locomotives and rolling stock. Some major projects of rail construction will be taken up shortly. Postal and telegraph facilities have expanded, especially in the rural and backward areas.

My Government attach importance to the problem of housing. A total expenditure of Rs. 72 crores has been incurred on housing for displaced persons since the Partition and loans and subsidies have been given for the construction of houses for industrial workers. With a view to encouraging the building of inexpensive and attractive houses, an International Exhibition on Low Cost Housing has recently been held and has attracted much attention.

A statement of the estimated receipts and expenditure of the Government of India for the financial year 1954-55 will be laid before you.

After the last session of Parliament, it became necessary to promulgate seven Ordinances. Of these, two deal with matters in respect of which Bills are pending before you. You will be asked to consider and pass such of these as require permanent legislation.

There are 28 Bills pending before you. Some of these have been considered by Select Committees; some

others, which are still under the consideration of Select Committees, will be brought before you with their recommendations. Among these are the Bills dealing with reform of the Hindu Law to which my Government attach considerable importance. There are other legislative measures relating to matters of general public interest, which will be brought before you during the course of this session. My Government are anxious to proceed with certain reforms relating to judicial procedure with a view to expediting these processes and lessening the expenditure involved in them.

Early in this month, a tragedy took place at the Kumbh Mela in Allahabad where a vast and unprecedented gathering of pilgrims had collected. The Uttar Pradesh Government had taken great pains to make satisfactory arrangements for this great concourse of human beings. But on the Amavas day an accidental mishap led to large number of persons being crushed to death by the uncontrollable passage of others over them. grievous tragedy, which marred a happy occasion, has brought sorrow to many and, on your behalf and mine, I extend my deep sympathy to relatives of those who have suffered.

The new year begins with hope and fear evenly balanced. There is promise of achievement and of progress towards peace. There is also apprehension at the trials we and the rest of the world might have to face. In this crisis of human destiny, we can serve both our own country and the larger causes of the world only by adhering to the principles that have guided us in the past and remembering the message peace, tolerance and self-reliance of the Father of the Nation. I trust that that message will guide you in your deliberations.

### KUMBH MELA TRAGEDY

The Prime Minister and Leader of the House (Shri Jawaharlal Nehru): I crave your leave to make a reference before this House starts its work for this session on this occasion. We have

just heard the President refer in his speech to the Kumbh Mela tragedy. I have no doubt that every Member of this House as well as elsewhere will associate himself with our deep sorrow and our sympathy and condolence with not only those who are bereaved, the families of those who have suffered in this tragedy, but with many others.

This is hardly the occasion for me to go into any facts of this terrible occurrence, partly because the matter is under enquiry by a distinguished committee, and partly because the State Government concerned is dealing with the matter. Some of us here were certainly present at the Kumbh Mela on this occasion, though they may not have been on the actual scene of this tragedy. I was the Mela itself when this tragedy In fact, I was took place. a rather high place—in the balcony of the Fort-having a distant view of the whole of that mighty concourse of human beings. I do not think that anyone who saw that enormous multitude-it is estimated that at least four million people had gathered together-can ever forget it. came as a deep sorrow that, during this tremendous event when so many people had gathered together, there should have been this tragedy in which many suffered death.

As I said, I do not wish to go into the facts of this occurrence at this stage, but I think that it is right that we should begin our work today with our expression of sorrow and condolence.

Shrimati Renu Chakravartty (Basir-hat) rose—

Mr. Speaker: There is no occasion for a speech now.

Shrimati Renu Chakravartty: May I know what has happened to the adjournment motion?

Mr. Speaker: That will come in due course; not now.

I entirely associate myself with the sentiments expressed by the hon, the Leader of the House. The tragedy was so sudden and so wide, in a sense affecting everyone in the whole of the Indian Union, that it has moved every heart to its depth. I think it is but proper that we should express our deep sorrow and our condolence to the families of the deceased and others who have suffered. We shall express our condolence and sympathy by standing in silence for two minutes.

(The House stood in silence for two minutes.)

### DEATH OF SHRI NAMDHARI

Mr. Speaker: I regret to inform the House of the passing away of Shri Atma Singh Namdhari who was a sitting Member of the House, at the age of 53.

We mourn the loss of Shri Namdhari and I am sure the House will join me in conveying our condolences to his family. The House may stand in silence for a minute to express its sorrow.

# DETENTION OF SHRI BHAJAHARI MAHATA

Mr. Speaker: I have to inform the House that I have received the following communication from the Magistrate, 1st Class, Purulia, Manbhum, Bihar:—

"22nd January, 1954.

Sir.

I have the honour to inform you that I have found it my duty in exercise of my powers under section 502 Cr.P.C. 1898 to direct that Shri Bhajahari Mahata. Member of the House of the People, [a report against whom under section 9(5) of the Bihar Maintenance of Public Order Act. 1949, has been received by me] be detained for the reason that his bailor Shri Sahadeb Chakrabarty who stood surety for him on 21-1-54 when he appeared in my court in response to the summons issued by the S.D.O. Sadar Purulia, refused to stand surety for him and surrendered him in court for necessary legal action stating that Sri Mahata does not like to remain on bail. Sri Bhajahari Mahata was asked to furnish another surety but he declined to do so and instead asked for being remanded to custody in pursuance of the new policy of his party namely Lok Sevan Sangha.

Sri Bhajahari Mahata M.P. was accordingly taken into custody at 3 p.m. on 22nd day of January, 1954 and is at present lodged in the district Jail at Purulia, Manbhum."

### MOTIONS FOR ADJOURNMENT

### KUMBH MELA TRAGEDY

Mr. Speaker: I have received notices of adjournment motions relating to the same subject, viz. the Kumbh Mela tragedy,—one from Shrimati Chakravartty, one from Shri V. G. Deshpande and another jointly from Shri Kripalani, Shri Gurupadaswamy and Shri K. Subrahmanyam. Before I give my ruling, I should like to know how these motions are admissible in this House, because however unfortunate the incident may be the Mela administration was entirely a matter for the Uttar Pradesh Government, and they were in charge of the arrangements. I do not think the motions would be admissible, but should like to know from those hon. Members who have tabled the motions if they have anything to say-not on the merits but on the question of admissibility.

I may state that there is also another reason for it, and that is that a committee of enquiry has already been set up and it will be premature to discuss anything without first knowing what the facts are, as may be found by the enquiry committee.

Further, there has been a reference to this incident in the President's Address, and though the discussion may not be permissible on an adjournment motion, I think it may not be possible altogether to avoid reference to this subject during the discussion on the President's Address, because the mention has been made by the President in his Address today.

There are also other reasons, but the principal reason is that the central responsibility is not there. The Government at the Centre was not actually in charge of the administration of the Mela arrangements and I do not see how I can consent to this adjournment motion.

Shrimati Renu Chakravartty (Basirhat): May I state, Sir, first that technically you may rule it out, but even technically you cannot do so, because it is a national tragedy? On top of that it is the Central Government which authorised the Uttar Pradesh Government to impose a toll tax. Even in the matter of amenities provided for the pilgrims the Central Government took responsibility. Above all, Sir, the main reason why we should debate this matter in this House is that there were many important Union Ministers who were present there and it was the many arrangements that were made for them that was directly responsible for this tragedy. Not only that, after this tragedy had happened, several of them were attending tea parties, etc., which has shocked the whole of India.

These are the reasons, Sir, why we consider that this matter should be debated in this House.

Shri V. G. Deshpande (Guna): My submission is that this matter should engage the attention of the Centre and this House because it was a national calamity of such a colossal scale that the whole of India has been shocked. The list of casualties shows that not only people from Uttar Pradesh but also from Bihar, Gujerat and other provinces have been involved in the the tragedy. Moreover, Minister, the President of the public and the Ministers of the Central Government, as the Prime Minister himself has just now referred, were present in the Mela when this

tragedy took place. My third argument is that the President of the Republic had issued an ordinance authorising the levy of a terminal tax on railway fares. Big crowds were thus attracted and money was collected through an ordinance of the Centre for the management of the fair. Under these circumstances, and particularly as a reference has been made to a party which was given in honour of the President, which was attended by Union Ministers and State Ministers where there was music and other types of enjoyment....

Mr. Speaker: Order, order, the hon. Member is going beyond the merits of admissibility. Those facts are yet to be ascertained. I could not take them for granted from newspaper reports merely.

### Shri V. G. Deshpande rose-

Mr. Speaker: I do not think the hon. Member need proceed further.

Dr. N. B. Khare (Gwalior): May I know, Sir, why this House, the whole House, just now stood up in silence to mourn the death of the victims of the tragedy, if it was not concerned at all?

Acharya Kripalani (Bhagalpur cum Purnea): May I bring to your notice, Sir, that an unusual kind of propaganda was carried on on behalf of the Centre and facilities were promised for attending pilgrims. This had not The Railways been done before. were supposed to make arrangements for the pilgrims. But it is a fact that trains were coming over full of people. Almost every train had passenthe roof. Some of these gers on passengers were killed in transit. All these things were known to The Central Central Government. Government was responsible for making railway and transport arrangements, and during that transport there were accidents. They took no steps to discourage people from collecting together. The Centre is therefore responsible; if not, only a little less responsible than the Provincial Government.

I. therefore, submit that the Adjournment Motion is admissible on its own merits.

Shri H. N. Mukerice (Calcutta North-East): Sir, as you said, the President was advised to make a reference to this in his Address, because it is obviously a matter of national portance. Apart from the Railways which are the direct concern of the Centre, it was the Army Engineers who helped in the construction of the bridges. I am also sure that the army was called to be in readiness to come and help in any emergency. There was a discussion openly in the papers that possibly the army was kept readiness in order that the arrangements may be better.

This was a festival which even though it pertained to Hindus was one of a national character. This kind of meident having happened in circumstances which are so dubious, the State Government had to appoint a mittee to enquire into the matter. But the terms of reference of the Committee of enquiry are so inadequate that we as representatives of different parts of the country feel we should have a right to say what we think in regard to this. I hope you will take into consideration the different aspects of the matter and give your ruling after you have given really careful thought to the widespread feeling all over the country regarding the desirability of a proper enquiry into the circumstances of the incident.

Shri N. C. Chatterjee (Hooghly): May I point out one thing? Just now seven Ordinances were placed on the Table by Mr. Sinha. (Some hon. Members: Not yet placed). They are on Order Paper. Two of them-Ordinance No. 1 of 1954 and Ordinance No. 2 of 1954-directly relate to Kumbh Mela. They are promulgated under Article 123 of the Constitution of India and they could be promulgated only when it is a Central subject, only when it is within the competence of the Parliament to enact such a law;

and because it is a Central responsibility and a Central matter subject to the jurisdiction of this Parliament these Ordinances were promulgated. I submit, Sir, it is perfectly legitimate and admissible.

Dr. Lanka Sundaram (Visakhapatnam): May I read the text of the Ordinance concerned before you give the ruling. It extends to the whole of India, except the State of Jammu and Kashmir. It reads:

"There\_shall be levied on all passengers carried by railway from any railway station in the territories to which this Ordinance extends," (it extends to the whole of India), "to any of the following railway stations...".

Allahabad City and adjoining stations are mentioned. The Schedule of rates shows the rates of taxes, viz., one rupee and eight annas, one rupee, eight annas, and six annas.

The point here is that nearly Rs. 20 lakhs of the tax-payers' money from all over India has been collected to make arrangements at Kumbh Mela. All arrangements were to be made by the Railways with the assistance of several authorities, both Central and local. The question of competence of this House to deal with this matter is beyond doubt.

Speaker: I do not want to Mr. enter into any argument with the viewpoints coming from the hon. Members on this side of the House. It is obvious that the subject-matter of the Motion is what happened, actually, what may be called a grim tragedy. The fact that the Central Government gave certain facilities to raise finances to enable the Uttar Pradesh Government to make arrangements is entirely a different matter and the tragedy is not the direct result of the Ordinances being passed. Nor even the military aid given is the direct cause; perhaps the absence of it would have been a cause for complaint. Further-I forgot to mention, -I find that the matter was discussed in the Uttar Pradesh Assembly alsothat is from the Press reports-and

the Chief Minister of Uttar Pradesh, I think, has given a statement of facts and a Committee of enquiry was appointed by the Uttar Pradesh Government. All this points to the fact as to where the responsibility lies and I do not see how I can consent to this kind of Adjournment Motions on the grounds urged.

Dr. N. B. Khare: My point is not answered.

Mr. Speaker: It does not require to be answered. I am not bound to answer each and every point.

Dr. N. B. Khare: Thank you. We walk away in protest against these banqueteers and racketeers.

Mr. Speaker: Order, order.

Acharya Kripalani: Sir, we do not walk out; yet I must tell you that many of us on this side feel the same way as those who have walked out.
