The Lok Sabha met at Eleven of the Clock

[MR SPEAKER in the Chair.]

ORAL ANSWERS TO QUESTIONS

Khandwa-Hingoli Rail Link

*869. {Shri T. B. Vittal Rao: Shri Ram Krishan: Shri Krishnacharya Joshi:

Will the Minister of **Railways** be pleased to refer to the reply given to Starred Question No. 2602 on the 28th May, 1956 and state the progress made up to date in the construction of Khandwa-Hingoli rail link?

The Deputy Minister of Railways and Transport (Shri Shahnawaz Khan): The overall progress made upto 30-9-56 on this construction is 24%.

Shri T. B. Vittal Rao: May I know when the laying of track will be taken up?

Shri Shahnawaz Khan: Actually, track is being laid on certain sections and most of the earthwork is complete and we are completing the masonry work on bridges. Work is at a very advanced stage on the section from Khandwa to Budikeda and from Hingoli to Kanhaigram, and we hope by about March next year itese two sections will be open to traffic.

Shri T. B. Vittal Rao: May I know the total route mileage of track laid and also whether the construction of bridges across the two rivers that it has to cross has commenced simultaneously?

Shri Shahnawar Khan: If the hon. Member wrnts to kilow the exact piotress, I wil give the information. The earthwork has been completed on a sec ion of 74 miles and is in progress over 81 miles. Masonry work and bridges have been comple ed on 8 miles and is in progress on 98 miles. The construction of quarters has progressed fairly satisfactorily and 517 LSD-1. we have completed 278 quarters and work is in progress on 571 other quarters. The expenditure so far incurred is Rs. 246.8 lakhs.

Shri T. B. Vittal Rao: May I know whether this whole line will be open to traffic by about April 1959, as stated several months ago?

Shri Shahnawar Khan: Subject to the availability of material, we hope to open this line by December, 1959.

Shri Chattopadhyaya: May I knowif this line would be opened by phases and if so when will the first phase be opened to traffic?

Shri Shahnawaz Khan: It will be opened by phases and the first section will be opened by March next year, we hope.

Medical Education

*870. Shri Keshavajengar: Will the Minister of Health be pleased to state the results, if any, regarding the adoption of any scheme of medical education and expansion of medical facilities in the country from the talk with the expert on medical education from Australia, Sir Earle Page, on or about the 2nd April, 1956?

The Deputy Minister of Health (Shrimati Chandrasekhar): No scheme of medical education or expansion of medical facilities was proposed by Sir Earle Page. The question of adopting a scheme or thereby achieving any results does not therefore arise.

Shri Keshavalengar : May we know if this educational expert was pleased to pay any visit to the medical colleges existing in this country?

Shrimati Chandrasekher : On his way back to Australia from Pakistan he did visit some of the medical institutions.

Shri Puanoose: What are the medical institutions he visited? Did he visit the medical college in Trivandrum? I ask this in the context that the degrees given there are not recognised by other Universities.

The Minister of Health (Rajkumari Amrit Kaur): Sir Earle Page was not invited by India to visit any medical institutions. He just happened to be in India and because he has been a Minister of Health he visited some institutions, I think, in Bombay and in Delhi and, perhaps, in Calcutta also. But he did not go South so far as I know. But, in any case, he did not propound any views about medical educetion. He congratulated us on what we had done after reading our report.

Shri Velayudhan: May 1 know what is Sir Earle Page? Is he an expert on the organisation of medical facilit cs internationally, or what is his importance?

Rajkumari Andrit Kaur: Sir Earle Page is a distinguished Australian and was Minister for Health in Australia.

Railway Rolling Stock

*871. {Shri Bhagwat Jha Azad: Shri D. C. Sharma:

Will the Minister of Railways be pleased to state:

(a) how Government propose to meet the Rolli 1^e Sto k Provramme of the Indian Railways for the Year 1957-58;

(b) what would be the maximum supply of wigons by the Indian wagons manufacturers; and

(c) what would be the quantum of import in this programme?

The Deputy Minister of Railways and Transport Shri Shahnawas Khan: (a) Partly by I digenous resources and partly by imports.

(b) Indigenous capacity to the extent of 17609 waro is has been booked against 1257-58 R.S.P.

(c) A statement is laid on the Table of Lok Sabha. [See Appendix III, annexure No. 115].

Shri Bhagwat Jha Azad: With regard to the statement referred to in part (c) of the question, could I know whether we are keeping to the schedule of supply for the years 1957 and 1958 or are we in any way falling short of our schedule?

Shri Shahnawaz Khan: I am not in a position to give the exact information to the hon. Member at this stage. Our programmes have to some extent been upset by the Suez Canal, crisis.

Shri Bhagwat Jha Azad: Could I know what percentage of our present requirements is being met by the indigenous sources to which the hon. Minister referred just now? Shri Shahnawaz Khan: As far as locomotives are concerned, we are producing 14 locomotives per month at Chittaranjan, and we hope that in the course of next two or three years we will be able to step up the capacity to 240 locomotives per year —average-size locomotives. That would be enough to meet our requirements annually. Of course, there are some arrears for which we may have to import.

Regarding wagons, in fact, we are fully self-sufficient in the general type. There are a few special types of wagons which we have to import.

As far as coaches are concerned, we are self-sufficient.

Shri Bhagwat Jha Azad: What are the special types of wagons?

Shri Shahnawaz Khan: Caustic soda wagons and special types of wagons for carrying oils, refrigerators etc.

Shrimati Tarkeahwari Sinha: In view of the assurance of the Chairman of the World Bank, MI. Black that they are going to finance some of the improvements and developments on our Railways in the Second Five Year Plan, may I know how far Government expects that the quantum of import and the development programme of 1957 and 1958 will be met by the finances of the World Bank?

Mr. Speaker: It does not arise out of this.

Shrimati Tarkeshwari Sinha: It does arise; the question was what would be the import programme for 1957-58.

Mr. Speaker: How does that arise? Let us not argue the matter.

Shrimati Tarkeshwari Sinha: It does arise, Sir. You ask the Minister.

Mr. Speaker: Finance does not arise out of this.

Shri T. B. Vittal Rao: May I know whether the present production of metre gauge locomotives manufactured in TELCO is sufficient for our requirements?

Shri Shahnawaz Khan: At present the TELCO's are is manufacturing 50 locomotives a year. They are stepping up their capacity to 100 locomotives per year. When that comes about, it will be enough to meet our annual requirements.

Pandit D. N. Tiwary: The deputy Minister said that we are self-sufficient so far as coaches and wagons are concerned. May I know whether it is a fact that order have been placed in foreign countries for the import of cosches and wagors coaches especially, and if so, why orders have been placed?

Shri Shahnawaz Khan: I submitted that for our annual requirements we are now self-sufficient. But the hon. Member is fully aware that during the war time, there were great arrears, overage stock accumulated, and in order to clear up those arrears, we have to import some.

Shri Gajendra Prasad Sinha: May I know whether the final assessment for our requirement of wagons for the second Five Year Plan has been maie? Is there any possibility of shortage of wagons?

Shri Shahnawaz Khan: We have made the firal assessment. It is slightly over one lakh wagons that will be required for our next Five Year Plan, and we are fully confident of producing all those within the country, as I said, barring a few very special type of wagons.

Shri Bhaywat Jha Azed: In respect of part (b) of the question, could the Deputy Minister tell us what would be the likely increase in production?

Shri Shahnawaz Khan: At present the annual capacity of our country to produce wagons is in the neighbourhood of 20,000. We hope to step that up to about 36,000 wagons during the second plan period.

District Development Machinery

*876. Shri Ram Krishan: Will the Minister of **Planning** be plased to refer to the reply given to Starred Question No. 27 on the 16th July, 1956 and state:

(a) whether the National Development Council has completed enquiry regarding the District Development Machinery; and

(b) if so, the details thereof?

The Deputy Minister of Planning (Shri S. N. Mishra): (a) and (b). As the reorganisation of States has now been completed, the suggestions in the Second Five Year Plan will come up for consideration before the National Development Council at its next meeting on the 8th and 9th December, 1956.

Shri L. N. Mishra: May I know whether this question will be decided by the National Development Council as to who is to preside over these District Development bodies whether he is to be an official or a non-official ?

Shri S. N Mishra: I an only say that the entire gamut of who should be associated with these bodies would be gone into during the course of the investigation.

Pandit D. N. Tiwary: May I know whether the hon. Deputy Minister 18 aware that there is no non-official chairman anywhere in these Cuncils?

Shri S. N. Mishra: You would recall, Sir, that this is a question which has been recurring every week probably twice or thrice, and as many replies have been given toit.

Some Hon. Members: We are not satisfied with the replies.

Mr. Speaker: The hon. Minister cannot satisfy all.

Shrimati Renu Chakravartty: May I know whether in these District Dvelopment Committees. about which the Government is going to enter into discussion es to what will be the best form of development of this machinery whether they have asked for the opinions of the various District Committees which are existing as well as of the representatives of the Lok Sabha on these Committees?

Shri S. N. Mishra: I do not quite get the entire question. How does the Lok Sabha come in here?

Shrimati Renu Chakravartty: There has been lot of criticism on the way the District Development Machineries are functioning. When the National Development Council is going to discuss it, will it have before it the opinions of the representatives of the people as well as the various District Committees which are already functioning? I think that without doing that, orly to come to a conclusion by themselves would not give them a very correct or proper perspective.

Shri S. N. Mishra: Perhaps I should correct the impression. The National Development Council is not going to come to

conclusions and except that it is and except that it is any to decide about the investigation that whe going to be made, and that investigation men

going to decide about the investigation that is going to be made, and that investigation would necessarily be spread over a long period and would cover a large number of matters, to which the hon. Member has drawn attention.

Shri Gajendra Prasad Sinha: May I know what are the non-official agencies through which this investigation will be carried out?

Shri S. N. Mishra: This is not a question of non-official agencies going into this matter. This investigation would be carried out on behalf of the National Development Council and the National Development Council would decide about it. They have in fact already taken a decision on this matter, and about the exact composition of it, the House would be apprised of later on when a decision is taken.

Extension of Service of Retired Railway Personnel

*878. Shri Velayudhan: Will the Minister of Railways be pleased to state:

(a) what is the usual practice followed by the Railways with regard to the extension of services of retired Railway personnel; and

(b) what are the rules and whether all categories are being given such extension?

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) and (b). It is presumed that the Hon'ble Member is referring to extension of service to Railway employees beyond the age of superannuation.

Save in very exceptional circumstances, extensions are being given in ex-cadre posts of a technical nature, in which difficulty is experienced in finding a person already in Railway service within the age of superannuation.

Shri Velayudhan: May I know whether non-technical personnel, I mean, the third grade officials, are not given extensions usually, and if that was the practice, what was the policy behind it?

Shri Alagesan: In very rare cases, as I said, extensions have been given. I think extensions have been given to both gazetted as well as non-gazetted people, but the number is small. The staff are re-employed in technical and other categories when there are not enough staff to carry on the work of the various projects connected with the Plan. Shri Velayudhan: May I know when re-employment is given after retirement, the particular staff or personnel are given the lowest post, not even the same post they held?

Shri Alagesan: Rules have been laid down in that connection, and I can read out what is the position:

On re-employment after retirement the employee is given the pay he last drew or in the case of re-employment in a lower grade the pay he would have drawn in the relevant scale as applicable to him had he retired from service from such lower grade less the full pension equivalent or provident fund benefits.

Shri Velayudhan: Is it only at the discretion of the senior officials that this extension is given and is a lot of favouri ism going on in respect of re-employment?

Shri Alagesan: I am not aware of any favouritism. A number of people have been re-employed and the General Managers have been given the power to re-employ the staff. On his own the General Manager can re-employ staff for one year, the period of re-employment varies from one year to three years.

Shri T. B. Vittal Rao: What is the age of superannuation of General Managers, and out of the seven General Managers how many have gone beyond their age of superannuation?

Shri Alagesan: I do not think that any General Manager has gone beyond his age of superannuation.

Shri T. B. Vittal Rao: What is the age of superannuation of General Managers?

Shri Alagesan: I think it is 55.

(a) whether some Members of Parliament were included in the Indian delegation to the Third Session of the F.A.O. Regional Conference for Asia and the Far East held at Bandung (Indonesia) from 8th to 19th October, 1956;

(b) it so, whether those Members of Parliament attended the Conference; and 6 DECEMBER 1956

(c) if not, whether those Members have sent any representation to Government for not attending that conference?

The Deputy Minister of Food (Shri M. V. Krishnappa): (a) Yes. Prof. N. G. Riaga and D_c . Rim Subhag Singh were included in the delegation.

(b) No.

(c) Dr. Ram Subhag Singh sent a representation for not attending the Conference.

श्री रघुनाथ सिंह : क्या कारएा है कि रंगा साहब झौर डा० राम सुभग सिंह ने इस डेलीगेशन में जाने से इंकार कर दिया था।

Shri M. V. Krishnappa: Dr. Ram Subhag Singh informed us that, since this delegation was led by an official, he would not like to go. Prof. N. G. Ranga intimated that he had some local urgent work and so he could not go.

Pandit D. N. Tiwary: May I know • whether there is any provision that an official should be the leader of the delegation where non-official Members of Parliament are going in the delegation and also whether the officials are given preference over Memoers of Parliament? What is the view of the Government in this matter?

The Minister of Food and Agriculture (Sari A. P. Jain): There is no fixed policy in the matter. In the past, there have been delegations which have been led by officials but which included Mandars of Parliament. There have been other delegations which have been harded by Manders of Parliament and which included officials. Generally, technical delegations are led by officials.

Panilt D. N. Tiwary: What decision have the Government taken on the letter of Dr. Ram Subhag Singh ?

Shri A. P. Jain: The matter was discussed at the highest level. The decision was that at that late stage no change could be mide. The reasons were threefold; firstly, this delegation would deal with technical matters; secondly, the names of the delegates including that of the leader had been communicated to the FAO; and thirdly, that the delegation was to leave the next day.

Shri Kamath: Before finalising the personnel of such delegations are the would be Members informed as to who would be the leader?

Shri A. P. Jain: I am not sure whether, in this particular case, it was conveyed course this information—both the names of the memoers of the delegation as also the leader—was conveyed to the Department of Parliamentary Atlairs.

Shri Kamath: The Minister of Parliamentary Attairs should convey it to the Memoers concerned. Did he sleep over it? He is present here and so he may enlighten us.

Shri Gajendra Prased Sinha: The Minister has just now said that this was a technical delegation. What was the necessity of including Members of Parliament?

Shri A. P. Jain: Members of Parliament are always useful.

Shrimati Tarkeshwari Sinha: Before selecting the Members to represent on such delegations, did the Government care to inform them about the background of the subject and also take their acceptance before finalising the names and communicating them to the F.A.O.?

Shri A. P. Jain: The ordinary procedure was followed in this case, that is, when a Member of Parliament is included, we refer the matter to the Department of Parliamentary Affairs.

Shri L. N. Mishra: The Minister has said that the letter of Dr. Ram Subhag Singh reached him at a late stage. May I know whether the Government have formulated any policy for future guidance?

Shri A. P. Jain: The definite policy of the Government is to avoid such difficulties.

Shri Keshavalengar: May I know whether it is not a fact that the Government have always briefed non-official Members in technical matters whenever they go on such delegations ? If that is so, may we know why that procedure was not adopted in this case?

Shri A. P. Jain: Nobody has said that that procedure was not adopted. On technical matters, the delegation is briefed.

Shri Kamath: Sir, on a point of order. The Minister was good enough to tell us just now that the Minister of Parliamentary Affairs was informed, but by gesture the latter seems to say he was saying that he was not informed

The Minister of Parliamentary Affairs (Shri Satya Narayan Sinha): No, no. I did not know the purpose which the hon. Member was having in his mind. It always happens and I quite agree with my colleague. The Ministries sometimes Shri Kamath: Only sometimes ?

Shri Satya Narayan Sinha: Please have some patience and allow me to complete the sentence.sometimes send the names very late. In these cases, I do not know what I have to inform this House.

Shri Chattopadhyaya: May I know if it is the policy of the Government to exclude Opposition Members from such delegations?

Shri A. P. Jain: Members are Members.

Shri Bhagwat Jha Azad: May I know....

Mr. Speaker: Order, order. We go to the next question.

Shri Bhagwat Jha Azad: It is a very important question . . .

Mr. Speaker: Order, order. It means that they are also Members of this House.

Shri A. P. Jain: When I have said that Members are Members, I meant that all Members were equally entitled.

Sugar Factories

*882. Shri Bibhuti Mishra: Will the Minister of Food and Agriculture be pleased to state:

(a) whether Government have directed various State Governments to redistribute sugar factories in Zonal areas according to the Crushing capacities of the factories in view of the experience gained last year; and

(b) if so, whether Government would lay on the Table a copy of the revised areas allotted to Sugar Factories in Bihar?

The Deputy Minister of Food (Shri M. V. Krishnappa): (a) No, Sir.

(b) Does not arise.

श्री विभूति मिश्र : मैं यह जानना चाहता हूं कि किस फैक्टरी में शुगरकेन का कितना ऐरिया लगेगा, उसका भी रिडिस्ट्रिब्यग्रन हुम्रा है या नहीं हुम्रा है ?

खादा और कृषि मंत्री (भी अ० प्र० जैन) : इस बात के ऊपर राज्य सरकारों को बतला दिया गया था कि जिस शुगर फैक्टरी में उसकी क्रींशग कैपेसिटी से ऐरिया ज्यादा हो उसको दूसरी तरफ़ लगा दिया जाय मौर राज्य सरकारों ने कहा था कि इसके ऊपर म्रमल किया जायगा ।

श्री बिभूति मिश्र : गत वर्ष या इस वर्ष ग्रौर राज्य सरकारों ने ठीक से उसका समु-चित बटवारा नहीं किया ग्रौर किसानों का ग्रगर गन्ना बच गया ग्रौर क़ीमत कम की गई तो इसके लिए राज्य सरकार जवाबदेही होगी या केन्द्रीय सरकार पर इसकी जवाबदेहीं होगी ।

श्री झ० प्र० जैन : केन्टीय सरकार की पालिसी के बारे में राज्य सरकारों को ग्रपनी राय बतला देती है लेकिन उस काम को करना राज्य सरकारों का काम है और राज्य सरकारें ही इस मामले को भ्रच्छी तरह से समझ सकती हैं। मुक्षे इस बात का पूरा विद्यास है कि राज्य सरकारें पूरी जिम्मेदारी से काम करेंगी और वे कोई दिक्कत पैदा न होने देंगी। Shri M.V. Krishnappa : The Government of Bihar were of the opinion that the supplies from zones now allotted to different factories were hardly adequate for a full crush and the question of prolonging the crushing in 1955.56 arcse mainly because of diverting cane from unreserved areas and not from reserved fields. It is felt that it is not necessary this year.

Shri Bhagwat Jha Azad: If as a result of this cross-channel way from Centre to State and State to Centre the cane remains uncrushed, may I know whether the Central Government will stand guarantee for the loss to the agriculturists?

Shri A. P. Jain: The Central Government cannot stand any guarantee. The Central Government is trying its best to give proper advice to the States.

Shri Bhagwat Jha Azad: Then who will stand guarantee?

Shri A.P. Jain : None.

Shri Bhagwat Jha Azad: Why not?

Shrimati Tarkeshwari Sinha : In viéw of the fact that one of the factors that created difficulty last year was the starting of the crushing season very late, may I know whether Government have taken any decision in the matter and whether the season will start earlier this year ?

Shri A. P. Jain: Yes, Government have taken definite decision in the matter. So far as Western U. P. is concerned special concession has been given that is, any factory which starts crushing before th November will get a concession on the price of sugarcane to the extent of 5 annas. Two anna will be borne by the Cential Go ernment in the foim of subialy and two annas by the State Government. by remitting the cess. The cane growers will get Rs. 1-6-0 instead of Rs. 1-7-0 for the cane crushed between 4th November and 12th November. The balance of the loss will be borne by the factories. So far as Bihar is concerned, we contacted the Bihar Government and they said that no such problem of excess sugarcane arises in the State of Bihar.

Shri L. N. Mishra: Last year, we had a sad experience regarding the crushing of sugarcane in some areas of Bihar? May I know whether some steps have been taken to ensure that it is not repeated this year?

Pandit D. N. Tiwari: May I know whether the Government is in a position to say that the sugarcane grown this year is more than last year? May I also know whether in some areas it is much more and in some other areas it is less? If that is the position, may I know how the excess quantity of sugarcane in those areas will be crushed and whether sugarcane from those areas will be sent to some other areas?

Shri A. P. Jain: The production of sugarcane this year in certain areas is certainly much larger than it was last year. One of the schemes adopted to meet this situation is to start early crushing, the details of which I gave to an hon. Member only a few minutes before. The Cane Commissioners of the State Governments are in constant touch as to whether there is excess of cane in any area. If there is excess they divert it to other factories. I am sure the State Governments are taking and will take every possible step to see that wherever there is excess of sugarcane it is diverted to factories where it can be crushed.

Kosi Control Board

*885. Shri L. N. Mishra: Will the Minister of Irrigation and Power be pleased to state :

(a) whether it is a fact that Central Water and Power Commission has advised the Kosi Control Board to make some changes in the alignment of the Western Kosi embankment;

(b) if so, the exact line to be followed now; and

(c) whether any protection would be provided to Sikaria Tadika and Bhakrain etc. as a result of this ?

The Deputy Minister of Irrigation and Power (Shri Hathı) : (a) Yes, Sir.

(b) The Kosi Control Board has, at its meeting held on the 4th December, 1956, decided to build the western embankment from a point opposite to Bishunpur to a point opposite to Bhakrain and thence to Pathphinda opposite to Jhamta.

(c) Protection would be afforded to Shikaria Tardiha and Bhakrain.

Shri L. N. Mishra: May I know whether it has been reported to the Government that the people on the eastern embankment have been demanding a change in the alignment of the eastern embankment because of the fact that the gap created by the change in the alignment of the western embankment has been considerable ?

Shri Hathi: Yes, because of this the people on the eastern side also have represented to the Bihar Government that the alignment might be changed on the eastern side also.

Shri L. N. Mishra: What is the decision of the Government?

Shri Hathi : The decision of the Kosi Control Board to change the alignment on the western side was taken day before yesterday, that is on the 4th December only. The other representations were based on the representations of the people on the western embankment in anticipation that this will be sanctioned, or the Government would change the alignment on the western aide. It is for the Bihar Government and the Kosi Project authorities to consider this question also.

Shri L. N. Mishra: I want to know whether the Government have examined this proposition that all these controversies about changing of alignment arise because of the fact that the Government have as yet no definite policy about the rehabilitation of these people who are to be adversely affected as a result of the construction of an embankment, and if so, do Government piopose to have a comprehensive policy as regards the question of rehabilitation of the people?

Shri Hathi: 'In fact, last season when i isi e the area I had discussions with the Bihar Gover ment and requested them to have a detailed pla for the rehabling the source of the villages which would come within the embankments. They are considering the question.

Overcrowding in Trains

*886. Shrimati Tarkeshwari Sinha: Will the Minister of Railways be pleased to state what specific steps Government have taken to discourage unnecessary travel on railways with a view to avoid overcrowding ?

The Deputy Minister of Railways and Transport (Shri Shahnawaz Khan): It is difficult to estimate the extent of what could be called unnecessary travel especially among third and second class passengers. For their part Railways have discontinued the grant of concessions for travel to and from local melas and 'fairs'. 6 DECEMBER 1956

Shrimati Tarkeshwari Sinha: Whether it is difficult to calculate or not, the fact is that there is overcrowding in the trains. May I know what steps Government propose to take, especially in the main lines, so that overcrowding is not there?

Shri Shahnawaz Khan : We are procuring more rolling-stock; we are electrifying sections of track where it is necessary and so on. These are the steps that we are taking.

Shrimati Tarkeshwari Sinha: May I know whether the Government have any scheme or plan to double the line capacity to enable more trains to run on the lines, and if so, may I know which are the lines in which Government propose to double the line capacity?

Shri Shihnawaz Khan: It is a very big question and I will take a very long time to reply. If the hon. Member is interested, she can come to me and I will give the information.

श्रीमती कमलन्तुमति शाह : क्या यह सच है कि ग्रावश्यकता इस बात की है कि ट्रेनों में ग्रोवरकाउडिंग (भीड़) कम करने के वास्ते थर्ड क्लास के डब्बे बढ़ाए जाएं न कि एग्रर कंडिशनिंग की जाए क्योंकि जनता को उससे बहुत ज्यादा खुशी नहीं होती है ?

भी झाहनवाज कां : ग्रानरेवल मेम्बर की राय बहुत मुनासिब है । हम एग्रर कंडिश-निंग भी थोड़ी थोड़ी करेंगे, लेकिन उस के साथ जिस किस्म के डब्बे ग्राप चाहती है वह भी लगायेंगे ।

Shri Kamath: Is the Deputy Mini ter in a position to assure the House that the somewhat fantastic suggestion of Professor (or Mr.) Gilbraith that railway travel should be made more expensive in this poor country has been finally rejected by the Government?

The Deputy Minister of Railways and Transport (Shri Alagesan): This question has been answered on a previous occasion, and we made a categorical statement that we can't look at the suggestion in the conditions that obtain in the country today.

Shri Chattopadhyaya: Is it a fact that the Planning Commission has drawn the attention of the Railway Ministry to relieve overcrowding on the trains by providing more third class bogies rather than providing air-conditioned third class coaches at second class fares and if so, what decision has the Railway Board taken in this matter?

Shri Alagesan: There are many assumptions of the hon. Member which are not correct. As far as removal of overcrowding is concerned, it is true that we have not been provided with sufficient funds to remove overcrowding. The extra capacity that we will be able to create in the next five years will be only to the extent of 15 per cent. That will increase in the course of these five years. So it is feared that the present extent of overcrowding will not be very much mitigated, and the only thing that stands in the way is the question of resources.

Several Hon. Members rose.

Mr. Speaker: Order, order. We will go to the next question. This is an annual feature.

बुग्ध ऊद्योग का विकास

साद्य उपमंत्री भी मो० वे० कुम्पाथा): (क) से (घ) सभा की टबिल पर एक विवरण रस दियागया है।[देसिये परिशिष्ठ ३, अनुबन्ध संस्था ११६]।

डा॰ राम सुभग सिंह : सरकार कई स्थानों पर दुग्धशालाएं चला रही है, उन को चलाने में जो झनुभव ग्रव तक सरकार को प्राप्त हुग्रा है उस के ग्राधार पर क्या यह सम्भव है कि वह साढ़े सत्तरह करोड की योजना को सफल कर सके ? 6 DECEMBER 1956

Shri M. V. Krishnappa: Steps have been taken to implement this scheme in the next five years. As I have already stated, the scheme envisages the establishment of 36 co-operative milk unions, establishment of Colonies for milch cattle dislodged from the cities of Bombay, Calcutta, Delhi and Madras, 12 co-operative rural creameries and 7 milk products factories, etc. One milk factory has been started, and a number of units are being started in Bihar alone—in Gaya and other places. Work is on hand in Haringhata near Calcutta and we hope to finish it by about five years. An expenditure of Rs. 17 1/2 crores has been set apart for this prupose.

Dr. Ram Subhag Singh: What has been the experience of the Government in the past in running the milk dairies, for instance, in Karnal, Jabalpur and Bangalore? On the basis of their experience, do Government believe that they can, with the existing staff, succeed in implementing the policy which has been formulated for the second Five Year Plan ?

Shri M. V. Krishnappa: We have every hope to do that. We have the Aarey Milk Factory in Bombay which has been acknowledged by all distinguished visitors as one of the biggest of its kind in the whole of Asia and some of them have said that it is one of the biggest dairies in the whole world. There, nearly 12,000 milch cattle are concentrated. So, since we have succeeded in starting one such big enterprise, we hope we will be able to complete the whole scheme in the next five years.

Dr. Ram Subhag Singh: How far has the import of milk and milk products from the United States affected the growth of milk industry in this country?

Shri M.V. Krishnappa : That is very difficult to say.

Shri Tek Chand: May I know the value of the imported milk products and tinned milk;

Shri M. V. Krishnappa: This question is a bout milk dairies and other things. I am prepared to give an answer to the hon. M neber's question if a separate question is put.

Bridges Across Damodar and Rupnarain River

*888. Shri B. K. Das: Will the Minister of **Transport** be pleased to state :

(a) how far the construction of bridges on the Dimodar and Rupparain rivers on the National Highway No. 8 has progressed; (b) the estimates for these two bridges;

(c) the amount which has already been spent on it;

(d) whether the public objected to the alignment and construction of these bridges; and

(e) if so, the action taken to meet the objection ?

The Deputy Minister of Railways and Transport. (Shri Shahnawaz Khan): (a) to (c). The birdges referred to by the Hon'ble member are being constructed on National Highway No. 6 and not on National Highway No. 8. A statement giving the required information is laid on the Table of Lok Sahba. [See Appendix III, annexure No. 117].

(d) and (e). No Sir; only one representation suggesting a change in the alignment of approaches to the Rupnarain bridge was received, but there was also a counter representation against any change. On investigation it was found that the change suggested in the first representation would introduce bad curves and involve acquisition of homestead areas. It was, therefore, not accepted.

Shri B. K. Das: Has the work of acquisition of land been completed?

• Shri Shahnawaz Khan: As far as I know, it is still in progress.

Shri B. K. Das: May I know by what time the work on these projects is expected to be completed and by what time will the roads be open to traffic?

Shri Shahnawaz Khan : The bridge over the Damodar is in a fairly advanced stage. Out of a total of about Rs. 12 lakhs that have been sanctioned for it, we have already spent something like Rs. 64 lakhs. 41 per cent of the work has been completed on this bridge. I am afraid we have not been able to start work on the Rupnarain river. Tenders have been invited. It is a big work and I think it will probably take about three years from the date of starting the work.

Bhakra Control Board

*890. { Shri L.N. Mishra : Shri Shivananjappa : Sardar Iqbal Singh : Sardar Akarpuri :

Will the Minister of Irrigation and Power be pleased to state:

(a) whether it is a fact that financial and technical experts who met in Delhi during October, 1956 have recommended that the power wing of the Bhakra Project should consist of ten units, and not nine as was decided by the Bhakra Control Board; and

(b) if so, whether this recommendation has been accepted?

The Deputy Minister of Irrigation and Power (Shri Hathi) : (a) and (b). A Sub-committee appointed by the Bhakra Control Board met in October, 1956 to consider *inter alia* the necessity for a 10th generating unit at the Bhakra Dam. Sub-Committee agreed on the necessity for this unit in the interest of the development of full power potential of the Dam and recommended that the provision for it should be made in the permanent structure to the minimum extent considered essential.

This recommendation was approved by the Control Board at its 47th meeting held on the 7th and 8th November, 1956.

Shri L. N. Mishra: What will be the effect of this additional generating unit on the cost of power in Bhakra? Will it be an increase over the overhead cost of power generation ?

Shri Hathi: Naturally so, if the 10th unit is installed. At the moment the additional expenditure for civil works as well as the equipment would cost about Rs. 853 lakhs.

Shri L. N. Mishra: May I know whether Government have made any efforts to find out the comparative cost of power generated in these major river-valley projects—Bhakra, Hirakud and Damodar and, if so, how does the cost compare with each other?

Shri Hathi: We have the figures for the cost of production for power at Hirakud and Damodar. Fo. Bhakra, it is yet not possible to have actual costs, but they vary to some extent. There is not much difference.

Shri Bhagwat Jha Azad : What will be the additional power that is likely to result from the installation of this 10th generating unit?

Shri Hathi: Each unit has an installed capacity of 90,000 KW. So, the 10th unit will add an additional installed capacity of 90,000 KW. The firm capacity would be 53,000 KW.

Railway Line to Garo Hills

*892. Shri Debendra Nath Sarma: Will the Minister of Railways be pleased to refer to reply given to Starred Question No. 495 on the 30th July: 1956, and state:

(a) whether construction work on the proposed Railway line from Pandu to Garo Hills will be started during the Second Five-Year Plan period, and

(b) if not, when it is expected to start ?

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) and (b). A preliminary Engineering Survey of the Darangiri-Amjanga route and a revision of the earlier survey of the Pandu-Amjanga link have already been sanctioned. A decision regarding their construction can only be taken on receipt of these survey reports

Shri Debendra Nath Sarma: May I know whether the construction of a new railway line from Pandu 10 the Garo Hills will be taken up during the second Five Year Plan Period ?

Shri Alagesan : That will depend upon so many factors. Of course, I know that there is a persistent local demand for the construction of this line, but we have to await the result of the survey reports. It will also depend upon the availability of funds. I am unable to say anything at present.

Shri Debendra Nath Sarma: The other day, the hon. Minister replied to a question that new railway lines would be constructed in those areas where the, e are local deposits and steel projects. Experts opinion is that the Garo Hills are full or coal and limestone deposits. Is the Government going to link those areas with railway lines in order to exploit those natural resources of coal and limestone?

Shri Alagesan : That is the main justification for this project. That will be very well borne in mind.

Shri S.C. Deb : May I know whether the Government is feeling the necessity of constructing this line and whether it is commercially sound?

Shri Alagesan: There is no question of our willingness or otherwise. In fact, we will be happy to construct the line but certain preliminaries have to be gone into before the actual project is undertaken.

State Partnership in the Co-operative Banks

Shri Kamath : *896. { Thakur Jugal Kishore Sinha : Shri Deogam :

Will the Minister of Food and Agriculture be pleased to state whether any decision has been taken to advise the State Governments to chalk out a Plan for the withdrawal of the State partnership from the Co-operative Banks within the prescribed time? The Deputy Minister of Food (Shri M. V. Krishnappa) t No. On the contrary, the Rural Credit Survey Committee recommended, and the Central and State Governments have accepted that State partnership in the share capital of cooperative banks at the apex and central levels should not fall below 51cc.

Visit of Railway Employees Children to Kashmir

*903. Shri H.G. Vaishnav : Will the Minister of Railways be pleased to state:

(a) whether the Indian Railways have organised group visit by children of Railway Employees 'to Kashmir, and

(b) if so, the details thereof?

The Deputy Minister of Railways and Transport (Shri Alagesan) : (a) and (b). Childrens camps are organised by the Indian Railways at various places for the benefit of Railwaymen's children. One such camp was recently organised by the Northern Railway in Kashmir from 24th September to 6 October, 1956 and was attended by 425 children out of whom 65 were girls.

Shri H. G. Vaishnav: May I know whether the expenses for these camps are borne by the railways or some fee is collected ?

Shri Alagesan: A small fee is collected from the s aff for their children who are sent to the camps. But that covers only a small portion of the expenses. The rest met by the Staff Benefit Fund of the railway.

Shri H. G. Vaishnav : May I know whether this scheme will be applied to other railways also ind some such camps will be arranged in future also?

Shri Alagesan : Other railways have run such camps already. The North-Eastern Railway ran four such camps; the Northern Railway four camps; the Western Railway one camp; the Southern Railway two camps; the Central Railway one camp and the Eastern Railway one camp. The South-Eastern Railway is considering the question.

Train Service in Bombay

*904 {Shri Kajrolkar : Shri Tulsidas :

+

Wili the Minister of Railways be pleared to state :

(a) whether it is a fact that there has been frequent d slocation of local train services in Bombay City both on the Central Railway and on the Western Rail-Way; (b) whether it is a fact that great inconvenience has been caused to the inhabitants by such dislocation;

(c) the reasons for the frequent break downs; and

(d) what steps Government proposed to take to ensure that lcca train services on the two railways in the city run without breakdowns?

•The Deputy Minister of Reilways and Transport (Shri Shah nawaz Khan): (a) Yes, occasionally.

(b) It is appreciated that dislocation of suburban train services causes inconvenience to passengers.

(c) (i) Abnormally heavy rains and flooding of the track during the monsoon.

(ii) Failure of Electric multiple unit stock and overhead electrical equipment.

(iii) Pulling of alarm chain.

(d) All possible steps are taken to reduce failure of rolling stock and electrical equipment.

Shri Kajrolkar : What steps do Government propose to take to see that the power failure does not cccur with such frequency causing breakdowns and inconvenience?

Shri Shahnawaz Khan : In some places where the overhead electrical wiring apparatus is defective or old, we are trying to replace it.

Shri Kajrolkar : Is there any alternative arrangement in such cases, as the very life of the city comes to a standstill whenever there is such a dislocation?

Shri Shahnawaz Khan : If the train fails, they can utilise the bus service.

Shri Tulsidas : May I know whether the dislocation of traffic in this railway has been of recent origin or has this been happening before?

Shri Shahnawaz Khan : There were about 10 cases of dislocation in the course of about 8 or 9 months and most of th se cases were due to floods. We are trying to raise the level of the track and we hope that there will be fewer failures in future.

Shri Tulsidas : My question has not been replied. The floods do take place every year in Bombay because of heavy rains. Last year and the year before last also there were floods but there was no failure of the trains then. It has happened only this year. What is the reason for the recent dislocation of traffic?

Shri Shahnawaz Khan : Train failures do occur semetimes. It is not of a recent origin at all.

Shri Ramachandra Reddi : May I know whether any inefficiency in the administration was noticed within the last 9 months?

Shri Shahnawaz Khan : No, Sir.

Salarjung Sugar Factory

*906. Shri Sivamurthi Swami Will the Minister of Food and Agriculture be pleased to state :

(a) whether Salarjung Sugar Factory managing body has represented to Government to reduce the cane price by -/2/per maund from the price fixed for the year 1955-56; and

(b) if so, whether Government have agreed to the representation?

The Deputy Minister of Food (Shri M. V. Krishnappa) : (a) Yes, Sir.

(b) Not yet. The matter is under consideration.

Shri Sivamurthi Swami : Mav I know whether any representations have been made to the Ministry by the cane growers and if so, what action has been taken?

Shri M. V. Krishnappa : The cane growers have represented that there was a splt in that meeting where the decision was taken. The Cane Growers Cooperative Association have represented that it is not a correct decision and the Government should not yield to it. We are looking into the matter; we have not yet taken any decision.

Shri Sivamurthi Swami : What are the sp cial grounds represented by the managing body of this factory to reduce the cane price by 2 annas per maund?

Shri M. V. Krishnappa : The Hy-derabad Government raised the cane cess from Rs. 2 to Rs. 4 per ton. That is one reason. The factory also was in a bad financial position and they could not work economically.

Will the Minister of Food and Agriculture be pleased to state:

(a) what has been the percentage of increase in the prices of food articles since September last;

(b) what is the maximum rise in the prices of wheat, rice and pulses ; and

(c) in which States?

'The Deputy Minister of Food (Shri M. V. Krishnappa) : (a) Percentage in-crease in prices of food articles from September, 1956 to November, 1956 was 6.4%.

(b) and (c). It is difficult to indicate in which particular place all over the country, the increase in prices of wheat, rice and pulses has been the highest. The Economic Adviser's index numbers, however, show that the increase in the case of wheat was 5.6 %, rice 1.5% and pulses 6.6%.

Aid from U.S.A.

*915. Shri L. N. Mishra : Will the Minister of Food and Agriculture be pleased to state :

(a) the effects of the recent Ameri-can aid of food and agricultural commodities on the price level of food articles in our country; and

(b) the articles and quantity of such aid received so far?

The Deputy Minister of Food (Shri M. V. Krishnappa): (a) and (b). Only about 30 thousand tons of wheat has so far been rec ived. This small quantity by itself could not be expected to make an impression on the price le el with the other stocks of wheat, it has helped in keeping the prices under check. Much larger supplies of wheat are expected from U.S.A. during the next few months.

Shri Bhagwat Jha Azad : How does the price level prevailing in the month of September last compare with the price level prevailing during the same period in the previous year?

Shri M. V. Krishnappa : The indices show that in September, 1956 it was 534 points; in November, 1956, it was 564 points.

Shri Bhagwat Jha Azad : May I know the factors that were conducive to the rise in prices in the months of August and September?

Shri M. V. Krishnappa : The main factor is seasonal variation. Generally, as in the case of rice for instance, the upward trend in prices starts in September and continues up to November. Gene-rally by December the prices start coming down because of the harvest. In addition to this main factor there are various other national and international factors.

(c) the amount of mustard seeds and mustard oil transported to the State year by year from other States during the said plan period?

The Minister of Food and Agri-culture (Shri A. P. Jain) : (a) One.

(b) Partly due to decrease in acreage and partly due to unfavourable weather conditions at the time of sowing as also during the growth period of the crop.

(c) A statement showing the quantity (c) A statement showing the quantity of rape and mustard sceds imported into West Bengal from other States during the years 1951-52 to 1954-55 is placed on the Table of Lok Sabha. [See Appendix III, annexure No. 118] Figures for 1955-56 are not yet available. Similar figures in respect of mustard oil are not which here available.

All India Malnad Conference

(d) how many landless people have been allotted land?

The Minister of Food and Agricul-ture (Shri A. P. Jain) : (a) Attention of the Hon. Member is invited to the reply given to Starred Question No. 755 on 16-8-1955. For convenience, a copy of the main recommendations made by the All India Malnad Committee is placed on the Table of Lok Sabha. [See Appendix III. annexure No. 180.] III, annexure No. 149.]

(b) to (d). The total area concerned is 25,000 sq. miles. Information regarthe acreage reclaimed and developed ing out of this area, the extra production there-from and the land allotted is awaited from the State Governments.

Railway Platforms

*875. Shri Dabhi : Will the Minister of Railways be pleased to state:

(a) whether it is a fact that the Esti-mates Committee have in its Twentyfifth Report, recommended that a pucca platform surface should be provided at all stations and that the provision should accordingly be made in the Second Five Year Plan ; and

(b) if so, whether Government propose to accept this recommendation?

The Deputy Minister of Railways and Transport (Shri Shahnawaz Khan) : (a) Yes, Sir.

6 DECEMBER 1956

(b) This recommendation is in consonance with the policy already accepted by the Railways. The execution of such works, however, depends on the recommendation of the Users Amenities Committees and the availability of funds.

Gosadans

*877. Shri D. C. Sharma : Will the Minister of Food and Agriculture be pleased to refer to the reply given to Starred Question No. 965 on the 10th August, 1956 and state the nature of the scheme to improve the working of Gozadans?

The Minister of Food and Agriculture (Shri A. P. Jain) : The nature of the Scheme to improve the working of the Gosadams is as under :---

- (i) provision of better transport facilities fcr cattle intended for Gosadans;
- (ii) provision of additional facilities for private Gosadans;
- (iii) Utilisation of existing Goshalas to serve as collection centres for old and useless cattle ; and
- (iv) establishment of a 'Charmalaya' at each Gosadan for proper flaying and economic utilisation of carcasses.

Ernakulam-Kasergode Coastal Canal

*879. Shri A. K. Gopalan : Will the Minister of Transport be pleased to state:

(a) whether Government have received any proposal regarding the construction of a coastal canal connecting Ernakulam to Kasergode;

(b) if so, whether this scheme is included in the Second Five Year Plan and

(c) the steps taken so far in this regard?

The Deputy Minister of Railways and Transport (Shri Alagesan) : (a) Yes.

(b) It has not been found possible to include the Scheme in the Second Five Year Plan for financial reasons.

(c) Does not arise.

Railway Workshop at Golden Rock

*883. Shri Nambiar : Will the Minister of Railways be pleased to state :

(a) whether it is a fact that the Railway Board has instructed the Personnel Officers to maintain personal contacts with workers and redress their indiviual grievances; and (b) whether it is a fact that the workers of Golden Rock Workshop generally have no chance of representing their individual grievances to the Personnel Officer informally as suggested by the Railway Board?

The Deputy Minister of Railways and Transport (Shri Shah Nawaz Khan) : (a) Yes.

(b) No.

Wastage of Capital Assets

*884. Shri Feroze Gandhi : Will the Minister of Railways be pleased to state what action has been taken with regard to th findings of the Estimates Committee that there has been wastage of about Rs. $32 \cdot 5$ crores, in each of the years 1953-54 and 1954-55, due to the wastage of capital investments in terms of locomotives unutilised on the B.G., and, that there has been wastage of capital investments of the value of the Rs. 21 crores and Rs. 19 crores, in each of the years 1953-54 and 1954-55, due to the non-utilisation of capital assets in terms of locomotives unutilised on the M.G.

The Deputy Minister of Railways and Transport (Shri Shahnawaz Khan): The assessment of losses is based on an assumption that the best results obtained in the past could have been attained without any regard to the practical conditions operating in the years concerned. This assessment therefore, is purely thretical. However, continuous efforts has been made to get over the drawbacks of the past which were inherited as a result of the War and sustained attention has been paid to improve the operational efficiency. Results in 1955-56 and during the current year testify that the steps taken have proved effective.

Basic Training Centres

*889. Shri Hem Raj: Will the Minister of Railways be pleased to refer to the reply given to Unstarred Question No. 971 on the 25th August, 1956 and state the method to be adopted for the selection and the qualifications for admission of the artisan staff in the Basic Training Centres?

The Deputy Minister of Railways and Transport (Shri Shahnawaz Khan): A statement is placed on the Table of Lok Sabha. [See Appendix III, annexure No. 120.]

Control of T. B.

*891. Shri Gidwani : Will the Minister of Health be pleased to state:

(a) whether the Government have considered the resolution passed by the Delhi State T. B. IWorkers Association at their conference held in Delhi on 28th 6 DECEMBER 1956

October, 1956 regarding controlling T.B. on all India basis and providing expensive antibiotics free of charge to T. B. patients belonging to low income group; and

(b) if so, what is their decision?

The Minister of Health (Rajkumari Amrit Kaur) : (a) No; the resolution in question has not been received by the Government of India. But Tuberculosis Control Schemes have been taken up on an All India basis and provision has been made for them in the 2nd Five Year Plan.

(b) Does not arise.

Diversion of Madras-Calcutta Mail via Kakinada

*893. Shri Mohana Rao : Will the Minister of Railways be pleased to refer to the reply given to Unstarred Question No. 788 on the 21st December, 1955, and state whether the diversion of Madras-Calcutta Mail through Kakinada city has since been decided?

The Deputy Minister of Railways and Transport (Shri Alagesan) : Apparently the hon. Member is referring to the diversion of the Madras-Calcutta main line via Kakinada. No decision has yet been taken in the matter.

Community Development Schemes

*894. Shri Gadilingana Gowd : Will the Minister of Community Development be pleased to state:

(a) whether it is a fact that the Union Government is considering the question of setting up a proper organisation in every State to avail of the funds and facilities offered by the Centre for the effective implementation of the Community Development Schemes; and

(b) if so, when it will be set up?

The Deputy Minister of Irrigation and Power (Shri Hathi) : (a) and (b). The existing set-up in the States is adequate and no separate organisation is contemplated.

Survey of Punjab Rivers

*897. { Sardar Iqbal Singh : Sardar Akarpuri :

Will the Minister of **Transport** be pleased to state whether any survey has been made of the rivers Beas, Sutlej and Jamna to solve the problem of their navigability and silting ?

The Deputy Minister of Railways and Transport (Shri Shahnawaz Khan): A survey of the Jumna river from Agra to Allahabad has been conducted by the Central Water and Power Commission to assess its navigability. No such survey has been carried out on the Beas and the Sutlej rivers. As regards the problem of silting, the Punjab Irrigation and Power Research Institute have been carrying out regular annual surveys on the Jumna.

The position regarding silt investigation on the Beas and Sutlej is being ascertained from the State Government.

Soil Erosion

*898. Shri Sanganna: Will the Minister of Food and Agriculture be pleased to refer to the reply given to Starred Question No. 1546 on the 30th August, 1956 regarding soil . rosion schemes in Hirakud and Machkund and state :

(a) whether any report on the progress of the work has been received by Government; and

(b) if so, the details thereof ?

The Minister of Food and Agriculture (Shri A. P. Jain): (a) No progress report has been received.

(b) Does not arise.

Dairy Development Scheme in Bihar

*899. Shri M. Islamuddin : Will the Minister of Food and Agriculture be pleased to refer to the reply given to Starred Question No. 1422 on the 25th August, 1956 in regard to the Dairy Development Scheme of Bihar and state :

(a) whether the locations of the following schemes in Bihar have been decided :

(i) three co-operative milk unions,

(ii) two creameries, and

(iii) one milk-powder factory ; and

(b) whether any progress has been made in the execution of these schemes ?

The Minister of Food and Agriculture (Shri A. P. Jain): (a) Final decision has so far been taken only in respect of one co-operative milk union which will be set up at Gaya.

(b) A milk supply scheme for Gaya has been received from Bihar Govt. ard is under consideration. Surveys around Jamshedpur and Dhanbad, which are in vice for the other two co-operative milk unions, are being taken up. Khagaria area has been surveyed for one of the rural creameries and surveys of Darbhanga and Saharsa areas are in progress for locating a milk products factory.

National Filaria Control Programme

*900. Shri Amjad All: Will the. Minister of Health be pleased to state whether the State of Assam was offered the

aid of National Filaria Control Programme and whether the State gave in undertaking that it would eventually meet all the cost for continued maintenance of the programme beyond the period for which the aforesaid aid lasts ?

The Minister of Health (Rajkumari Amrit Kaur) : An offer was made but the Government of Assam have not so far agreed to participate in the National Filaria -Control Programme.

Chakmaghat Hydro-electric and Flood Moderation Scheme

*901. Shri Biren Dutt : Will the Minister of Irrigation and Power be pleased to refer to the reply given to Starred Question No. 2056 on the 12th September, 1956 and State :

(a) whether any steps have so far been taken to implement the scheme known as "Chakmaghat Hydro-Electric and Flood Moderation Scheme" of Trip tra ; and

(b) if so, the amount that has already been spent and on what items ?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) Preliminary investigations of the Scheme have been taken up.

(b) Rs. 815 have been spent so far on these investigations.

Food Situation in Orisea

*902. Shri B. C. Das: Will the Minister of Food and Agriculture be pleased to state:

(a) whether the food situation in Orissa has deteriorated during the recent few weeks;

(b) whether Government of Orissa have requested the Centre for a loan to enable it to purchase and stock foodstuff suitable for consumption by the people of Orissa; and

(c) whether the Government of Orissa have drawn the attention of the Centre to the fact that the Zonal system introduced by the Food Ministry is adversely affecting the food position of Orissa; and whether free export of rice from Orissa s a cause of the deficit food position of the State?

The Minister of Food and Agriculsture (Shri A. P. Jain): (a) and (b). No, Sir.

(c) No Zonal Scheme has so far been introduced though some discussions were held with the State Govts. Last year Orissa suffered heavily from drought and 517 LSD

floods, but this year the crop is good and the State is expected to be surplus in rice.

N.E.S. Blocks in Manipur during the Second Five Year Plan

*905. Shri Rishang Keishing: Will the Minister of Community Development be pleased to state:

(a) the number of National Exten-sion Service Blocks and Multipurpose Multipurpose Development Blocks to be sanctioned for Manipur during the Second Five Year Plan;

(b) the number of officers trained so far as village level workers, Blocks or Project Officers, Social and Educa-tion Officers etc., and

(c) the steps taken by the State Government to train officers to avoid undue delay of any development schemes for dearth of trained Officers during the Second Five Year Plan ?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) 12 N.E.S. Blocks including one multipurpose development Block.

(b) Number of personnel trained upto 31-10-1956.

(c) Training of Block Development Officers, Social Education Organisers and Extension Officers (Cottage Industries) is arranged by this Ministry. As there is no Extension Training Centre in Manipur, the Village Level Workers are trained in the Extension Training Centre at Jorhat in Assam. Allotment of Blocks to all States including Manipur is made only after adequate number of trained personnel is available to man the blocks. Training programme is so arranged that as far as possible the progress of development schemes is not held up for want of trained personnel.

Hospitals for Children

*908. Shri A. K. Gopalan: WШ the Minister of Health be pleased to state:

(a) whether Government have any schemes in the Second Five Year Plan to open more hospitals for children in India;

(b) if so, the details of the schemes;

(c) whether the Soviet Expert team which visited India to study children's diseases has submitted any report in this connection; and

(d) if so, the salient features of the Report?

The Minister of Health: (Rajkumari Amrit Kaur): (a) and (b). The Government of India have no scheme in the Second Five Year Plan for the opening of hospitals for children in India. The opening and maintenance hospitals is the responsibility of the State Governments and State Plans provide for the opening of new and expansion of existing hospitals. The Government of India have prepared a scheme for the establishment of Paediatric Centres under the Second Five Year Plan. The Plan provision for this scheme is Rs. 45 lakhs. The Central Government will bear 75% of the non-recurring expenditure and 50% of the recurring expenditure. Proposals from the State Governments.

(c) No team of Soviet Experts has been invited to visit this country to study and report on children's diseases. A team of Russian Experts has, however, been invited and is at present assisting in the development of a Children's Hospital in New Delhi. An opportunity was taken by this team to visit some Centres in the country where Children's Hospitals are comparatively well developed.

(d) The experts have made certain observations. The salient point among the observations made are (1) the inadequacy of the number of beds for children even in teaching hospitals; (2) the lack of a coordinated approach in the study of children's diseases; and (3) the comparatively poor progress in the matter of development of Paediatric Surgery.

Ganga Barrage Project

*909. { Shri Barman: Shri K. K. Basu:

Will the Minister of Irrigation and Power be pleased to state whether Government have investigated the question of having a rail-cum-road bridge and a barrage across Ganga underneath at Farakka in West Bengal?

The Deputy Minister of Irrigation and Power (Shri Hathi): The Project has not yet been fully investigated.

Gir Lions

•910. Shri Dabhi: Will the Minister of Food and Agriculture be pleased to refer to the reply given to Starred Question No. 173 on 22nd February 1956 and state:

Agricultural Programme

The Minister of Food and Agriculgave a tentative idea of their proposals for raising the targets of agricultural production at the Mussoorie Conference and furnished more detailed proposals in connection with the discussions subse-quently held by the Planning Commission with the individual States. Following these discussions the State Govt, have furnished a statement giving schemewise break-up of the revised target of agricultural production proposed by them a copy of which is placed on the Table of the House. [See Appendix III, annexure No. 123.] The revised target of agricultural production is put at 19.65 lakh tons inclusive of 15 lakh tons of foodgrains as against the target of 17 lakh tons and 12 lakh tons respectively envisaged earlier in the State Plan. In addition the State Govt. have submitted proposals for further expansion of the minor irrgation programme involving an additional expenditure of Rs. 2.8 crores and expected to benefit an area of 7.9 lakh acres and to yield an additional production of 2.53 lakh tons. They have also asked for an allocation of Rs. 46 lakhs under the plan for completing the tube-well programme continued from the First Plan. These proposals are under consideration at the moment.

International Rice Commission

The Deputy Minister of Planning (Shri S. N. Mishra): (a) and (b). The Planning Commission along with the Ministries of Agriculture and Community Development, held discussion with representatives of 19 States Governments during September and October this year and took into account the proposals from other States before working out the revised targets of agricultural production which were indicated in the press note published

on the 5th November, 1956. A copy of the press note is available in the Library. The targets were arrived at after full discussion. These targets are broken up in detail by States and it is expected that all State Governments will do their best to achieve their targets.

(c) A number of States envisaged additional allotments but it was agreed that to the maximum extent possible internal adjustments should be made and additional schemes and allotments should be considered during the next year or two and in the light of the progress made in the actual implementation of the programmes.

Waiting Rooms at Pathankot Station

(Shri Dabhi:)Shri Hem Raj: *923. {Shri Raghunath Singh: Dr. J. N. Parekh:

Besides these there are 6 retiring rooms at the Station.

(b) The waiting rooms get crowded at train times during the tourist seasons.

(c) It is proposed that during the next season one out of six retiring rooms will be converted ' into a waiting room. There are also proposals to provide 2 more 1st Class waiting rooms, one for gents and one for laides, subject to the approval of the Passenger Amenities Committee.

Cashew Factories

(a) whether any research has so far been undertaken to prevent permanent stains and bruises caused in the hands of women workers engaged in work in Cashew Factories; and

(b) whether it is a fact that almost the entire number of workers engaged in decorticating the raw Cashew nut get the above mentioned affilication?

The Minister of Health (Rajkumari Amrit Kaur) : (a) No research has so far been carried out by the Government of India to prevent stains and bruises in the hands of women workers engaged in work in Cashew Factories. (b) So far as the Central Government is aware certain operations connected with the processing of cashew nuts are associated with the risk of occupationral dermatitis due to the caustic nature of cashew nut oil. The State Governments concerned have therefore been requested to declare these operations as "dangerous operations" and to frame special rules under Section 87 of the Factories Act to ensure the safety, health and welfore of workers in the industry.

Railway Coupes

676. Thakur Jugal Kishore Sinha Will the Minister of Railways be pleased to state the categories of high officials who are entitled to exclusive use of coupes and the reference to the rules according to which they are so entitled ?

The Deputy Minister of Railways and Transport (Shri Alagesan) : The facility under reference in authorised under supplementary Rules 166-171 of the Fundamental and Supplementary Rules.

Regarding categories of High Officials who are entitled to this facility, the inforamtion is being collected and will be laid on the Table of lok Sabha.

Indication Boards on Train

The combined train was introduced from 1-10-1956 and indication boards have been provided from 13-11-1956.

The delay in providing indication boards is under investigation.

However, till the provision of indication boards on 13-11-56, indications in in chalk-mark were made on the coaches concerned and special staff and the Station Masters assisted passengers and directed them to the appropriate coaches.

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) With effect from 1-10-1956 an additional train each way has been introduced between Secunderabad and Bolarum. It js also proposed when additional coaches and locomotives becomes available to introduce one more train each way between Secunderabad and Bolarum and Faluknuma.

▶ (b) The punctuality performance of suburban trains on the metre gauge sections of the Secunderabad Division has not been satisfactory during August to October, 1956, mainly due to cautious driving on account of breaches and accidents and excessive alarm chain pulling. Special drives have been instituted with the assistance of the Police to put down the evil of alarm chain.pulling. All avoidable detentions are also promptly taken up.

Bhakra-Nangal Project

687. Shri D. C. Sharma: Will the Minister of Irrigation and Power be pleased to state:

(a) the mileage of canal construction to be undertaken by Bhakra-Nangal Project;

(c) The expenditure on works pertaining exclusively to any particular state is to be borne wholly by the State concerned. Expenditure on common works is to be shared on the basis of (i) discharge; and (ii) length of Channels for each State.

Bhakra-Nangal Power Supply

688. Shri D. C. Sharma: Will the Minister of Irrigation and Power be pleased to state:

(a) the estimated quantity of power to be supplied by the power houses at Bhakra and Nangal during 1956; and

(b) how it has been distributed among the various States?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) No power House has yet been erected at Bhakra Dam. At Nangal two Power Houses viz., Ganguwal and Kotla have been commissioned. The estimated quantity of power to be supplied by these Power Houses during 1956 is 25,91,85,000 units

(b) At present Delhi is being supplied with 21% of the power generated, and the balance is being utilised by the Punjabs The Rajasthan State is not yet in a position to utilise its share pending completion of the transmission lines and other connected works.

Shri D.C. Sharma: 689. { Sardar Iqbal Singh: Sardar Akarpuri:

Will the Minister of Health be pleased to state the number of demolition notices issued by the Delhi Development Authority after the 15th of August 1956 so far?

The Minister of Health (Rajkumari Amrit Kaur): 263 demolition notices were issued by the Delhi Development Provisional Authority during the period beginning from the 16th August 1956 till the 30th November, 1956. These notices have been served on those persons who have deliberately broken the law.

Hydro-electric Survey of Punjab

690. Shri D. C. Sharma : Will the Minister of Irrigation and Power be pleased to refer to the reply given to Starred Question No. 909 on the 9th August, 1956, and state :

(a) whether the Central Water and Power Commission has completed the survey of hydro-electric resources in Punjab; and

(b) if so, the names of the Districts which the Commission has surveyed?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) The reply is in the negative.

(b) The question does not arise.

The Minister of Health (Rejkumari Amritkaur) : (a) and (b). A statement giving the requisite information is laid on the Table of the House. [Sec Appendix III, annexure No. 129.]

Guinea Worm Disease

694. Shri Bheekha Bhai : Will the Minister of **Health** be pleased to refer to the reply given to Unstarred Question No. 1860 on the 13th September 1956 and state :

(a) the amount provided in the Second Five Year Plan for fighting guines worm discase; and (b) the ways in which the Central Government is helping in the research in this field in Madhya Pradesh, Assam, Bihar, Bhopal, Uttar Pradesh, West Bengal, Hyderabad and Coorg etc?.

The Minister of Health (Rajkumari Amrit Kaur): (a) A provision of Rs. 3.41 lakhs has been made specifically for the survey and eradication of guinea worm disease in the Second Five Year Plan of the Rajasthan State. One of the accepted methods for its eradication is the provision of a protected water supply for which Rs. 54 crores have been provided in the Second Five Year Plan by the States and Rs. 40 crores by the Centre.

(b) Results of research carried out by the Indian Council of Medical Research on the nature and control of guinea worm disease in Rajasthan are available to and can be made use of by other States. It is not necessary to carry on the research on this disease in each State.

Hybrid Maize

696. Shri R. P. Garg: Will the Minister of Food and Agriculture be pleased to refer to the reply given to Starred Question No. 1959 on the 10th September 1956 and state the quantity of the hybrid maize distributed to P.E.P.S.U. farmers during the year 1955-56?

The Minister of Food and Agriculture (Shri A. P. Jain): The Government of India did not supply hybrid maize seeds to P.E.P.S.U. during 1955-56. Certain varieties of hybrid maize seeds were procured by the Government of India through the T.C.M. during June-July, 1956 for distribution to the various States. Out of these 19,400 lbs. of seed was supplied to P.E.P.S.U. Government for distribution to the farmers.

South Eastern Railway

697. Shri S. C. Samanta; Will the Minister of **Railways** be pleased to state whether there is any proposal to rename South Eastern Railway as Steel Plant Railway?

The Deputy Minister of Railways and Transport (Shri Alagesan) : No.

Out Agency in Kushalgarh Sub-division

698. Shri Bheekha Bhai: Will the Minister of Railways be pleased to state:

(a) whether it is a fact that Kushalgarh Sub-division has been denied out agency facilities from Udaigarh despite repeated requests; and

(b) if so, the reasons therefor?

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) and (b). No request has been received so far by the Western Railway for opening an out-agency in the Kushalgarh subdivision. The Railway is, however, now being advised to examine the question of opening such an out-agency.

Forest Research Institute Dehra Dun

699. Shri Shivananjappa: Will the Minister of Food and Agriculture be pleased to to state :

(a) whether it is a fact that the Forest Research Institute at Dehra Dun has decided to run a project in the institute for regular semi-commercial trial of Kattha manufacture and for training personnel from various States;

(b) if so, when this project will be started; and

(c) the special features of the project?

The Minister of Food and Agriculture (Shri A. P. Jain): (a) Yes Sir.

(b) The project was started on 1-11-1956.

(c) Special features of the project are as follows:---

I. It is a pilot project. It does not require any heavy capital lay-out or any imported equipment.

2. With the Forest Research Institute technique of *Kattha* manufacture it is now possible to make high quality *Kattha* by cottage scale working with the same yield as normally obtained by large scale factory method. The valuable *K attha* from the

waste liquors can be recovered which could not be done by the indigenous in-dustry. The total solids recovered by the Institute method are also more than those obtained from the indigenous method.

3. The quality of *kattha* made by the Forest Research Institute method is far superior than ever produced normally both by the indigenous and factory methods.

4. By the Forest Research Institute method, it is possible to run the kattha industry not only for about 2 months in the year and in the forest areas alone but throughout the year and in any place wherever the khair wood can be made available economically.

5. While it takes about a couple of months for *kattha* to be ready for sale by the indigenous method, the Forest Research Institute method has made it possible to finish the entire processing within less than a week.

All-Kerala Municipal Conference

700. Shri A. K. Gopalan: Will the Minister of Health be pleased to state:

(a) whether Government are aware of the deliberations of and resolutions passed at the All Kerala Municipal Conference held at Quilon on the 20th and 21st October, 1956;

(b) if so, the specific features of the same; and

(c) the action taken by Government on them?

The Minister of Health (Rajkumari Amrit Kaur): (a) to (c). Yes. Govern-ment are aware that an All Kerala Muni-cipal Conference was held but they have not received a copy of the resolutions passed in the Conference.

Kakinada-Kotipalli Line

701. Shri Mohana Rao : Will ٠he Minister of Railways be pleased to state :

(a) whether there is a proposal of opening the Kakinada-Kotipalli reopening Branch Railway line; and

(b) if so, what steps have been taken ?

The Deputy Minister of Railways nd Transport (Shri Alagesan) : (a) and and (b). It has not been found possible to consider this proposal during the 2nd Five Year Plan Period in view of the curtailment of funds for the construction of newlines.

of Railway Board Reorganisation Office

702. Shri Ganpati Ram : Will the Minister of Railways be pleased to state:

(a) Whether it is a fact that reorga-nisation scheme for Railway Boards' office has been finally approved by Government; and

(b) if so, the details of the scheme and the date from which the scheme will take effect ?

The Deputy Minister of Railways: and Transport (Shri Alagesan): (a) The Secretariat Service Scheme and the Stenographers Service Scheme have been finalised and issued. The Clerical-Service Scheme is under reference with the Union Public Service Commission and the Ministry of Home Affairs.

(b) The reorganisation schemes will. have retrospective effect from 1-12-54. These schemes have been drawn up more or less on the lines of the corresponding Central Secretariat Service Schemes.

An outline of the two schemes which have been finalised, is given in the note which is laid on the Table of the House. [See Appendix III, annexure No. 130.]

Central Health Scheme

703. Shri D. C. Sharma : Will the nister of Health be pleased to-Minister state :

(a) whether it is a fact that no separate beds are reserved, in the local hospitals, for the Central Government employees drawing less than Rs. 500 p.m. who are rendered medical aid through the Central Health Scheme;

(c) whether it is also a fact that in the event of a Government servant's death in the hospital, no free or even hired ambulance facilities are provided for the transport of the deceased from the hospital; and

(d) if so, why ?

The Minister of Health (Raj-kumari Amrit Kaur) : (a) and (b). 20 beds in the Silver Jubilee T.B. Hos-pital, Delhi and 10 beds in the T.B. Hospital at Mehrauli have been reserved for Central Component control (Control for Central Government servants for all categories and members of their families for the treatment of tuberculosis. No reservation of beds has been made in any of the general hospitals in Delhi and New Delhi for any category of Government servants included in the

Contributory Health Service Scheme. The scheme is intended mainly to im- Contributory prove the out-patient and domiciliary medical facilities available for Government servants and members of their families. For the in-patient hospital treatment Government servants have to take their chance along with members of the public.

(c) and (d). A funeral van is available on hire from the New Delhi Municipal Committee for the purpose. An ambu-lance is not meant for carrying dead lbodies.

(a) whether it is a fact that most of the trains run late from Katihar-to Amingson on the Pandu region of the North-Eastern Railway; and

(b) if so, the reasons therefor ?

The Deputy Minister of Railways and Transport (Shri Alagesan) : (a) and (b). There has been a setback in the punctuality performance of trains running from Manihari ghati Katihar to Amingaon, mainly due to the late running of connecting steamers and trains. Special steps are being taken to improve the punctuality per-formance of the trains concerned.





DEATH OF DR. AMBEDKAR

The Prime Minister and Leader of the House (Shri Jawaharlal Nehru): Mr. Speaker, Sir, I have to convey to the House the sad news of the death of Dr. Ambedkar. Only two days ago, I believe, the day before yesterday, he was present in the other House of which he was a Member. The news, therefore, of his death today came as a shock to all of us who had no inkling of such a thing happening so soon.

Dr. Ambedkar, as every Member of this House knows, played a very important part in the making of the Constitution of India, subsequently in the Legislative Part of the Constituent Assembly and later in the Provisional Parliament. After that, he was not a Member of Parliament for some time. Then, he came back to the Rajya Sabha of which he was a sitting Member.

He is often spoken of as one of the architects of our Constitution. There is no doubt that no one took greater care and trouble over Constitution making than Dr. Ambedkar. He will

be remembered also for the great interest he took and the trouble he took over the question of Hindu Law reform. I am happy that he saw that reform in a very large measure carried out, perhaps not in the form of that monumental tome that he had himself drafted, but in separate bits. But, I imagine that the way he will be remembered most will be as a symbol of the revolt against all the oppressive features of Hindu society. He used language sometimes which hurt people. He sometimes said things which were perhaps not wholly justified. But, let us forget that. The main thing was that he rebelled against something against which all ought to rebel and we have, in fact, rebelled in various degrees. This Parliament itself represents in the legislation which it has framed, its repudiation of those customs or legacies from the past which kept down a large section of our people from enjoying their normal rights.

When I think of Dr. Ambedkar, many things come to my mind, because he was a highly controversial figure. He was not a person of soft speech. But, behind all that was this powerful reaction and an act of rebellion against something that repressed our society for so long. Fortunately, that rebellion had the support, not perhaps in the exact way he wanted it, but in a large measure, the principle underlaying that rebellion had the support of Parliament, and, I believe, every group and party represented here. Both in our public activities and in our legislative activities, we did our utmost to remove that stigma on Hindu society. One cannot remove it completely by law, because custom is more deep-rooted

and, I am afraid, it still continues in many parts of the country even though it may be considered illegal. That is true. But, I have no doubt that it is something that is in its last stages and may take a little time to vanish away. When both law and public opinion become more and more determined to put an end to state of affairs, it cannot last long. Anyhow, Dr. Ambedkar, as I said, became prominent in his own way and a most prominent symbol of that rebellion. I have no doubt that. whether we agree with him or not in many matters, that perseverance, that persistence and that, if I may use the word, sometime virulence of his opposition to all this did keep the people's mind awake and did not allow them to become complacent about matters which could not be forgotten, and helped in rousing up those groups in our country which had suffered for so long in the past. It is, therefore, sad that such a prominent champion of the oppressed and depressed in India and one who took such an important part in our activities, has passed away.

As the House knows, he was a Minister, a member of our Cabinet, for many years, and I had the privilege of co-operating with him in our Governmental work. I had heard of him and, of course, met him previously on various occasions. But, I had not come into any intimate contact with him. It was at the time of the Constituent Assembly that I got to know him a little better. I invited him to join the Government. Some people were surprised that I should do so, because, it was thought that his normal activities were of the opposition type rather than of the governmental type. Nevertheless, I felt at that time that he had played an important and very constructive role in the making of the Constitution and that he could continue to play a constructive role in governmental activities. Indeed, he did. In spite of some minor differences here and there, chiefly, if I may say so, not due to any matters of principle, but rather linguistic matters and language used.

we co-operated in the Government for several years to our mutual advantage, I think. Anyhow, a very leading and prominent personality, who has left his mark in our public affairs and on the Indian scene. has passed away, a personality who was known to nearly all of us here, I suppose, and I feel sure that all of us feel very sad. We know him well. He had been unwell for a long time. Nevertheless, the passing of a person is painful. I am sure that you, Sir. and the House will be pleased to convey our deep condolences and sympathy to his family.

There are various rules laid down in our Rules of Procedure in regard to such occurrences, in regard to adjournment of the House. Normally speaking, those rules apply to Members of the House. Dr. Ambedkar was not a Member of this House. He was a Member of the Rajya Sabha. He was an ex-Member of this House. The rule says that in such cases, a reference may be made in the House. but there may be no adjournment unless he comes in the category of outstanding personalities, in which case, total adjournment may be made. There can be no doubt that he comes under the category of outstanding personalities. According to the strict rule, it says, token adjournment may be made. I submit that, without doing any violence to this rule or to the spirit underlying this rule, the present case deserves for some reasons which I have mentioned and others which I have not mentioned, that the House do adjourn for the day. That is subject to your wishes and the wishes of the House.

Shrimal Renu Chakravartty (Basirhat): Sir, I join the Leader of the House in requesting you to convey to the members of the family of Dr. Ambedkar the condolences of our party and our colleagues.

We, younger Members, never had the privilege of working with him.

We had also our difference. But, today, we all of us cannot forget how he brought to the forefront of our people's conscience the disabilities suffered by a section of our people owing to our oppressive social system. Personally I feel that, although we have passed the Hindu Code Bill in parts, the principles which Dr. Ambedkar had embodied in his ori-ginal draft were wiser in many aspects. We also pay our tribute to his outstanding intellect which rose against social inequality and narrow prejudices, and he became one of those who were known as the architects of our Constitution, and I am sure the country will remember him embodied in that Constitution. I also join with the leader of the House in requesting you to adjourn this House as a mark of respect to his momory.

Shri Asoka Mehta (Bhandara): I wish to associate myself with the tribute that has been paid to Dr. Ambedkar.

I was privileged to be associated with him on more than one occasion. and in his remarkable and fascinating career, there were many facets. We who come from Bombay remember him as a teacher, we remember him as an economist, we remember him as a labour leader, we remember him as political leader. Apart from the great work that he did in this House and as a Member of the Government, as far as my part of the country is concerned, he brought a new awakening. It was because of him that large sections of people on our side were given a sense of social significance, they were given a sense of confidence. I believe if he had not been there, perhaps my part of the country would not have been what it is today.

I am sure in paying our respect to his memory and in trying to do honour to him by adjourning today, we only pay the great debt that many of us owe to him for the great services that he has rendered to our society.

Shri Frank Anthony (Nominated— Anglo-Indian): I would like to associate the Independent Group with the sentiments that have fallen from the Leader of the House.

It has been my privilege to know Dr. Ambedkar for many years, and I feel that no adequate tribute can be paid to him in the course of a few minutes. His was a versatile mind. He was not only a deep, but a profound scholar, and, as the Leader of the House said, he was a controversial figure. But what I believe was the dominant characteristic of the complex personality was the characteristic of being an indomitable fighter, and it was that indomitable spirit which enabled him to triumph over personnal disabilities which perhaps would have crushed persons of less tenacious character.

We may not have agreed with his politics. Perhaps we did not agree sometimes with the way that things were said by him, but having heard from him the bitter personal disabilities with which he was confronted from his earliest life, I would not presume to judge the fact that perhaps in some respects the iron had entered his soul and his bitterness to that extent, if not justified, at least was understandable. There is no doubt that Dr. Ambedkar started from the humblest beginning, but his name will be writ large on the scroll of Indian history, and I believe not only his community, but that the country has reason to be proud of a very great son. I would ask you to convey our condolences to his family.

Shri Gadgil (Poona Central): Normally after the Leader of the House and my party has spoken, there is no justification for me to speak, but I plead this justification that I had the privilege of Dr. Ambedkar's friendship for over 35 years. He was ten times dearer to us Maharashtrians than what he was to India as a whole. It was he who created a sense of selfrespect and importance in the most down-trodden community in our area. Undoubtedly he was very bitte! in his tongue, but his heart was sweet His faults we all know, but his virtues outweighted them.

What he did in the matter of framing our Constitution is sufficiently well known. But, essentially, he was a rebel against the injustice in the status quo, whether the sphere was social or economic.

Lastly, he was thinking on much more progressive lines. Very recently, I had some discussion with him, and he said, 'No more privileges to the Scheduled Castes. Now, they must come into their own and fight against the injustice that is still there, along with the rest of the members of the whole Indian community.' Such a whole Indian community.' Such a in this world must pass away.

Let us, therefore, remember what good he did, and deserve by what he did and progressively achieved—the objects for which he stood.

I associate myself with the sentiments expressed by other Members of this House.

Mr. Speaker: I fully associate myself with all the sentiments expressed on the floor of the House by the Leader of the House and the leaders of various groups, and I am sure the House will equally associate itself with those sentiments. Dr. Ambedkar was a great and dynamic personality. He rose from humble beginnings and became a leader of the Scheduled Castes. He was a great scholar and writer, and, more than all, he was a powerful speaker.

He piloted our Constitution. In the field of social reform, he initiated many wholesome measures. In his death, India has lost one of her great sons. I shall convey the sentiments of this House and the condolences to the members of the bereaved family.

As a mark of respect, I am sure the House would like to adjourn today. In sorrow, we shall stand for a minute in silence.

The Members then stood in silence for a minute.

Mr. Speaker: The House will now stand adjourned as a mark of fespect to him, and meet again at 11 A.M. tomorrow.
