- (a) & (b) Details of State-wise number of project received, sanctioned and funds released under the Innovative Stream for Rural Housing & Habitat Development are at Annexure. The Scheme has been discontinued with effect from 1.4.2004; hence no proposal is under consideration.
- (c) & (d) No, Sir.
- (e) & (f) Since the Scheme has been discontinued with effect from 1.4.2004, no proposal is under consideration with regard to Andhra Pradesh.
- (g) & (h) Yes, Sir. Small Rural Housing Schemes namely Innovative Stream for Rural Development & Habitat Development, Rural Building Centres (RBCs), Samagra Awaas Yojana (SAY) have been discontinued with effect from
- 1.4.2004 and merged with the main scheme i.e. Indira Awaas Yojana (IAY) to give more thrust for construction of maximum IAY houses for eligible Below the Poverty Line (BPL) families in rural areas.
