FUNCTIONAL AND CLOSED MSMEs

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of functional and closed down Micro, Small and Medium Enterprises (MSMEs) in the country, State-wise;
- (b) the details of share of MSME products in the export of the country during each of the last three years;
- (c) the details of employment opportunities provided including for the women in rural and tribal areas in the country during the said period, State-wise; and
- (d) the details of measures taken to provide employment to closed small-scale industries in the country?

Answer

MINISTER OF STATE (INDEPENDENT CHARGE) FOR MICRO, SMALL AND MEDIUM ENTERPRISES(SHRI DINSHA PATEL)

(a): The details of the functional and closed down Micro, Small and Medium Enterprises (MSMEs) are collected through an All India Quinquennial Census of Registered Micro, Small and Medium Enterprises. As per the Quick Results of Fourth All India Census (Reference Year 2006-07), State-wise details of registered MSMEs which are functional and closed down are as given in the Annexure I.

(b): Based on the data received from Export Promotion Councils (EPC), the share of Micro and Small Enterprises (MSEs) in the total exports of the country for the years 2005-06, 2006-07 and 2007-08 were 32.92 %, 31.92 % and 30.80% respectively.

(c): Based on the Fourth All India Quinquennial Census of Micro, Small and Medium Enterprises (Reference Year 2006-07), and 5th Economic Census of Central Statistical Organization, Ministry of Statistics and Programme Implementation, the State-wise details in respect of estimated employment generated by micro, small and medium enterprises for 2006-07 are given in the Annexure II.

(d): The Central Government implements several schemes/programmes for promotion and development of MSMEs and for employment generation. To facilitate the promotion and development of micro and small enterprises and enhance their competitiveness, the Government announced a 'Policy Package for Stepping up of Credit to Small and Medium Enterprises (SMEs)' on 10th August 2005 which envisages public sector banks to fix their own targets for funding SMEs in order to achieve a minimum 20 % year - on- year growth in credit to the SME Sector. The Government has also announced in February 2007 a 'Package for Promotion of Micro and Small Enterprises' with an objective to provide support in areas of credit, technology upgradation, marketing, infrastructure, etc. Further, the Government has enacted the Micro, Small and Medium Enterprises Development Act, 2006, which has come into force from 2nd October, 2006. The Government is also implementing several schemes/programmes, which include the National Manufacturing Competitiveness Programme and schemes relating to credit, infrastructural development, technology upgradation, marketing, entrepreneurial/skill development, etc., for assisting the MSE Sector in meeting the challenges. Some of the major schemes / programmes being implemented are Credit Guarantee Scheme, Credit Linked Capital Subsidy Scheme, Performance and Credit Rating Scheme, Cluster Development Programme, National Manufacturing Competitive Programme, Prime Minister's Employment Generation Programme (PMEGP) and Market Development Assistance Scheme.
