- (c) if so, the details of present ratio and whether the Government of Kerala has met the required portion of its share; and
- (d) if not, the means through which the Railways propose to complete these projects indicating the time frame as well?

The reasons for delay in execution of ROB Projects in Kerala are as under:	

Delay in finalization of alignment by State authorities, preparation of General Arrangement Drawing (GAD) and subsequent alterations. There are 15 such cases pending in Kerala.

Delay in acquisition of land in approaches. There are 31 cases pending for land acquisition in Kerala.

For Kerala ROB/RUB projects, there are labour problems.

Works entrusted to M/s. RBDCK (Road & Bridge Development Corporation of Kerala), a State Govt. PSU, are progressing slowly due to their financial problems.

- # Delay in diversion of road traffic, closure of Level Crossings (LC), provision of temporary LCs.
- # Delay in diversion of utilities like water lines, drainage lines, electrical lines, telephone lines by various agencies.
- (b): No, Madam, the cost sharing continues to be 50:50% between Railway and State Government.
- (c): Does not arise.
- (d): Railways have allocated requisite fund in the Budget for ROB works. Where land acquisition or GAD issues are not pending, the works are progressing and have been planned for completion in Railway portion as per schedule. There will not be any financial constraint in completion of these ROBs so far as Railway's share and railway track portion are concerned. However, the progress of approach portions (by State Government) and progress of entire ROB/RUB, if executed fully by RBDCK, depends upon the State Govt./ RBDCK, for which the State Government of Kerala is to arrange funds as per State Govt's share.
