(a) & (b): Three external funding agencies, namely World Bank, Department for International Development (DFID) and European Commission (EC) provide support to the Sarva Shiksha Abhiyan (SSA) programme in accordance with SSA's existing Framework of Implementation. The external agencies provide sector support to the SSA programme, which means that funds are not tied to any specific segment of the programme, but are in the form of general support to SSA, and encompass a range of interventions, including inter alia opening and construction of new schools, additional classrooms and other civil works, provisioning for teachers, teacher training, textbooks, academic resource support through establishment of block and cluster resource centres, community mobilisation, training of community members, and innovations to promote education of girls, SC, ST and Minority children, as well as Computer Aided Learning. The external agencies have provided support in two phases, namely Phase-I for the period 2004-07, and Phase-II for the period 2007-10. The details of reimbursement made to the Central Government by the external agencies during the last three years are as under:-
