(a) The present status of poultry and dairy in Maharashtra is as under:

Poultry

# Maharashtra has 64.76 million numbers of poultry as per 18th Livestock Census data and stands fourth in the country after Tamil Nadu, Andhra Pradesh and West Bengal.

# As per Animal Husbandry Statistics 2010 (series 12) egg production estimates in Maharashtra is 3864 million numbers and stands third in egg production in the country after Andhra Pradesh and Tamil Nadu.

# Poultry meat production is 3,09,000 tonnes in Maharashtra i.e. third in position after Tamil Nadu and Andhra Pradesh.

# Per Capita availability of eggs in Maharashtra is 35 numbers per year.
