Will the Minister of CIVIL AVIATION be pleased to state:

- (a) the details of the major Civil Aviation projects sanctioned by the Government during the last three years for development of infrastructure at various airports in the country;
- (b) the progress of work under these projects as on date;
- (c) whether the work on these projects is going on as per schedule;
- (d) if not, the details of the projects where the progress of work is tardy and behind the schedule; and
- (e) the steps being taken to expedite work under these projects?

Answer

(a), (b), (c), (d) & (e): A Statement is laid on the Table of the House.

Statement in reply to parts (a), (b), (c), (d) & (e) of the Lok Sabha Starred () Question No.282 dated 23.07.2009 regarding Civil Aviation Projects.

(a) & (b): Airports Authority of India (AAI) has entered into an Operation, Management & Development Agreement (OMDA) with the M/s Delhi International Airport Private Limited (DIAL) and Mumbai International Airport Private Limited (MIAL) for modernisation and development of Delhi and Mumbai airports respectively. DIAL & MIAL have undertaken all the Mandatory Capital Projects at the airports as per schedule stipulated in the OMDA . AAI have undertaken development projects at various airports as under:

(i) The projects completed during the last three years are: Amritsar-expansion & modification of terminal building, extension of runway, apron technical block cum control tower, cargo complex and operational wall; Dehradun- construction of runway & control tower cum technical block; Kangra-extension of runway, construction of apron, taxiway, terminal building, car park, operational wall, drainage, etc; Jaipur-construction of new international terminal complex; Jodhpur-extension of apron and allied works; Kargil- construction of new airport; Khajuraho-extension of runway, construction of new apron & taxiway; Kullu-construction of new terminal building and pavement works; Lucknow-resurfacing of taxi-track & extension of apron, isolation bay & runway and extension of runway, Pathankot-development of civil enclave including residential quarters; Srinagar- expansion & modification of terminal building complex; Udaipur-construction of new terminal building complex, extension of apron, link taxiway & runway; Varansi- extension & strengthening of existing runway and provision of shoulders; Bhubaneswar- extension of runway and expansion of apron, construction of additional taxiway; Gaya-construction of new terminal building & allied structure; Cooch Behar- construction of new terminal building; Raipur-strengthening and expansion of apron; Agartala- expansion of terminal complex, apron and construction of new technical building cum control tower; Dibrugarh-construction of new terminal building including land acquisition; Dimapur- resurfacing of runway; Guwahati-extension of runway & construction of new apron with link taxiway; Imphal- resurfacing of runway, construction of isolation bay, extension of apron & link taxiway; Lilabari- construction of new terminal building; Silchar-extension of runway, acquisition of land & construction of boundary wall; Ahmedabad- construction of new departure block for domestic terminal building, isolation bay and parallel taxi track, new arrival block, construction of new apron; Aurangabad- construction of new apron, new terminal building; Bhuj-construction of new civil air terminal; Gondia- construction of new passenger lounge, control tower, fire station, boundary wall; Indore-construction of isolation bay and taxiway; Surat-development work; Nagpur- expansion and modification of terminal building for international operations; Porbandar- construction of new terminal building and associated works; Agatti- construction of terminal building, fire station and control tower; Calicut- resurfacing of runway and allied works, expansion and modification of integrated terminal building including electrical packages; Coimbatore- extension of runway; Madurai- strengthening and extension of runway; Mangalore- construction of apron; Mysore- pavement work; Puduchery- construction of runway; Tirupati- resurfacing and strengthening of runway, taxi track, apron, isolation bay etc.; Trichy- construction of new apron, taxi track and new terminal building; Vizag-construction of new integrated terminal building.

(ii) The projects where the works are in progress: Chandigarh-construction of new integrated terminal building; Dehradun- construction of new terminal building and allied works; Jaipur- construction of new apron and taxiway; Jaisalmer- construction of new civil enclave; Khajuraho-construction of new integrated terminal building; Lucknow-construction of new international terminal building, new apron & taxiway; Srinagar- expansion of apron phase-II; Udaipur-construction of control tower and technical block; Varansi- extension and

strengthening of apron and runway, construction of new integrated terminal building including aerobridge; Ludhiana- strengthening/ resurfacing of runway & apron/taxiway; Bhubaneswar- construction of new integrated passenger terminal building; Port Blair- expansion of apron and additional taxiway; Ranchi-expansion of apron and construction of isolation bay, new integrated passenger terminal building, resurfacing of runway; Raipur- construction of new expandable modular integrated terminal building; Kolkata- construction of passenger terminal building, extension of secondary runway, etc.; Agartala- strengthening of existing runway; Barapani (Shilong)- construction of new terminal building & expansion of runway; Bagdogra- extension of apron; Dimapur- expansion of apron & construction of link taxiway; Guwahati- construction of isolation aircraft parking stand; Imphal- construction of new apron; Pakyong- construction of new airport; Ahmedabad- construction of new international terminal building Phase-I & II; Aurangabad- extension of runway; Bhopal- construction of new expandable modular terminal building, new apron, extension of runway; Goa- new international terminal, car part, extension of apron and allied works; Gondia- construction of parallel taxiway, NIATAM and two nos. of additional hangers; Indore- construction of new terminal building; Pune- extension and modification of terminal building; Agatti- construction of terminal building, fire station and control tower; Coimbatore-expansion and modification of terminal building, construction of part parallel taxiway and expansion of apron; Cuddapah- construction of runway, taxiway and apron; Chennai- construction of domestic terminal and extension of existing international terminal and extension of secondary runway; Madurai- construction of terminal building and allied works; Mangalore- construction of new terminal building; Mysore- development of building work; Rajamundry- construction of new terminal building including car park; Trivendrum- construction of new international terminal building and apron; Vijaywada- extension of runway.

In addition to above, AAI have also undertaken major CNS projects at various airports.

(c) & (d) Development work at most of the airports including Delhi and Mumbai are as per schedule.

(e) An OMDA Implementation Oversight Committee has been constituted under the chairmanship of Secretary, Ministry of Civil Aviation, to coordinate and monitor the development works at Delhi and Mumbai. Besides, AAI have also set up an independent department, Project Monitoring and Quality Assurance Department, to ensure regular monitoring and quality assurance of the development work which has been undertaken by AAI.
