## Will the Minister of POWER be pleased to state:

(a) whether the target set for electrification of un-electrified villages and providing electricity connection to Below Poverty Line people/households for the sanctioned projects under the Rajiv Gandhi Grameen Vidyutikaran Yojana (RGGVY) during the Eleventh Five Year Plan period has been achieved so far;

- (b) if so, the year-wise and State/UT-wise details of the target achieved so far and if not, the reasons therefor;
- (c) whether the electrification work under the scheme is yet to commence in some of the States;
- (d) if so, the State-wise details thereof along with the reasons therefor; and
- (e) the steps taken/proposed by the Government to initiate the electrification work in such States without further delay?

(a)&(b): Under Rajiv Gandhi Grameen Vidyutikaran Yojana (RGGVY), the year-wise target and achievement in respect of electrification of un/de-electrified villages and release of electricity connections to Below Poverty Line (BPL) households in the country during the 11th Five Year Plan period is as under:-

It is evident from the above table that the targets in respect of both un/de-electrified villages and BPL households for the year 2007-08, 2009-10, 2010-11 have been achieved. The targets set for the year 2008-09 could not be achieved because the approval of Government for continuation of RGGVY scheme for 11th Plan was received in January, 2008 and necessary order was issued by this Ministry on 6.2.2008. This in turn affected the progress of RGGVY projects during the year 2008-09.

The State-wise and Year-wise details of targets and achievement of electrification of un/de-electrified villages and release of BPL connections for the sanctioned projects under RGGVY is at Annex-I & II respectively.
