THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (DR. CHARAN DAS MAHANT)

(a)&(b): The Ministry under its Plan Scheme for Technology Upgradation/ Establishment/ Modernization of Food Processing Industries (FPIs) extends the financial assistance for setting up of new food processing units as well as technological upgradation and expansion of existing units in the country. Ministry extends financial assistance in the form of grants-in-aid to entrepreneurs @ 25% of the cost of Plant and Machinery and Technical Civil Works subject to a maximum of Rs. 50 lakhs per project in general areas and @ 33.33% subject to maximum of Rs. 75 lakhs per project in difficult areas. The details of the financial assistance provided to the entrepreneurs in the country during 11th Plan period is annexed. Ministry has engaged a professional agency to maintain the status of proposals under the scheme. Under this arrangement, the details of all the pending applications alongwith their present status has been kept in the public domain on the website of the Ministry.
