(c) whether the Government has taken any steps towards renovation and modernisation of libraries across the country including upgrading the standards of documents preservation;

(d) if so, the details thereof alongwith the amount of funds allocated for the said purposeduring each of the last three years; and

(a) and (b). The libraries declared as 'heilitidions of National Importance' and certain other national evel libraries that are controlled by the Ministy of Culture, (including National Library, Kolkata, Khuda Bakheh Oriental Public Library, Patra, Rampur Raza Library, Rampur, Deh Public Library, Deh, Certarl Reference Library, Kolkata and Certral Secretariat Library, New Dehi) are in a good condition, and are providing requisite services to the readers.

(c) & (d): As 'library' is a subject in the State list of VII Schedule of the Indian Constitution, the renovation and modernization of public libraries in the country is the responsibility of State governments, in the libraries under the Ministry of Culture, a number of measures such as modernization, renovation and preservation projects between the undertaken. The projects include the projects between

(i) Access to online full texts, scholarly journal

(ii) Online public access catalogue for library users.

(iii) Digitization of old and rare books including manuscripts.

(iv) Conservation and preservation of rare books and manuscripts using modern techniques, etc.

In addition, the Raja Rammohan Roy Library Foundation (RRRLF), an autonomous body under the Ministry of Culture, provides financial assistance to libraries maintained by the State Governments, and NGOs under matching and non-matching schemes for modernisation and renovation of public libraries.

Details of the assistance provided by RRRLF is as follows:

(e) Efforts have been made by the concerned libraries to fill up the vacant positions through

Staff Selection Commission and Union Public Service Commission. In case of autonomous bodies, filling up of the vacant posts is done through open advertisement
