(c)&(d) Government outsourced the job of making CGHS Plastic cards to National Informatics Centre Services Incorporation (NICSI), a Section -25 Government Company under the National Informatics Centre (NIC). Open tenders were floated by NICSI to empanel the private agencies for the said work. Two agencies were initially empanelled for this work i.e., M/s Synapse Solutions P. Ltd., New Delhi and M/s Alankit Assignments P. Ltd., New Delhi. Later, the contract with M/s Alankit Assignments P. Ltd., New Delhi, was terminated in March, 2010, as the performance of the company was not satisfactory.
