Monday, July 24, 1978/Sravana 2, 1900 (Saka)

#### **OBITUARY REFERENCE**

MR. SPEAKER: I deeply regret to inform the House of the tragic demise of one of our sitting colleague, Shri Parmanand Govindjiwala, representing Khandwa constituency of Madhya Pradesh.

A leading Advocate, Shri Govindjiwala took active part in the merger movement of Hyderabad State with India in 1947. He entered public life in 1960 when he was elected to the Municipal Committee of Burhanpur. Later he was Member of the Madhya Pradesh Vidhan Sabha during 1967-72. He was the Chief Whip of his party in the State Legislature. Interested in Archaeology and History, he used to contribute articles in various magazines and periodicals. He also published a book on the Hindu Marriage Act. He was also a good sportsman.

As a parliamentarian he was quite active. As the House is aware, he met with  $a_n$  accident with a bus on the night of 19th July, 1978 and was admitted to Dr. Ram Manohar Lohia Hospital. In spite of all efforts, his life could not be saved and he passed away last night at the young age of 48. THE PRIME MINISTER (SHRI MORARJI DESAI): It is a very tragic occasion for us when we are meeting today. Shri Parmanand Govindjiwala met with an accident on the 19th July while driving a scooter at night. He met with an accident which was very serious. As a result, he was unconscious throughout and all the attempts of the doctors could not save hig life.

He was in the prime of his life, only 48, and was in public life from his early age of 21. He was an LLB and associated himself in public life with Jan Sangh at the age of 21. As you mentioned Sir, he took a very active part in the Hyderabad merger movement in 1947 and was a very active Member of the Burhanpur Municipality for 8 years, and he was Member of the Madhya Pradesh Vidhan Sabha for five years. He was an active Member of this House and always was loyal to the values he held in life very dear. We have lost a very prominent Member of this House and an active worker in the cause of India, its social and political life.

Sir, it is a tragic loss and we all mourn it very deeply and I would request you, Sir, to convey our deep sense of grief and our condolences to the family of the bereaved, particularly to his widow and his four young children.

SHRI C. M. STEPHEN (Idukki): Sir, I rise with a feeling of grief to associate myself with all other Members in this House with the sentiments expressed by the Prime Minister and yourself.

Sir, this House is a very peculiar lot in the sense that transgressing all

the difference of opinion, when the dust and din of the battle is over, we, the Members in this House, have a feeling to one another as belonging to a family. After the fight when we go out, we meet one another, embrace one another, smile at one another. This is a family. The family represents the family of India. Naturally, therefore, if any member of this family drops out, there is a deep pain and anguish in the heart of everybody. It is with that anguish that I rise.

Mr. Govindjiwala has had a fairly long period of public service. That he associated himself with the merger movement at the tender age of 16 or 17 and that he continued in his public service, shows that he was a man moulded for public service. He started his service in a legislature, not in the Parliament, in his own State Assembly and that for the entire period of five years, he was the Whip of the party to which he belonged, shows how distinguished he was. I had my own nodding acquaintances with him, not very intimate, but nodding acquaintance, with shaking hands. And particularly I am sorry of the circumstance under which this tragic death occurred.

Moments such as these are moment which are described as adhystam vidyala. May I associate myself with the sentiments of condolences and request you to convey to the bereaved family our deep condelences?

SHRI YESHWANTRAO CHAVAN (Satara): Mr. Speaker, Sir, I join you and others in expressing our deep grief on the loss of a very active and a very important young Member of this hon. House, Shri Parmanend Govindyiwala He was on the right side of 50 and, therefore, he was in the prime of his life. He must have been looking to his future life with some hope and confidence; unfortunately that was not to be.

The manner in which the tragic death came about, makes the whole thing still more sad. From his life sketch, he was a Member here for the first time, but he was an active public worker throughout his life. From 1947, he was active in practically every important political event that took place in India. And from other activities, it seems, he was not marely a public worker but a man who was interested in history, in archaeology. He was an author by himself. He was an advocate by profession, a versatile person, a very popular man in his own constituency and area.

The loss of such a person who is a very active member of Parliament is a loss to the nation. The loss to his family is still greater because he leaves behind his four younger children and his widow. I think, the whole nation altares their grief and, to that extent, possibly, it will be lessened. But. certainly, we place on record our grief and I sequest you to convey our deep condolences to his family.

SHRI A. BALA PAJANOR (Pondicherry): Mr. Speaker, Sir, on behalf of the All India ADMK party, we share the feelings of the members of the House. It is a great loss specially when a member of this House has passed away in tragic conditions and that too when we all understand that it could have been averted. I am sure, the family cannot be compensated by our words or other material compensations. But, we hope, that Nature will give strength to the family. We express our deep grief and wish that such things are averted in the future.

With these sentiments, I join in conveying our condolences to the bereaved family. The loss of a member of Parliament is a loss to the nation. I request you to convey our condolences to his family.
