INTRODUCTION

- I, the Chairman, Public Accounts Committee (2010-11), having been authorised by the Committee, do present this Twenty-eighth Report (Fifteenth Lok Sabha) on action taken by the Government on the Observations/Recommendations of the Committee contained in their Ninth Report (Fifteenth Lok Sabha) on 'National Programme for Nutritional Support to Primary Education (Mid-Day Meal Scheme)' based on C&AG Report No. PA 13 of 2008.
- 2. The Ninth Report was presented to Lok Sabha on 11th March, 2010. The Ninth Report was laid in Rajya Sabha a day earlier *i.e.* on 10th March, 2010. Replies of the Government to the Observations/Recommendations contained in the Report were received on 18th November, 2010. The Public Accounts Committee considered and adopted the Twenty-eighth Report at their sitting held on 3rd February, 2011. Minutes of the sitting are given at *Appendix I*.
- 3. For facility of reference and convenience, the Observations and Recommendations of the Committee have been printed in thick type in the body of the Report.
- 4. The Committee place on record their appreciation of the assistance rendered to them in the matter by the Office of the Comptroller and Auditor General of India.
- 5. An analysis of the action taken by the Government on the Observations/ Recommendations contained in the Ninth Report (Fifteenth Lok Sabha) is given at *Appendix II*.

CHAPTER I

REPORT

I. Introductory

This Report of the Committee deals with Action Taken by the Government on the Observations/Recommendations of the Public Accounts Committee contained in their Ninth Report (15th Lok Sabha) on "National Programme for Nutritional Support to Primary Education (Mid-Day Meal Scheme)".

- 2. The Ninth Report of the Public Accounts Committee, which was based on Report No. PA 13 of 2008 (Union Government) of the Comptroller and Auditor General of India and presented to Lok Sabha on 11th March, 2010, contained fourteen Observations/Recommendations. The Action Taken Notes on all the Observations/Recommendations have been received from the Ministry of Human Resource Development (Department of School Education and Literacy) and are broadly categorized as under:
 - Observations/Recommendations, which have been accepted by the Government.
 - Recommendation Paragraph Nos. 1, 2, 3, 4, 5, 7, 9, 10, 11, 12 and 13
 - (ii) Observations/Recommendations, which the Committee do not desire to pursue in view of the replies received from the Government.
 - Recommendation Paragraph Nos. 8 and 14
 - (iii) Observations/Recommendations in respect of which replies of the Government have not been accepted by the Committee and which required reiteration.

- (iv) Observations/Recommendations in respect of which the Government have furnished interim replies:

- 3. The Committee desire that the Ministry of Human Resource Development (Department of School Education and Literacy) should furnish at the earliest final/conclusive Action Taken Note on the Observation/Recommendation to which interim reply has been furnished.
- 4. The Action Taken Notes furnished by the Ministry of Human Resource Development have been reproduced in the relevant Chapters of this Report. In the succeeding paragraphs, the Committee have dealt with action taken by the Government on some of their Observations/Recommendations made in the Original Report, which merit comments.

II. Diversion of Funds and Foodgrains

[Recommendation Paragraph No. 9 of the Ninth Report (15th Lok Sabha)]

- 5. In their Ninth Report, the Committee had noted numerious instances of diversion of funds and foodgrains meant for the Mid-day Meal Scheme in 11 States/UTs *viz*. Kerala, Jharkhand, Uttar Pradesh, Andhra Pradesh, Nagaland, Assam, Andaman and Nicobar Islands, Meghalaya, Bihar, West Bengal and Madhya Pradesh, which present an appalling scenario of lack of proper monitoring on the part of the Ministry of Human Resource Development. Taking a very serious view of such instances which may lead to financial manipulation by vested interest, the Committee had expressed the hope that the Ministry would henceforth take up the matter at appropriate level to initiate suitable remedial measures with a view to avoiding recurrence of such instances. The Committee had also urged upon the Ministry to fix responsibility for diversion of funds and foodgrains at the earliest in a time-bound manner.
- 6. In their Action Taken Note, the Ministry of Human Resource Development (Department of School Education and Literacy) have stated that cases of diversion of funds/foodgrains as pointed out by Audit had been taken up with the concerned State Governments requesting them to initiate appropriate action immediately to recoup the cost of funds and foodgrains so diverted, fix responsibility for such irregularity and furnish final Action Taken Note to that Department.
- 7. An analysis of the Action Taken Note of the Ministry revealed that diversion of funds and foodgrains have been confirmed in six States viz. Kerala, Jharkhand, Uttar Pradesh, Andhra Pradesh, Nagaland and Bihar. In case of Assam, the State Government has been directed to contact the local AG Office to ascertain the diversion and to recoup the cooking cost so diverted by fixing responsibility. The reply of the State Government was still awaited. In case of Andaman and Nicobar Islands Administration, it has been confirmed that no diversion has been done except book adjustments for the smooth functioning of the Scheme. In case of West Bengal, the Ministry intimated that 'from the records it emerges that there is no diversion of funds' as the amount of Rs. 90.00 crore was provided from the State Budget for construction of kitchen sheds and an amount of Rs. 228.07 lakh was sanctioned for Management, Monitoring and Evaluation (MME) purpose by the Government of India. The Government of Meghalaya had informed the Ministry that particular Audit para has been rechecked and after detailed examination it is informed that there has not been any diversion of funds. In their response, Government of Madhya Pradesh had informed the Ministry that utilization of transport grant of Rs. 17.78 lakh for printing of cards, audit fees and stationery was done from the grant provided by the State Government.
- 8. The Committee note that diversion of funds and foodgrains have been confirmed in six State namely Kerala, Jharkhand, Uttar Pradesh, Andhra Pradesh, Nagaland and Bihar. Lapse noticed in the confirmed cases of diversion is indicative of wide spread fiscal indiscipline in implementing the Scheme. The Committee feel that institutional apathy and lack of concerted efforts should not be allowed to creep in implementing such an important Social Welfare Scheme of National Coverage aimed at bringing better primary education through elimination of class room hunger lest it should be reduced to a mere bureaucratic exercise. The Committee deplore the

failure of the above States as well as the administrative Ministry to enforce strict fiscal discipline in the implementation of the Scheme. Though the Ministry have asked the States/UTs concerned to initiate appropriate action to recoup the cost of diverted funds/foodgrains and fix responsibility, no concrete action has been taken as yet for initiating appropriate action in this regard. In these circumstances, the administrative Ministry need to urge the authorities concerned of the States/UTs to be more vigilant and serious in their approach. They should give proper attention and care to its implementation with a sense of dedication to ensure resounding success of this Scheme meant to uplift the children of the disadvantaged sections of the society. The Committee note with deep dismay the diversion of funds and foodgrains and desire that exact reasons of such diversion should be identified in these six States under intimation to the Committee. The Committee would like the Ministry to pursue all such cases to fix responsibility and take appropriate punitive-cum-preventive measures to obviate instances of such nature in future.

III. Provisioning of Cooking Infrastructure

[Recommendation Paragraph No. 10 of the Ninth Report (15th Lok Sabha)]

9. In their Ninth Report, the Committee had expressed surprise over the fact that pucca kitchen-cum-store/kitchen sheds had not yet been provided in all the Mid-Day Meal implementing schools despite allocating an amount of Rs. 5,000 crore for the purpose. Against the Ministry's assurance in February, 2009 that all such schools would be provided cooking infrastructure by the year 2008-09, the Committee had noticed that as many as 2,62,809 schools were yet to be sanctioned kitchen sheds as of December, 2009. Observing that lack or non availability of proper kitchen infrastructure would either render the mid-day meals being cooked in unhygienic conditions or deprive the schools of the limited class room/space available with them, the Committee had recommended that the policy for construction of kitchen-cum-store should be revisited and all efforts should be made for construction of required kitchens without further loss of time.

10. In this regard, the Ministry have stated in their Note the following action taken by them:

"Concern of the Public Accounts Committee is noted for compliance. During the Financial Year 2009-10, Rs. 1044.29 crore was released for construction of 1,03,555 kitchen-cum-stores. For the Financial Year 2010-11 Kitchen-cum-store for 1,70,353 have been approved by the Programme Approval Board. Instead of flat rate of Rs. 60.000 per unit for construction of Kitchen-cum-store, the Government of India has revised the guidelines in November, 2009 and the cost of the Kitchen-cum-store is now determined on the basis of plinth area norm fixed by the Central Government and adopted by the State Government and the Schedule of Rate prevalent in the State. The revised norm is effective from 1.12. 2009."

11. The Committee note that the Ministry of Human Resource Development have taken certain basic measures to remove the huge pendency in the construction of kitchen sheds/kitchen-cum-stores, which are crucial for maintaining quality and hygienic standards of the mid-day meals. Still much effort is yet to be made by the

Ministry and the States/UTs so as to materialize the construction of remaining kitchens/kitchen-cum-stores numbering around 2,62,809. In the opinion of the Committee, providing hygienic mid-day meals still remains an unsurpassed challenge. The Committee feel that the lapses concerning the service delivery of serving hygienic food can be reduced to a great extent by ensuring availability of clean kitchens with the schools. The Committee, therefore, desire that priority must be accorded on providing kitchen infrastructure to all the pending schools possibly within the current financial year *i.e.* 2010-11. The Committee would like the Ministry to make all out efforts in this regard and furnish year wise detailed information on the total amount sanctioned for construction of kitchens/kitchen-cum-stores; amount utilized there against, number of kitchens/kitchen-cum-stores constructed; total number of pendency along with reasons therefor etc. during the last two years.

IV. Adverse Impact on Teaching

[Recommendation Paragraph No. 11 of the Ninth Report (15th Lok Sabha)]

12. The Committee had observed in their Ninth Report that contrary to Scheme guidelines, teachers/teaching staff in most of the States/UTs were actively involved in the implementation of the Mid-Day Meal Scheme such as receipt/collection of foodgrains, procurement of vegetable and condiments supervision of cooking and serving of meals. thereby leading to loss of valuable teaching time. Emphasizing that any spurge in the duties of the teachers other than teaching activities was not only violation of the prescribed guidelines but also an obstruction in learning activities which eventually leads to injustice to the students, the Committee had sought an assurance from the Ministry in unequivocal terms that involvement of teachers in the Scheme is limited only to supervision/cooperation in serving the meals without compromising with their teaching duties/time. The Committee had also suggested for providing additional support mechanism in terms of manpower and related facilities to the schools wherever required.

13. In their Action Taken Note, the Ministry stated their position in this regard as under:

"As per para 4.3 of the Mid-Day Meal (MDM) Guidelines, 2006, teachers are under no circumstances to be assigned such responsibilities that will impede or interfere with teaching-learning process. Teachers are to be involved only in ensuring food quality and wholesomeness or the meal served to children, the actual serving and eating is undertaken in a spirit of togetherness, under hygienic conditions and in an orderly manner during lunch break of 30-40 minutes. This provision has been reiterated by this Department *vide* letter No. 1-10/2009-Desk (MDM) dated 8.10.2009 to States/UTs to ensure that teachers are not at all involved in the process of cooking and its supervision.

Further, a separate provision for payment of lump sum honorarium to cook-cumhelper @ Rs. 1,000 for her part time services has been made under the scheme so that teachers are not involved in the cooking and serving processes. The norms for engagement of cook-cumhelpers have also been prescribed. One cook-cumhelper can be engaged in the school having student strength upto 25. For 26-100 students in a school, 2 cooks-cumhelpers can be engaged and for each additional

100 students, one additional cook-cum-helper can be engaged. This number of cook-cum-helpers will be sufficient for cooking and other related activities in schools and thus enabling teachers to concentrate on teaching process."

14. The Committee are already aware of the Mid-Day Meal Guidelines of 2006 which protects the teachers/teaching staff from assigning such responsibilities that will impede or interfere with teaching/learning process. This has further been strengthened by incorporating a separate provision for engaging cook-cum-helpers which is being given the specialized task for preparing and distributing mid-day meals to desist the teachers from the undesirable distraction. The Committee, however, observe that the mid-day-meal scheme implementing primary schools, most of which have already been facing staff shortage, are still engaging the teachers in such activities as other than the permissible role of ensuring food quality and wholesome meals as well as overseeing proper serving of meals. Thus, it appears that the existing arrangement is not fool proof and needs to be further redefined and crystallized to explore feasibility of evolving and following a system wherein permanent post of cook/cook-cum-helpers etc. are made available separately or synergized with suitable school staff in each school to relieve the extra burden on the teachers. Engagement of cook/cook-cum-helpers, as per norms prescribed, should be incorporated in the Management Information System (MIS) reports generated by the schools to facilitate closer and proper monitoring. Alternatively, options may also be explored for enlisting the services of experienced and dependable caterers in serving the mid-day-meal in specifically suitable areas or locations.

CHAPTER II

OBSERVATIONS/RECOMMENDATIONS WHICH HAVE BEEN ACCEPTED BY GOVERNMENT

Action Taken Note on the Recommendations and Observations contained in the 9th Report of Public Accounts Committee (15th Lok Sabha) on National Programme for Nutritional Support to Primary Education (Mid-Day Meal) Scheme

Observation and Recommendation No. 1

The National Programme for Nutritional Support to Primary Education, commonly known as the Mid-Day Meal Scheme launched as a Centrally-sponsored scheme in August, 1995 was intended to boost universalisation of primary education by increasing enrolment, attendance and retention levels of children and simultaneously impacting on the nutritional levels of primary students across the country. Budget allocation for the scheme has increased from Rs. 1099.03 crores as in 2002-03 to Rs. 8000 crores in 2008-09. In addition to the budgetary support the scheme was also aided by a subsidy of Rs. 6898.29 crore allowed to Food Corporation of India on supply of foodgrains for the scheme during the years 2002-03 to 2006-07. The scheme was revised in 2004 and again in 2006. According to the Department of School Education and Literacy, the Mid-Day Meal Scheme supplements the Sarva Shiksha Abhiyan (SSA), which is a scheme for universalisation of elementary education. The improvements brought about as a result of revised scheme are increase in the calorific value of the food supply to the children (from 300 to 450 calories) and increase in the protein content from 8-12 grams to 12 grams. Although the objectives of the Mid-Day Meal Scheme are laudable and have assisted in moving towards universalization of primary education, yet, certain shortcomings in the implementation of the scheme have come to the notice of the Committee through the examination of the subject which are discussed in the succeeding paragraphs.

Status of Action Taken/Proposed to be taken

Observation and Recommendation No. 2

The Committee regret to observe that the funds allocated for the Mid-Day Meal Scheme were not utilized during the years 2007-08 and 2008-09. Against the budgetary allocations of Rs. 6678.00 crores and Rs. 8000.00 crores in 2007-08 and 2008-09 respectively the actual expenditure during these years was Rs. 4930.77 crores and

Rs. 6982.54 crores. Obviously under utilisation of funds during last two years must have affected various features of the scheme. The Committee would like the Ministry to analyze the reasons for this under utilization of funds and take suitable steps to obviate such a situation in future.

Status of Action Taken/Proposed to be taken

The main reason for low utilization of Central assistance under Mid-Day Meal Scheme is delay in release of funds. At present, funds under the Scheme are released by the Central Government to the Consolidated Fund of the States/UTs. Thereafter, States/UTs transfer it either directly to the Districts or through the Directorate. Levels through which the fund passes from State/UT Governments to the village/school level differ from State/UT to State/UT, but the system of transfer of fund is through the treasury. It has been observed that in several States/UTs, it takes anywhere between 3—6 months for the funds to reach the actual working level *i.e.* school/cooking agencies. This delay affects the implementation of the programme adversely and thus, utilization of Central assistance. This Department has written to Chief Secretaries of all States/ UTs on 12.5.2010 for release of Central assistance released under MDMS without any delay. This matter was also discussed in the Chief Secretaries' Conference held on 1st and 2nd February, 2010 and it was decided that funds released by Central Government under MDMS should reach the schools within one month. On 18.6.2010 all States/UTs have been requested to release the funds to schools as per the decision taken in the Chief Secretaries' Conference. State/UT wise information in respect of compliance is being collected. (Copy of letters dated 18th June, 2010 and 25th November, 2010 are enclosed at (Annexure-I).

Besides the above, it is not possible to utilize the 10% funds earmarked for being utilized in the North Eastern Region (NER) because the number of children in this region is only about 5%. Further, the scheme was extended to upper primary classes in 3479 Educationally Backward Blocks on 1.10.2007 and to all Blocks on 1.4.2008, but some States could not actually extend the coverage from these dates due to local administrative and financial problems. States/UTs have been requested repeatedly to ensure cent per cent coverage of Government, Government aided, Local Body and National Child Labour Project schools and centres of Education Guarantee Scheme and Alternative and Innovative Education Centres including Madarsa and Maqtabs supported under the SSA. Adherence to the regularity, quantity and quality aspects of the MDM is also stressed to the States/UTs at every possible occasion.

The undersigned is directed to refer to Food Corporation of India's letter No. 26/1/2009-10/MDM/Sales-IX/Vol. II dated 9th/10th November, 2010 on the above subject and to say that information about the district wise availability of foodgrains during 2007-08, 2008-09 and 2009-10 with Assam, Arunachal Pradesh, Orissa and Uttarakhand is still awaited. It is therefore, requested that the same may kindly be sent immediately for its onward submission to Committee of Lok Sabha Secretariat (PAC Branch).

Observation and Recommendation No. 3

The Committee note that the guidelines stipulated for the scheme do provide for the operation of voluntary organizations and Non-governmental organizations etc. Considering that such organizations could also play a useful role in operationalising the scheme, however, it is important to emphasize that the programme must neither be perceived as NGO-driven nor get dominated by them. Since Public Private Partnerships (PPPs) are being used in some States for associating Voluntary Organisations/NGOs in the Mid-Day Meal Scheme, the Committee desire that the Ministry should prescribe specific guidelines to govern particularly the PPP framework. Although the State Governments, keeping in view their own circumstances and requirements, do require a degree of flexibility to modify the guidelines but the basic principles underlying the guidelines governing PPPs should not be diluted.

The Committee also desire that the Ministry should develop appropriate criteria to adjudge the suitability of NGOs/private partners for participating in the scheme's implementation. The selected NGOs/private partners should have a strong local and grassroot presence in the States where they operate and should also be fully conversant with local needs and culture. In order to meet the above -mentioned criteria, the Ministry and State Governments should discourage the tendency of outside agencies undertaking such tasks and maintain that Voluntary Organizations/NGOs deliver the required results from the local perspective. The Committee are also of the view that the Ministry should undertake periodic assessments of the performance of such Voluntary Organisations/NGOs in order to satisfy themselves that the scheme is being implemented in the intended spirit complying with the prescribed procedures laid down for the purpose.

In the light of the fact that the Government plays a pre-eminent role in the funding and implementation of the scheme, the Committee would like to emphasize that monetary grants, if required to be provided should be made available only to good, reputed and functional Voluntary Organizations/NGOs which comply with all the directives of the Government and fulfil all the parameters laid down by the Ministry. The Committee also feel that concerted efforts should be made by Ministry to raise the bar for entry of NGOs in the programme and their performance constantly monitored in order to check misuse of public funds that may take place in the guise of Public Private Partnership.

Status of Action Taken/Proposed to be taken

Para 3.6 of the Guidelines of Mid-Day Meal Scheme, 2006 envisage that as far as possible, the responsibility of cooking/supply of Mid-Day Meal should be given to local women's/mother's self help groups, the personnel directly engaged by the VEC/SMDC/PTA/Gram Panchayats/Municipality. In urban areas where there is paucity of space in schools for setting up kitchen, cooking may be undertaken in a centralized kitchen and cooked hot meal may then be transported under hygienic conditions through a reliable transport system to various schools. There may be one or more such nodal kitchen(s) in an urban area, depending on the number of clusters which they serve.

Para 3.9 of the guidelines lays down norms for engaging NGOs for supply of Mid-Day Meal to schools. By and large food is cooked locally in the rural areas

through the Self Help Groups or the cooks-cum-helpers engaged by the school management. In urban areas gradually this task has been entrusted to NGOs having financial and administrative capacity to operate Centralised kitchens.

A revised detailed guideline for engagement of NGOs incorporating the observations contained in para 3 and para 4 of this report has been circulated to States/UTs *vide* this Department's letter No. 1-7/2010-Desk (MDM) dated 8.9.2010 (*Annexure II*).

Subject:— Guidelines for engagement of Voluntary Organisation/Non-Governmental Organizations (NGOs) under Mid-Day Meal Scheme.

Sir/Madam,

As you are aware Para No. 3.6 of the Guidelines of Mid-Day Meal Scheme 2006 envisage that as far as possible the responsibility of cooking/supply of cooked Mid-Day Meal may be assigned to local women's/mother's Self Help Groups, the personnel directly engaged by the VEC/SMDC/PTA/Gram Panchayat/Municipality, Local Youth Club affiliated to the Nehru Yuvak Kendras or Voluntary Organisations.

- 2. Community participation is key to the successful implementation of the Mid-Day Meal Scheme as it ensures effective monitoring at the local level and also generates a sense of ownership of the programme in the community. It is, therefore, desirable that Mid-Day Meal is cooked locally in the school premises either through Self Help Groups or through the personnel engaged by the School Management Committee constituted under the Right of Children to Free and Compulsory Education Act, 2009 or any other equivalent Committee responsible for implementing the scheme.
- 3. However, for urban areas, where there is a space constraint for setting up school kitchens in individual schools, the Guidelines provide that a Centralised Kitchen could be set up for a cluster of schools where cooking can take place and the cooked hot meal may be transported under hygienic conditions through reliable transport systems to various schools. Operation of these Centralized Kitchens may be entrusted to reputed NGOs under the PPP model. It would be advisable to select NGOs with a local presence and familiarity with the needs and culture of the State. As the quality and quantity of meals supplied to a large number of children receiving MDM from Centralized Kitchens depends upon the commitment and ability of the NGOs, it is important that such NGOs are selected carefully and their performance is evaluated regularly.
- 4. The guiding principles laid down in para 3.9.1 of the MDM guidelines must be followed strictly while selecting NGOs for operating Centralised Kitchens. Besides, the following may also be observed to ensure greater accountability from the NGOs:
 - (i) The NGO should have a properly constituted Managing/Governing Body with its powers and duties clearly defined in its constitution.

- (ii) Name of all office bearers involved in the establishment and management of such organizations should be disclosed along with their roles and responsibilities in the organization. If any of the office bearers holds a public office, then details of that office should also be mentioned specifically.
- (iii) A contract/MOU between the NGO and the local authority responsible for engaging the NGOs shall be signed to define the liabilities of the parties and the consequence of non performance on their parts. It should also include a stringent mechanism to check and supervise the quality and quantity of meal supplied by the NGO to the children.
- (iv) The performance of such NGOs engaged in serving MDM to children should be assessed every year through a credible system of evaluation. Renewal of MOU with an NGO for the next year should depend on its performance being found satisfactory in the current year.

To the above extent, para 3.9.1 of the Guidelines 2006 shall stand revised.

5. All States/UTs are requested to issue necessary instructions in the light of the above, endorse a copy of the same to this Ministry for our records and monitor strict compliance of these instructions.

Observation and Recommendation No. 4

The Committee also note that in some cases, public figures/civil servants have associated themselves through the device of the establishment and management of such organizations as NGOs. However, the Committee are constrained to point out that such information in regard to the association of public figures/civil servants with the programme was not furnished to them by the Ministry. It would, therefore, be appropriate if the Ministry devise a mechanism whereby full disclosure exists about the role of such persons in these organizations considering its sensitivity and the issue of utilization of funds for private purpose. They feel that service delivery of the scheme should not become an instrument of benefit for interested persons.

Status of Action Taken/Proposed to be Taken

The above-mentioned revised Guideline incorporates this observation.

Observation and Recommendation No. 5

The Committee's examination has also revealed that the scheme of Central support for providing the foodgrains through Food Corporation of India (FCI) is plagued with several deficiencies. The scheme, *inter alia*, provide for central assistance by way of free supply of food grains through the Food Corporation of India (FCI), as also reimbursement of the cost of transportation from the nearest FCI depot to the concerned primary school. The Committee are surprised to note that the allocation of foodgrains was based on anticipated and not on actual enrolments, prepared district-wise and submitted by the Nodal Department to the States concerned. The Committee are of the view that this approach could lead to a situation where the extent of lifting of foodgrains by the State Governments could be confused with or interpreted as progress in terms of the scheme's objectives. The Committee, therefore, desires that the Ministry and the State Governments should devise such measures, as are based on actual and original numbers to measure genuinely the progress regarding the MDM scheme in terms of student enrolment, attendance, retention and reduction in the drop-outs which were the major objectives of the scheme at the time of its inception.

Status of Action Taken/Proposed to be taken

From the year 2007-08, all the recurring Central assistance including foodgrains is generally being allocated on the basis of approval accorded by the Project Approval Board (PAB) keeping in view the actual performance in terms of number of children, who availed mid-day meal and number of school days on which meal was served during the previous year. However, States/UTs are being advised to serve mid-day meal to all children attending eligible school on all school days irrespective of the approved numbers of students and working days. In case, the actual number of children availing mid-day meal and/or the working days are more than the number approved by the PAB requiring allocation of additional funds and foodgrains, then the States/UTs may approach the GOI with evidence for the same. The progress of the Scheme is monitored through the Quarterly Progress Report which has information on actual enrolment as well as the number of children approved by the PAB, opted for MDM and actually availed the MDM. A copy of the format of QPR is enclosed at Annexure III.

Observation and Recommendation No. 7

The Committee note that seven States *viz*. Tripura, UP, Kerala, Manipur, Meghalaya, Haryana and Rajasthan drew foodgrains in excess of their requirements. This depicts faulty assessment on their part and tardy monitoring mechanism in place for the purpose. The Ministry have conceded that the allocation of foodgrains was based earlier on anticipated enrolment and average attendance rate. However, from 2007-2008 onwards, the central assistance to the States is being provided on the basis of the number of children actually availing Mid-Day Meals. The Committee hope that the Ministry and FCI would take appropriate measures with the implementing authorities in various States so that foodgrains is lifted on realistic assessments. The Committee feel that the reported cases of overdrawal of foodgrains as also the stock out situations mentioned above should invariably form an integral part of the agenda during the monitoring/review meetings of the Ministry.

Status of Action Taken/Proposed to be Taken

In order to ensure that no excess foodgrain is available with States/UTs over and above the requirement, the annual allocation is made after adjusting the unspent balance of foodgrains available with the States/UTs at the end of the previous year.

During the National as well as Regional Review meetings or while analyzing the Quarterly Progress Report, the performance is scrutinized with reference to the actual number of children who availed MDM and actual number of working days on which MDM was served. If there is any mismatch in the utilization of foodgrains and funds in the light of reported number of children and working days on which MDM was served during the quarter, the same is brought to the notice of the States/UTs for remedial action. Funds are released in three instalments. Decrease/increase in the number of children/working days is taken into consideration while releasing the last instalment of central assistance.

Observation and Recommendation No. 9

Another area of concern has been the reported instances of diversion of funds and foodgrains meant for the Mid Day Meal programme in 11 States which present an appalling scenario whereby the very purpose of establishing this scheme remains defeated. It clearly indicates lack of proper monitoring on the part of the Ministry. The Committee take a very serious view of such instances whatever be the reasons thereof. The Committee are of the view that such instances may lead to financial manipulation by vested interests. The Ministry should have initiated suitable remedial measures to check such repeated instances. That this was not done is regretted. The Committee hope that Ministry would now take this matter with the States at appropriate level so that such instances do not take place. The Committee regret to point out that the Ministry have not responded to their specific query in regard to fixation of accountability in respect of diversion of funds and foodgrains. They, therefore, urge that the States should be persuaded to fix responsibility for such irregularities at the earliest in a time-bound manner.

Status of Action Taken/Proposed to be Taken

Cases of diversion of foodgrains/funds as pointed out by Audit had been taken up with the concerned State Governments requesting them to initiate appropriate action immediately to recoup the cost of foodgrains and funds so diverted, fix responsibility for such irregularity and send final Action Taken Note (ATN) to this Department. Details of Action Taken as per the information received from the States/ UTs are as under:—

- (i) Government of Kerala has informed that State is giving 60 grams of rice and 30 grams of pulses instead of 100 grams of rice. The calorie of the stuff given by the State Government is almost equal since it contains more proteins. The rice saved was used to provide MDM to the pupils in the Upper Primary section. As may be appreciated, it is difficult to allow some children to go without food and starve while others under the same roof are given food. The Government of India identified this requirement and extended the programme to the whole elementary section. The Government of Kerala was more proactive and it can't be termed as diversion. The extension of the scheme upto 8th standard by the Government of India vindicates the action of the State Government. The Government has taken measure to increase the per capita rice allotment from the financial year 2006-07 onwards while providing pulses and hence it will be sticking to the scheme in letter and spirit. The reply of the State Government is not acceptable as it is against MDM guidelines. State Government has been requested to take appropriate action immediately to recoup the cost of foodgrains diverted for feeding the upper primary classes, fix responsibility for such irregularity in a time bound manner and send Action Taken Note to this Department immediately.
- (ii) Government of Jharkhand has informed that they are not aware of any such diversion. However, instructions are being issued to stop such practices. State Government has been requested to obtain the facts of diversion from the office of the Principal Auditor General, Ranchi, Jharkhand and take appropriate action against the officials involved in this. The State Government has been further directed on 28.07.2010 to recoup the cost of foodgrains diverted to TDPS immediately, fix responsibility for such irregularity at the earliest in a time bound manner.
- (iii) Government of Uttar Pradesh has informed that in respect of diversion of 440 MTs of foodgrains lifted from the FCI godown of Bulandsahar, it has been decided to initiate regular departmental proceedings against the then District Magistrate and to suspend her during the pendency of the proceedings. Since the officer is presently on deputation to Government of India, the matter has been referred to GOI for appropriate action under Rule 3(1)(B) of AIS(Discipline and Appeal), 1969. Another officer involved in this diversion was the District Basic Education Officer, who was suspended but under the order of the High Court, he has been reinstated. On the conclusion of the Departmental proceedings, the State Government is consulting the State Public Service Commission on the quantum of punishment.

- (iv) Government of Andhra Pradesh has stated that in Warangal and Nalgonda districts, since the cooking of Mid-Day Meal was taken up in the Open arena due to non-availability of kitchen sheds which caused ill-health to pupil of Primary and Upper Primary schools. The construction of kitchen sheds had to be taken up on war footing for hygienic preparation of mid day meals, hence, the diversion of funds could not be avoided as the funds were not available for this purpose. The State Government has been requested to recoup the cooking cost immediately, fix responsibility for such irregularity at the earliest in a time bound manner and send Action Taken Note to this Department immediately. In response to this, State Government has informed that action will be initiated against the persons responsible and the diverted funds for construction for kitchen-cum-store will be recouped after receipt of funds and revalidation from Finance Department under kitchen-cum-store.
- (v) Government of Nagaland has informed that the State Government took a conscious decision to convert the foodgrains received under Mid-Day Meal Scheme during 2000-2001 to 2004-2005 into cash due to the following compelling reasons:—
 - (i) Socio-culturally, the concept of mid-day meal is alien to the community. The first meal of the day (lunch) is taken early in the morning and therefore, children go to school after having had their meal.
 - (ii) Instances of malnutrition in the State are rare and when the MDM Scheme was launched there was no corresponding nutrition programme for school-going children in the State, which could have provided the support for the implementation. The Scheme consisted of free foodgrains and transportation cost to be availed under JRY programme of DRDAs. The Mid-Day Meal Scheme was thus introduced in August, 1995 having sensitized the beneficiaries and implementing agencies to its objectives, without logistics having been worked out, without funds to meet the cooking cost *viz.* supplementary food items, fuel, utensils, cooking arrangement.
 - (iii) There was no well established PDS system in place and most villages did not have fair price shop.
 - (iv) Due to the variety of constraints and particularly logistic difficulties, as many schools are located in far-flung, remote areas where there are no public carriers, there was doubt that the foodgrains could be effectively delivered to the schools.

The amount received as proceeds of sale was Rs. 879.86 lakhs and not Rs. 686.86 lakhs. This amount was deposited into the account of the Directorate of School Education and disbursed through the Deputy Inspector of Schools (DIS) to the Village Education Committees (VECs) for serving of Mid-Day Meal to the children during this period from the locally available nutritious food items. In this regard, detailed guidelines were issued.

- State Government has further informed that conversion of foodgrains to cash has since been totally stopped and hot cooked meals are now being provided to the children. This has been made possible with the provision of cooking cost from the year 2004-05.
- (vi) Government of Assam has informed that there are no reports from any district in the State that cooking cost had been diverted for purchase of utensils and LPG. State Government has been directed to contact the local AG office to ascertain the diversion to recoup the cooking cost so diverted immediately, fix responsibility for such irregularity in time-bound manner and take appropriate action against the erring officials. The reply from the State is awaited.
- (vii) A&N Islands Administration has reported that the allocation order for foodgrain under the Mid Day Meal Scheme is issued by the Education Department directly to the FCI, Port Blair and copy endorsed to Department of Civil Supply and Consumer Affairs requesting to lift the allocated quantity of MDM rice from FCI Godowns located in Port Blair. Department of Education is not furnishing PDS wise bifurcation list to the FCI or Department of Civil Supply & Consumer Affairs. The MDM rice lifted from the FCI Godowns is utilized by the Civil Supply & Consumer Affairs Department at Port Blair Head Quarter Area. In other areas of the island, rice is released through the PDS quota of Civil Supply & Consumer Affairs Department. For the purpose of proper accounting rice supplied to MDM Scheme through PDS is later adjusted in ledger books as transfer from MDM to PDS. Actually, there is no diversion of foodgrains meant for MDM Scheme to Public Distribution System. The UT Administration has confirmed that no diversion has been done and this is only book adjustments for the smooth functioning of the scheme in all parts of the Islands.
- (viii) Government of Meghalaya has informed that this particular audit para has been rechecked with the concerned Deputy Inspector of Schools, West Garo Hills, Tura. After detailed examination, it was informed that there has not been any diversion of fund from the Mid-Day Meal Scheme. State Government has been requested to take appropriate action against erring officials, fix responsibility for such irregularity in time-bound manner and send the Action Taken Note to this Department immediately.
 - (ix) Government of Bihar has intimated that 667.8 quintals of wheat were diverted in five blocks of Buxar District during 2003-04 for flood relief work, out of which 119 quintal of wheat has been recouped. District Magistrate, Buxar on 14.12.2009 has given orders to Bihar State Food and Civil Supplies Limited, Bhojpur for recoupment of equivalent to 548.88 Qtls. of wheat. The State Government has been requested to fix responsibility for such irregularity at the earliest in a time bound manner and send Action Taken Note to this Department immediately.
 - (x) Government of West Bengal has informed that there was a single head for different items under MDM Scheme including cooking cost, kitchen devices

& MME. The fund was actually placed under the same head separately for cooking cost, kitchen shed, kitchen devices & MME but kept in same head. From the records it emerges that there is no diversion of fund. The amount of Rs. 90.00 crore was provided from the State Budget for construction of Kitchen sheds and the total fund was released to the districts for the same purpose. Similarly, an amount of Rs. 228.07 lakh was sanctioned for MME purpose from the office of GoI. This also has the approval of Finance Department, Rs. 1.55 crore was spent for purchase of utensils for Mid-Day Meal Programme, this amount was released from Sarva Shiksha Abhiyan, West Bengal.

(xi) Government of Madhya Pradesh has informed that utilization of transport grant of Rs. 17.78 lakhs for printing of cards, audit fees and stationary (Chhinndwada Rs. 2.82 lakhs, Sagar Rs. 9.47 lakhs and Panna Rs. 5.49 lakhs) has been done from the grant provided by the State Government, wherein a provision of service charge of Rs. 1.00 per quintal was made at Zila Panchayat level for such expenditure.

Observation and Recommendation No. 10

The Committee are surprised to find that the most vital infrastructure requirement for implementation of the cooked Mid-Day Meal Scheme i.e., pucca kitchen-cumstore/kitchen sheds has not yet been provided in all the schools which avail of this scheme notwithstanding the fact that an amount of Rs. 5000 crore has been allocated for this and other related purposes. The Ministry had informed the Committee in February, 2009 that based on the central assistance all the schools would be provided cooking infrastructure by the year 2008-09. They have now stated (17th December, 2009) that 2,62,809 schools are yet to be sanctioned kitchen sheds. They have also stated that it was proposed to provide these schools with kitchen sheds during the remaining period of 11th Five Year Plan. It is matter of concern that even according to the Ministry, it would take at least three years to provide kitchen infrastructure to more than two and half lakhs of schools. Obviously due to lack of infrastructure for cooking food the meals may have to be provided by outside agencies or it will be cooked in unhygienic conditions or by using space provided for class rooms. To remedy such a situation, the Committee recommend that the policy for construction of kitchen-cumstore should be revisited and all out efforts should be made for construction of required kitchens without further loss of time.

Status of Action Taken/Proposed to be Taken

Concern of the PAC is noted for compliance. During the Financial Year 2009-10, Rs. 1044.29 cr. was released for construction of 1,03,555 kitchen-cum-stores. For the FY 2010-11 kitchen-cum-store for 1,70,353 have been approved by the PAB. Instead of a flat rate of Rs. 60,000 per unit for construction of kitchen-cum-store, the Government of India has revised the guidelines in November, 2009 and the cost of the kitchen-cum-store is now determined on the basis of plinth area norm fixed by the Central Government and adopted by the State Government and the Schedule of Rate prevalent in the State. The revised norm is effective from 1.12.2009. As per Right of children to Free and Compulsory Education Act, 2009 all schools must have kitchen-cum-store by 2013. However, this would only be possible if requisite funds are made available to this Ministry. The status of construction of Kitchen-cum-store upto 2009-10 is at *Annexure IX*.

Observation and Recommendation No.11

Another related area which requires intervention of the Committee is the fact that contrary to the existing guidelines prescribed by the Ministry that teachers should not be assigned responsibilities which would interfere with the teaching and learning activities, it was found that in most States teachers were actively involved in the implementation of the scheme such as receipt of foodgrains, procurement of vegetables and condiments, supervision of cooking and serving of meals thereby leading to a loss of valuable teaching time. The Committee are of the view that any splurge in the duties of the teachers other than teaching activities is not only violation of the prescribed guidelines but also an obstruction in learning eventually leads to injustice to the students. The Committee therefore, would like to have an assurance from the Ministry in unequivocal terms that involvement of teachers in the scheme is limited only to supervision/cooperation in serving of the meals without compromising with their teaching duties and alternatively additional support mechanism in terms of manpower and related facilities should be provided to the schools wherever required.

Status of Action Taken/Proposed to be Taken

As per para 4.3 of the MDM Guidelines, 2006, teachers are under no circumstances to be assigned such responsibilities that will impede or interfere with teaching-learning process. Teachers are to be involved only in ensuring food quality and wholesomeness or the meal seved to children, the actual serving and eating is undertaken in a spirit of togetherness, under hygienic conditions and in an orderly manner during lunch break of 30-40 minuties. This provision has been reiterated by this Department *vide* letter No. 1-10/2009-Desk (MDM) dated 8.10.2009 to States/UTs to ensure that teachers are not at all involved in the process of cooking and its supervision.

Further, a separate provision for payment of lumpsum honorarium to cook-cumhelper @ Rs. 1,000 for her part time services has been made under the scheme so that teachers are not involved in the cooking and serving processes. The norms for engagement of cook-cum-helpers have also been prescribed. One cook-cum-helper can be engaged in the school having student strength upto 25. For 26-100 students in a school, 2 cooks-cum-helpers can be engaged and for each additional 100 students, one additional cook-cum-helper can be engaged. This number of cooks-cum-helpers will be sufficient for cooking and other related activities in schools and thus enabling teachers to concentrate on teaching process.

Observation and Recommendation No. 12

The Committee note with satisfaction that Steering-cum-Monitoring Committees (SMCs) have been constituted in all the States/UTs which would enable an effective monitoring and evaluation of the scheme. However, they would still like to know from the Ministry whether SMCs have been set up at all the four levels. *i.e.* National, State, District and Block and have been performing their functions of guiding, monitoring,

coordinating and taking action on reports of independent monitoring agencies. Although the SMCs in States/UTs have been constituted, yet their meetings are not being held regularly. It appears to the Committee that the Government is reluctant to mobilize these SMCs to meet regularly and sumbit their minutes to the Ministry. The Committee feel that Ministry should have taken pro active action *suo-moto* to ensure that meetings of SMCs are held regularly and the findings sent to the Ministry. The Committee would like to be intimated about the concrete steps taken by the Ministry in this regard.

Status of Action Taken/Proposed to be Taken

As per para 3.2 of the Guidelines of the Mid-Day Meal Scheme, 2006 provides that States/UTs are required to set up Steering-cum-Monitoring Committees. (SMCs) at that State, District and Block levels to oversee the implementation of Mid-Day Meal Scheme.

Vide letter No. 1-8/2010-Desk (MDM) dated 30.8.2010 all States/UTs have been reminded to hold the meetings of SMCs at all levels at regular intervals (*Annexure X*). It is also provided in the circular that the meeting of the District level SMC will be held every month in which the review of the SMC meetings held at the Block level would be done in addition to the normal functions of the SMC. Similarly, State level SMC would review the functioning of the District level SMC. The holding of State level SMC meeting is monitored through the Quarterly Progress Reports of the States/UTs.

This Ministry is developing a web enabled Management Information System (MIS) with integration of Interactive Voice Response System (IVRS) for monitoring of MDM Scheme on real time basis. This will help in monitoring of various parameters of Mid-Day Meal Scheme including meetings of SMCs at all levels. The target to complete this system is December, 2011.

Subject: Setting up of Steering cum Monitoring Committees at the State, District and Block level to oversee the implementation of Mid-Day Meal Scheme.

Sir/Madam,

As you are aware, Para 3.2 of the guidelines of the Mid-Day Meal Scheme, 2006 stipulates that States/UTs would set up Steering-cum-Monitoring Committee (SMC) at the State, District, City and Block level to oversee the implementation of Mid-Day Meal Scheme. A suggested composition of the SMC at various level is also given in the Annexurer of the guidelines. The function of these SMC is to:—

- (a) Guide the various implementation agencies;
- (b) Monitor programme implementation, assess its impact and take corrective steps;
- (c) Take action on reports of independent monitoring/evaluation agencies;
- (d) Effect coordination and convergence among concerned departments/perfiment agencies *e.g.* FCI and schemes; and
- (e) Mobilize community support and promoting public/private for the programme..
- 2. It has been noticed that although State level SMC has been set up in most of the States/UTs their meetings are not being held as regularly as desired. Further SMCs at District City and Block level are either not set up on their meetings are not being held regularly. You would appreciate that effective functioning of Block, City and District level SMCs is essential for successful implementation of the MDM Scheme. Such observation has also been made by the Public Accounts Committee (PAC) of 15th Lok Sabha in its 9th Report on Mid-Day Meal Scheme.
- 3. All States/UTs are therefore requested to take following action regarding monitoring of Mid-Day Meal Scheme:—
 - (a) Steering-cum-Monitoring Committee shall be set up if not done already, at the State District, City and Block level.
 - (b) Meeting of SMC at Block and City level shall be held every month in the first week of the month to monitor the implementation of the scheme in the previous

- month and arrangements for properly implementing the scheme in every school of that particular block particularly the availability of foodgrains and funds.
- (c) Meeting of SMC at District level shall be held every month in which the region of the SMCs meetings held at Block level would be done in addition to the normal functions of SMC. This meeting may be held on the same date along with the meeting held every month for monitoring the lifting of foodgrains from the FCI godwons and payment made to them.
- (d) Meeting of SMC at State level shall be held in atleast every six months in which the review of the SMCs meetings held at District level would be done in addition to the normal functions of SMC.
- 5. All States/UTs are requested to issue necessary instructions in the light of the above, endorse a copy of the same to this Ministry for our records and monitor strict compliance of these instructions.

Observation and Recommendation (No. 13)

Although the Scheme has now been in operation since 1995, yet no specific assessment has been conducted by the Ministry to find out the extent to which the original objectives of the scheme such as improving enrolment, attendance and retention have been achieved. The Committee do not approve of the common monitoring institution that has been entrusted with the responsibility of monitoring both the schemes *i.e.*, SSA and Mid-Day Meal Programme. The improvements in educational outcomes, health and nutrition must be assessed and measured with reference to the stated objectives of the scheme. The Committee are of the view that the Ministry and State Governments should conduct an impact assessment of the scheme in order to ensure that its implementation was resulting in the desired outcomes.

Status of Action Taken/Proposed to be Taken

In December, 2005, the Ministry entrusted the task of evaluation of the Mid-Day Meal Scheme to the Programme Evaluation Organisation (PEO) of the Planning Commission. The Terms of Reference of the evaluation *inter alia* included assessment of the impact of the Scheme on enrolment, attendance, retention and nutritional status of the children at the primary level. The Planning Commission has submitted the report to this Ministry in the 1st week of June, 2010. This Ministry has shared the report with the States/UTs and requested them to examine the observations and initiate necessary remedial actions to improve the quality of implementation of MDM Scheme *Annexure XI*.

The Ministry is pursuing the matter with State/UT Governments to submit the Action Taken Note on the reports of the independent agencies.

CHAPTER III

OBSERVATIONS/RECOMMENDATIONS WHICH THE COMMITTEE DO NOT DESIRE TO PURSUE IN VIEW OF THE REPLIES RECEIVED FROM THE GOVERNMENT

Observation and Recommendation No. 8

The Committee have been given to understand that the two schemes *viz.*, Sarva Shiksha Abhiyan and Mid-Day Meal have been dovetailed by the Government and no separate mission has been created for the MDM programme as it was seen as a programme that would serve the purpose of SSA by addressing class-room hunger. In the opinion of the Committee as both the schemes are supplementary to each other, it would be difficult for the Government to measure the achievements of the MDM scheme which were anticipated at its inception apart from satisfying class-room hunger. The Committee desire that a mechanism ought to be worked out by the Ministry which would enable them to assess the impact of Mid-Day Meal Scheme independent of SSA.

Status of Action Taken/Proposed to be Taken

It may not be practicable and feasible to assess the impact of Mid-Day Meal independent of SSA on educational parameters because:—

- Mid-Day Meal and SSA are being implemented simultaneously and universally in schools.
- (ii) SSA has several interventions which directly affect the enrolment, attendance, retention, academic attainment of children in schools. MDM is one material intervention amongst several interventions of SSA.
- (iii) Educational attainments also depend substantially on the economic status of the parents, general health of children and the surrounding environment.

However, the education related parameters *viz.* enrolment, attendance, retention, academic attainment etc. are monitored under the SSA regularly. The Planning Commission has evaluated the Scheme and the highlights of the Report is at *Annexure-VII.* The suggestions have been noted for reference of the working group of the Planning Commission for the 12th Plan Period.

Highlights of Evaluation Study of Mid-Day Meal Scheme conducted by Planning Commission.

- The Cooked Mid-Day Meal Program has been successful in addressing classroom hunger in sample schools.
- Cooked Mid-Day Meal is reported to have created a platform for children of all social and economic backgrounds to take meals together, thereby facilitating achieving the objective of social equity.
- It has also been observed that the programme has resulted in the diversion of the attention of teachers and students on activities related to it, rather than towards teaching and learning activities, which results in loss of studies.
- In general, visible shortage of basic infrastructural facilities and manpower (that are crucial for the success of the Cooked Mid-Day Meal programme) were noted.
- Most of the States, it was observed, did not follow the guidelines of Government of India to deliver foodgrains at the school point by PDS dealer, thereby resulting in the leakage of foodgrain. There have been instances where due to long supply chain, foodgrain supplied got adulterated and pilfered.
- While Cooked Mid-Day Meal Scheme seems to have contributed to an increase in the attendance in schools across the country, it does not seem to have any significant impact on fresh enrolments in sample schools.

Observation and Recommendation No. 14

The Committee notes that there was a qualitative shift in the focus of the scheme in September, 2006 from education (with its emphasis on enrolment, learning levels and attendance) to nutrition and health. The Committee are constrained to note that although one of the main objectives of the revised scheme in September, 2006 was to positively impact the nutritional and health levels of primary schools children, the Ministry had not collected data on the nutritional status of children covered under the Mid-Day Meal Scheme. Further, it is disconcerting to note that there were no linkages with the Ministry of Health and Family Welfare for the health checks prescribed under the scheme. The Committee, therefore, recommend that Ministry should ascertain the impact of the nutritional and health levels of primary school children and adhere to this revised objective.

Status of Action Taken/Proposed to be Taken

Various programmes of the Ministry of Health & Family Welfare (MHFW) and Ministry of Women and Child Development, general economic development and income level of parents besides MDM, contribute towards the nutritional status of a child. Mid-Day Meal is only one out of the four meals that a student takes. Therefore, it will not be possible to assess the impact of Mid Day Meal on the nutritional level of

children. Moreover, the measurement of nutritional level is in the domain of the MHFW. National Family Heatlh Survey (NFHS) conducted by the MHFW, to capture the nutritional status of people of the country does not included children of age group 6-14. On the request of the Ministry of the Human Resource Development (MHRD), the MHFW is actively considering inclusion of this crucial age group in the next NFHS. MHFW has further informed that data on nutrition (height, weight, anaemia etc.) through the NFHS are collected on the interval of 5-7 years. Therefore, a decision has been taken to have nutrition data for the population of age one month and above in 284 districts of Uttar Pradesh, Bihar, Jharkhand, Uttarakhand, Madhya Pradesh, Chhattisgarh, Rajasthan, Orissa and Assam through a separate survey now. At present, all States/UTs are implementing School health Programme under the National Rural Health Mission (NHRM). Under the School Health Programme, regular health check ups are envisaged for identifying the health related deficiencies in school children and providing necessary medical care including supply of micro nutrients, iron and folic acid, Vitamin A and deworming tablets etc.

Under the National Rural Health Mission (NRHM), Ministry of Health & Family Welfare is expected to carry out regular School Health Programme in all States/UTs and monitor the nutritional status of children. This Ministry is working in close coordination with Ministry of Health & Family Welfare to achieve this objective. A copy of the D.O. letter from Joint Secretary (EE-I, Department of School Education & Literacy on School Health Programme of all the States/UT Governments is enclosed at *Annexure XII*.

As mentioned in my last letter, in our country where 37.2% people live below the poverty line and almost 55% suffer from acute deprivation, comparable to the people living in sub-Saharan Africa, provision of Mid-Day Meal to school children is doing *God's own work*. All of us are privileged to be involved in this noble, God's very own mission! You all are doing a great job; please make sure our school kids get full benefit under the scheme and public funds earmarked for the same are optimally utilised. A little effort on your part will benefit millions of our children.

Let me draw your kind attention to another important but largely overlooked component of the Mid-Day Meal scheme. The scheme envisages appropriate interventions relating to micro nutrients supplementation and de-worming through administration of (i) six monthly doses of de-worming and Vitamin-A supplementation, (ii) weekly Iron and Folic Acid supplement. Zinc, provision of ORS where required; and (iii) other appropriate supplementation to children studying in elementary classes depending on common deficiencies found in the local areas MDM guidelines also stipulate that only iodized/double fortified (Iron and Iodine) salt should be used for cooking.

Why, you may ask should we involve ourselves with this? Consider this the consequences of micronutrient malnutrition are unacceptably high morbidity and mortality. Vitamin-A, Iron and Zinc deficiency when combined constitute the second largest risk factor in the global burden of diseases; 330,000 child deaths are precipitated every year in India due to Vitamin-A deficiency; 22,000 people mainly pregnant women, die every year in India from severe anaemia; 6.6 million children are born mentally impaired every year in India due to iodine deficiency; intellectual capacity is reduced by 15% across India due to iodine deficiency; and 200.000 babies are born every year with neural tube defects in India due to folic acid deficiency. In addition children suffer from many avoidable ailments, which affect their capacity to excel in studies.

A recent report of the MOH&FW Government of India shows that some States have already initiated a school health programme, Gujarat is one of the States

which has a very active school health programme, as can be seen from the figures below:

Their major new initiatives have been Computerization of School Health Programme; distribution of Vitamin 'A' Tablets; mass de-worming and IFA distribution to Primary-School children under direct observation of the teacher.

Some of their major strategies have been: State level Steering Committee. under the chairmanship of the Health Minister for taking important policy decisions regarding the School Health Programme; Meeting of all stakeholders; Micro planning at PHC level; State level master plan; involvement of private doctors on holidays; preparation of training module and teachers training for health check up and computerization of school health registers and information available at the school level.

Dental problems; skin diseases like scabies and ear infections were related to bad hygiene generally, which needed to be taught to the children as part of their education Similary, issues of anaemia have to be dealt with through IFA tablets, de-worming as well as promotion of green vegetables. Simple washing hands regularly could save many cases of diarrhoea, which kills many children! The adolescent girls who were given IFA tablets reported more zest for life as well as better educational outcomes.

Five percent of the children had refractive errors because of which some of them had to give up their studies! In most cases their studies were compromised. A unique way was found to involve school lady science teachers wearing spectacles, after proper training to identify children who had refractive errors. They were subsequently prescribed spectacles by the ophthalmic assistant at public cost through the school health programme. 140040 children were provided with spectacles in this manner.

Unfortunately, despite the above known benefits of the programme: it is not receiving due attention of many State Governments. I hope that in view of the very adverse consequences of this neglect, and the huge untapped potential of benefiting our students, this programme would be taken more vigorously, henceforth, in collaboration with the National Rural Health Mission.

In view of the above, I shall appreciate if you could take take up with your State Health Department and ensure that the school health programme is carried out in the right spirit and all students that need health care are provided with the same. Along with the personnel of the Health Department, we could also rope in the Lions and Rotary clubs, as well as Indian Medical Association for ensuring that proper school check up is carried out.

In addition to treatment, the schools should also ensure that children learn good hygienic practices of daily bath, keeping themselves clean (may be the school could provide a bar of soap on a regular basis), cleaning teeth, cutting nails, eating green vegetables and using iodized salt. Wherever, these programmes have been implemented effectively, there has been a direct effect on student's performance. In Gujarat, the School Health Programme has now been scaled up into a "School Health Week". It's a unique idea of providing not only health examination to children but counselling, health education, cleaning of water sources in village, nutrition day activities, and tree plantation etc.

This is something worth emulating; the brochure on the school health programme can be seen at http://mohfw.nic.in/School%20Health%20Programme.pdf. If you do feel the need we could also organise a one day workshop in Ahmedabad to orient you on the Gujarat School Health programme.

Action taken in this regard may please be intimated to the undersigned. Please do not hesitate to write if there is anything, which we can do at this end to facilitate this task. A little effort on your part will make sure that our school children enjoy better health and perform better on expected educational outcomes.

CHAPTER V

OBSERVATIONS/RECOMMENDATIONS IN RESPECT OF WHICH GOVERNMENT HAVE FURNISHED INTERIM REPLIES

Observation and Recommendation (No. 6)

In this connection, the Audit has also brought out some instances of stock out with FCI godowns and also cases of drawal of foodgrains in excess of requirements. At the instance of the Committee, the Ministry have simply forwarded a tabulated data submitted by FCI indicating the closing balance of stocks in seven States which did not contain any data regarding foodgrains received against the specific requirements made. The Committee are surprised that the Ministry seem to be satisfied with the reply of the FCI in regard to the stock out situation in FCI godowns. According to them, mere furnishing of tabulated data indicating monthly closing balance of stocks can not be a parameter which can substantiate that FCI had sufficient stock at all times to cater to the requirements of the schools in serving the Mid-Day Meals in an uninterrupted manner. The Committee, therefore, desire that the Ministry should obtain district-wise details from FCI where the food shortages were noticed during the last three years so that corrective measures could be taken and shortcomings removed. In their opinion, it is imperative that the Ministry should continuously monitor the supply of the foodgrains and also give clear cut instructions to the States for maintaining buffer stock in the areas/districts having rough terrain and inclement weather like in Uttarakhand and other hilly States. The Committee also recommend that the Ministry should explore the feasibility of buying foodgrains locally when conditions like stock outs are noticed.

Status of Action Taken/Proposed to be taken

Food Corporation of India has been requested to give the information on district and month-wise availability of foodgrains in 2007-08, 2008-09 and 2009-10 in respect of 7 States namely Jharkhand, Uttarakhand, Assam, Kerala, Arunachal Pradesh, Orissa and Bihar, where C&AG has reported non-lifting of foodgrains due to shortage of foodgrains with the FCI. The reply received in respect of Kerala, Jharkhand and Bihar is enclosed at *Annexure-IV*. The reply from FCI in respect of Assam, Arunachal Pradesh, Uttarakhand and Orissa is still awaited.

The payment of cost of foodgrains has been decentralized at district levels from 1.4.2010 for smooth supply of foodgrains to schools/implementing agencies. A detailed guideline on supply of foodgrains under Mid-Day Meal Scheme has been issued by this Department *vide* letter No. 1-15/2009-Desk(MDM) dated 10th February, 2010 (*Annexure-V*).

According to the guidelines, the foodgrain is to be allocated to the States/UTs well in advance. The guideline clearly provides that the District Nodal Officer will intimate the schedule of lifting as per their local needs to the FCI and FCI will ensure

continuous availability of adequate quantity of good quality of foodgrains which will be in any case not less than Fair Average Quality (FAQ), in its Deposts. Districts have been given the option to lift foodgrains on monthly/bimonthly/quarterly basis depending on the local needs/conditions. FCI is required to appoint a Nodal Officer for each State to take care of various problems in supply of foodgrains under the scheme. The guidelines also stipulate *inter alia* monthly monitoring of lifting, payment of FCI and availability of stock at FCI godown at the District and State/UT levels. States/UTs are required to ensure that every consuming unit maintains a buffer stock of foodgrains required for a month to avoid disruption due to unforeseen exigencies. Relevant extracts of MDM guidelines is enclosed at *Annexure-VI*.

The Budget provision for the MDM Scheme does not permit purchase of foodgrains from open markets at rates higher than the BPL rates. However, this suggestion has been noted for reference to the working group of the Planning Commission for the 12th Plan period for finalizing the outlay of the Scheme in due course.

Subject: Guidelines for decentralisation of payment of cost of foodgrains to FCI at District level under Mid Day Meal Scheme.

Sir/Madam,

Under the National Programme of Mid Day Meal in Schools, free foodgrains are supplied to Districts @ 100 gms. and @ 150 gms. per child per day for children studying in schools at primary (class I to V) stage and Upper Primary (class VI-VIII) stage respectively Local Depots of the Food Corporation of India (FCI) supply the foodgrains and centralized payment of the cost of foodgrains is made to the FCI by the Government of India without obtaining confirmation of lifting from the States/UTs as the confirmation process was taking a lot of time and causing undue hardship to the FCI. Centralized payment without confirmation is prone to delay and risk.

Now, the Government of India has decided to decentralize the payment of cost of foodgrains under the Mid Day Meal Scheme to the district level from the next financial year i.e. 2010-11 with effect from 1.4.2010. The procedure to be followed for supply of foodgrains by FCI and payment to be made to FCI towards cost of foodgrains supplied under the scheme is as under:—

2. Allocation of Foodgrains

- 2.1 Under the scheme, the foodgrains will be allocated biannually by the Department of School Education and Literacy with the concurrence of Department of Food and Public Distribution separately for Primary and Upper Primary level.
- 2.2 The first six monthly allocation will be made in the 1st week of February of the previous financial year on the basis of number of children and number of school days approved by Programme Approval Board of Mid Day Meal Scheme (MDM-PAB) for the previous year.
- 2.3 The second and final allocation of foodgrains will be made in the first week of August after deducting the unspent balance available with the States/UTs out of foodgrains allocated during the previous year and also the allocation made for the first six months from the annual allocation approved by MDM-PAB for the current year.
- 2.4 To ensure timely final allocation of foodgrains by Government of India, the States/UTs will send the utilisation certificate of the foodgrains supplied under

the scheme during the previous year latest by 30th June. In the utilisation certificate only the quantity actually consumed at the school/cooking agency level will be indicated as utilized. Whatever remains in their stores or godowns at school, cooking agency, Block and District levels will be shown as unspent balance.

- 2.5 On receiving allocation from the Government of India the States/UTs will made district-wise allocation of the foodgrains separately for primary and upper primary classes in accordance with the number of children and number of working days approved for that particular district.
- 2.6 District administration will ensure that every consuming unit maintains a bufferstock of foodgrains required for a month to avoid disruption due to unforeseen exigencies.

3. Supply/Lifting of Good Quality of Foodgrains

- 3.1 It will be the responsibility of the FCI to ensure continuous availability of adequate quantity of good quality of foodgrains which will be in any case not less than Fair Average Quality (FAQ), in its Depots FCI will appoint a Nodal Officer for each State to take care of various problems in Supply of foodgrains under the scheme.
- 3.2 The District administration on receiving the allocation from the State/UT will send a schedule (periodicity and date/week) of lifting of foodgrains to the local FCI Depot depending on its requirement, transportation convenience and storage capacity. Districts can lift foodgrains on monthly-bimonthly or quarterly basis as indicated in their schedule.
- 3.3 The FCI will allow lifting of foodgrains as per the allocation of the State Government and lifting schedule provided by the District administration starting from 1st day of the month preceding the allocation quarter and upto 25th of the last month of the allocation quarter. For example, the validity period for lifting of foodgrains for the quarter beginning April, 2010 will be from 1st March, 2010 to 25th of June, 2010.
- 3.4 FCI will note make any modification in the quantity to be lifted. This has already been clarified by the Department of Food and Public Distribution *vide* letter No. 4-3/2008-09-BP-II dated 9.9.2009 and by FCI vide their letter No. 26/1/2009-10/MDM-S-IX/Vol. II dated 16.11.2009 to all field officers of the FCI.
- 3.5 The District administration and the FCI Depot will ensure that no lifting is done in excess of the allocated quantity.
- 3.6 The District Collector/CEO of Zila Panchayat will ensure that foodgrains of at least FAQ are received from FCI Depot after joint inspection by a team consisting of FCI official and the nominees of the Collector and/or Chief Executive Officer. District Panchayat and confirmation by them that the grain conforms to at least FAQ norms. The consignee receipt (in triplicate) should be jointly signed by the in charge of FCI Depot and nominee of District Collector. One copy of the receipt will be retained by the lifting official and another one is sent to District level paying authority for its record.

- 3.7 The sample (in triplicate) of stocks proposed to be lifted will be drawn jointly in the presence of the representatives of the State Government and the FCI and the sample slips will be jointly signed and sealed. One such sealed sample will be given to State Government representative, one will be sent to FCI District Office and one will be retained at the depot.
- 3.8 Samples of lifted foodgrains shall be retained for 3 months in token of quality of grains received from FCI in case any complaint of low quality of foodgrains is received within this period, these samples can be used to ascertain the veracity of the complaint.
- 3.9 The process followed at the time of receipt of foodgrains from FCI depots should be repeated at each level till the foodgrains reach the end user to ensure that only good quality foodgrains is delivered for consumption by children.

4. Payment of Cost of Foodgrains

- 4.1 FCI will raise the bills pertaining to supply of foodgrains during a month to the District administration by the 10th day of the next month in the prescribed format and the District administration will ensure payment within 20 days.
- 4.2 State Government will nominate an officer who will be responsible for receiving the bills submitted by FCI and ensuring payment to it in time. FCI will intimate its account number and mode of receiving of payment to the nodal officer, who should be made responsible for transferring money/depositing cheque in that account.
- 4.3 For the purpose of making payment to FCI in time, the States/UTs will make adequate provision in its budget keeping in view the annual requirement of funds for this purpose and release the same in advance to the districts. The Govt. of India shall also release the funds to States/UTs in advance as soon as the budget is passed.
- 4.4 Under the present system funds are released by the Central Government to the Consolidated Fund of the States/UTs. Thereafter, it is channelized to Districts in the Treasury mode either through the Directorate or directly by State/UT. It has been observed that in several States/UTs, it takes around 2-3 months for the funds to reach the district level in such an event payment to FCI may get delayed for want of funds leading to disruption in the scheme in order to avoid such a situation. State Government should authorize the district administration to draw money under the relevant Treasury Rule (usually TR-27) to make payment to FCI for supply of foodgrains under MDM Scheme in case no budget is available. This payment will be adjusted after receipt of budget by the districts.

5. Monitoring System

5.1 A monthly meeting will be held by the District administration with FCI District Manager or his representative and all other concerned officials in the last week of the month to resolve all the issues pertaining to lifting quality of foodgrains and payment and submit a report to the State Headquarters by 7th of the next month.

- 5.2 States/UTs will monitor the lifting payment and quantity of foodgrains sent to School/Cooking Agency on the 10th of every month in a meeting with the State nodal officer of the FCI and send a report to this Department. In the proforma appended at Annexure-I by the 15th of every month.
- **6.** All States/UTs are requested to issue necessary instructions in the light of the above endorse a copy of the same to this Ministry for our records and monitor strict compliance of these instructions on monthly basis.

7. Responsibility of Food Corporation of India (FCI)

It will be the responsibility of the FCI to ensure continuous availability of adequate food grains in its Depots (and in Principal Distribution Centres in the case of North East Region). It will allow lifting of foodgrains for any month/quarter upto one month in advance so that supply chain of foodgrains remains uninterrupted.

For the NP-NSPE, 2006, FCI will issue foodgrains of best available quality, which will in any case be at least of Fair Average Quality (FAQ). FCI has also appointed a Nodal Officer for each State to take care of various problems in supply of foodgrains under MDM Programme.

The District Collector/CEO of Zila Panchayat will also ensure that foodgrains of al least FAQ are issued by FCI after joint inspection by a team consisting of FCI and the nominee of the Collector and/or Chief Executive Officer, District Panchayat, and confirmation by them that the grains conforms to at least FAQ norms.

FCI will keep samples of such food grains supplied by it for future verification and analysis; this will be available in case of any complaints regarding the quality of foodgrains supplied.
