- (a) the details of allotment of land by Delhi Development Authority(DDA) to private agencies and Government bodies, separately for construction of schools during each of the last three years and the current year, organisation-wise;
- (b) whether preferential allotments have been made to the private agencies and if so, the details thereof along with the reasons therefor;
- (c) thedetails of allotments still pending for construction of Government schools; and
- (d) thesteps taken/being taken by the Government to provide land for setting up new schools/construction of pucca buildings for those schools running from tents or kuchcha buildings?

No allotment of land has been made to private institutions for construction of school buildings during the last three years.

- (c) : As per information received in the Ministry, 84 site specific applications have been received from Directorate of Education, GNCTD for allotment of lands for Senior Secondary Schools only. 4 sites have been allotted and 6 sites are under process for allotment. One site was found to be unfeasible. The rest 73 sites applied for are earmarked for Primary Schools and as per MPD, 2021 norms these sites cannot be considered for allotment of Senior Secondary Schools.
- (d): Delhi Government has informed that Directorate of Education applies to various land owning agencies viz. DDA, Gram Sabha and DUSIB for allotment of land and constructs the building on the allotted land and that at present no Government School is running in Tent or Kuchcha building.
