- (a) the details of funds allocated for Sarva Shiksha Abhiyaan (SSA), Rashtriya Madhyamik Shiksha Abhiyaan (RMSA) and Mid-Day Meal Scheme in the country during the last three years and the current year;
- (b) whether the allocated funds are not being fully spent on education;
- (c) if so, the reasons therefor and the steps taken/proposed to be taken by the Government to improve the situation; and
- (d) the number of cases of misappropriation of funds that were proved and action taken against the officers found responsible for the same during the above period, State-wise?

(a): The details of funds allocated for Sarva Shiksha Abhiyaan (SSA), Rashtriya Madhyamik Shiksha Abhiyaan (RMSA) and Mid-Day Meal Scheme in the country during the last three years and the current year are as under:

- (c) Government of India has a monitoring mechanism through Joint-Review Missions and 38 monitoring institutions to assess the implementation of these schemes in the field, besides regular annual auditing of accounts.
- (d) Proven cases of misappropriation have been reported from Himachal Pradesh for Rs.9.53 lakhs in 2010-11 against which an FIR has been lodged, fraudulent transaction of Rs. 32.07 lakh reported in Gujarat in 2010-11 for which an FIR has been lodged, misappropriation of an amount of Rs. 31.25 lakh reported in the State of Haryana, of which Rs. 8.79 lakhs have been recovered.
