Classification and allocation of time to Bills

- 4. After considering all aspects of the Bills, the Committee recommend that twenty-five Bills shown in Appendix be placed in category `A'. The Committee also recommend allocation of time for each of the Bills as shown in column 5 of the Appendix.

5. After considering all aspects of the Bill, the Committee recommend allocation of 2 hours for the discussion of the Rights of Transgender Persons Bill, 2014, as passed by Rajya Sabha.
