**Will the Minister of INFORMATION AND BROADCASTING be pleased to state:**

- (a) Whether several Regional offices of Central Board of Film Certification do not have regular Regional Officers;
- (b) if so, the details thereof and the reasons therefor;
- (c) whether the Government proposes to revise the Recruitment Rules for the said post;
- (d) if so the details thereof; and
- (e) the measures taken/proposed to be taken by the Government to fill up the posts of Regional Officers along with the time by which these posts are likely to be filled up. Region-wise?

**Answer**

THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF INFORMATION AND BROADCASTING, ENVIRONMENT, FOREST AND CLIMATE CHANGE AND MINISTER OF STATE FOR THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI PRAKASH JAVADEKAR).

(a) & (b): Yes Madam, Out of nine Regional Offices of CBFC the post of Regional Officers in 4 regional offices viz. Mumbai, Bangalore, Thiruvananthapuram and Guwahati are vacant. However, additional charge has been given to PIB Officers in the concerned cities.

(c) & (d): At present, there is no such proposal for amending the recruitment rules of the post of Regional
