## Will the Minister of AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMEOPATHY (AYUSH) be pleased to state:

- (a) the number of Government and private Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homoeopathy (AYUSH) institutes including research institutes and colleges, separately indicating the number of seats therein, State/UT-wise;
- (b) the steps taken/proposed to be taken by the Government to set up/recognise new AYUSH research institutes and colleges/ universities and upgrade the existing institutes along with the criteria therefor and the funds earmarked, allocated and utilized for the purpose during each of the last three years and the current year, State/ UT-wise;
- (c) the number of proposals received from various States/UTs in this regard and the action taken/ proposed to be taken by the Government thereon during the said period, State/UT-wise;
- (d) the other measures being taken by the Government to promote education and research under AYUSH system of medicines to promote research in AYUSH; and
- (e) whether the Government proposes to introduce a new legislation/policy to promote and popularize AYUSH system of medicines nationally and interna- tionally and if so, the details thereof?
