**Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:**

- (a) whether the Government has decided to establish 20 Indian Institutes of Information Technology (IIITs) in the country under Public Private Partnership (PPP) mode;
- (b) if so, the details thereof, State and location- wise;
- (c) whether the State Government of Gujarat has requested to sanction one more IIIT in Surat, for which land and industry partners have also been identified; and
- (d) if so, the time by which the said IIIT is likely to be established?

**Answer**

MINISTER OF HUMAN RESOURCE DEVELOPMENT (SMT. SMRITI ZUBIN IRANI)

(a) & (b): Yes, Madam. The Union Cabinet, on 07.12.2010 approved a scheme, based on Public-Private-Partnership (PPP) model, for setting up 20 new Indian Institutes of Information Technology (IIITs) with an outlay of Rs.2808.71 Crores (Rs.2558.71 Crores for non-recurring, Rs.200.00 Crore for recurring expenditure and Rs.50.00 Crore for faculty development expenditure). The capital cost of each IIIT is Rs.128.00 Crore to be contributed in the ratio of 50:35:15 by the Central Government, the State Government and the industry respectively (57.5:35:7.5 in case of North-Eastern region). The concerned State Government will provide 50-100 acres of land, free of cost and encumbrances.

The MHRD has approved a total of sixteen proposals for IIIT in PPP mode under the Scheme of "Setting up of 20 IIITs in PPP mode" from fifteen States, namely, Andhra Pradesh (IIIT Chittoor and IIIT Kakinada), Assam (IIIT Guwahati), Gujarat (IIIT Vadodara), Haryana (IIIT Sonapat), Himachal Pradesh (IIIT Una), Karnataka (IIIT Dharwad), Kerala (IIIT Kottayam), Madhya Pradesh (IIIT Bhopal), Rajasthan (IIIT Kota), Tamil Nadu (IIIT Tiruchirappalli), Maharashtra (IIIT Pune), Uttar Pradesh (IIIT Lucknow), West Bengal (IIIT Kalyani), Manipur (IIIT Manipur) and Tripura (IIIT Tripura).

(c): Yes, Madam.

(d): The proposal for establishment of IIIT will be considered by the Council of IIITs in due course.
