- (d) whether the Government proposes to grant certain orders of Shipping Corporation of India, Dredging Corporation and Mazgaon Dock to Cochin Shippard Limited (CSL); and
- (e) if so, the details thereof and the steps taken by the Government in this regard and also to transfer the fund for development of CSL?

Answer

MINISTER OF STATE IN THE MINISTRY OF SHIPPING (SHRI PON. RADHAKRISHNAN)

- (a) There are two shipyards under the administrative control of the Ministry of Shipping v.i.z. Cochin Shipyard Limited (CSL), Kochi and Hooghly Dock & Port Engineers Limited, Kolkata. The details of ship-building and repair orders received by these two shipyards during each of the last three years including orders pending with each of the yards, is given in Annexure.
- (b)&(c):Cochin Shipyard Limited has been awarded one contract in the year 2012-2013 for the building of one Buoy Tender Vessel (MV Indira Point) on nomination basis by the Directorate General of Light Houses and Light Ships. It has also received ship repair orders from Dredging Corporation of India Limited, Indian Navy ,Coast Guard and others.
- (d)&(e):Shipping Corporation of India Limited (SCI) has signed a Memorandum of Understanding (MoU) with Cochin Shipyard Limited for cooperation in construction and acquisition of offshore vessels. Cochin Shipyard Limited meets its capital expenditure requirement through its own internal resources and raising tax free bonds.
