(a) the details of foodgrains procured in Bihar by Central Government/State Government/Food Corporation of India during each of the last three years;

(b) whether the Central Warehousing Corporation (CWC)/Bihar State Warehousing Corporation are facing shortage of adequate storage capacity for storing foodgrains in the State;

(c) if so, whether the Central Warehousing Cor-poration has not built any godowns in the rural areas of the State;

(d) if so, the details thereof and the reasons therefor along with the number of additional godowns proposed to be built during the next couple of years;

(e) whether there have been a delay in payment of procurement price to the farmers in the State; and

(f) if so, the details thereof and the reasons therefor along with the remedial steps taken in this regard?

Under Private Entrepreneurs Guarantee (PEG) scheme, District wise storage gap was calculated by the State Level Committees (SLCs) and a Capacity of 9.40 lakh MT was approved by the High Level Committee (HLC) for creation in Bihar under the Scheme. Out of this, a capacity of 40,000 MT is being created by CWC and status thereof is as under-
