# COMMITTEE ON PRIVATE MEMBERS BILLS AND RESOLUTIONS (Thirteenth Lok Sabha) TWENTY-FIRST REPORT

(Presented on 5.12.2001)

On behalf of the Committee on Private Members Bills and Resolutions, I having been authorised by the Committee to present the Report, present this Twenty-first Report.

2. The Committee met on 3 December, 2001 for the purpose of classification and allocation of time for discussion of Bills (vide Appendices I and II) under clauses (b) and (c) of Rule 294(1) of the Rules of Procedure.

#### Classification and allocation of time to Bills

- 3. The Committee considered classification and allocation of time in respect of twelve Bills shown in Appendices.
- 4. After considering all aspects of the Bills, the Committee recommend that six Bills shown in Appendix I be placed in category `A. The Committee further recommend that the six Bills shown in Appendix II be placed in category `B. The Committee also recommend allocation of time for each of the Bills as shown in column 5 of the Appendices I and II.

### Recommendations

5. The Committee recommend that the classification and allocation of time in respect of Bills by the Committee, as shown in the Appendices, be agreed to by the House.
