- 5. Karampura Near Commercial Complex

- 7. Stack Parking at Paharganj behind Shiela Cinema
- 8. Stack Parking at Satbhama Road at Karol Bagh
- 9. Sant Nagar, Rani Bagh
- 10. UV Block Shalimar

The South Delhi Municipal Corporation has undertaken projects for construction of various Multi Level Parking at the following locations:
